- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule of Assets is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the Jet Midwest, Inc. 401(k) Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution salary deferral plan covering all eligible employees of Jet Midwest, Inc. and its affiliates (the "Company") who have one month of service. The Plan is qualified under Internal Revenue Code section 401(k) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of the Company is responsible for oversight of the Plan. The Board of Directors determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan allows participant loans from participant account funds.

Ascensus Trust Company is the custodian of the Plan and Ascensus, LLC is the third-party administrator of the Plan.

Contributions

Contributions to the Plan consist of voluntary employee pre-tax contributions from salary that are matched to a certain percent by employer contributions. Participants may contribute up to one hundred percent of their total pre-tax salary, subject to annual statutory limits as defined by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investments options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Plan includes an auto escalation clause, which increases the deferral rate of auto-enrolled participants by 1% each year until the deferral rate reaches 10% or the participant makes a different election. Additional profit-sharing amounts may be contributed at the option of the Board of Directors. During the year ended December 31, 2024 and 2023, the Company made no such profit-sharing contribution.

The elected contribution may be changed as often as desired. The Company will make safe harbor contributions equal to a match of 100% of the deferral up to 3% of the employee's gross pay plus an additional 50% of the next 2% from each payroll period.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's safe harbor matching contribution and (b) the Plan's earnings or losses and charged an allocation of administrative expenses. Allocations are based on defined account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Benefits

Participants are entitled to the benefit which can be provided from the participant's account. Distribution of the participant's vested accrued benefit shall commence upon request. Upon termination of employment, the participant, or in the case of death, the participant's beneficiary can elect to receive the participant's vested account balance in a single lump sum or request that it be rolled over to a different IRA provider or another retirement plan, in accordance with the Plan document.

Investment options

A participant directs all contributions into mutual funds and common/collective trusts managed by the Custodian. Employees can change their investment options anytime.

Vesting

Participants' contributions, safe harbor employer matching contributions, and earnings thereon are fully vested at all times. Vesting in profit sharing contributions, and the related earnings is based on years of continuous service. Employer profit sharing contributions, and related earnings fully vest after six years of credit service. A participant also vests fully upon death or disability.

Amendment and termination

The Company shall have the right at any time to amend the Plan in any manner it deems necessary or appropriate. Although the Company has not expressed an interest to do so, it shall have the right, at any time, to suspend or discontinue its contributions under the Plan, and to terminate, at any time, this Plan, subject to the provisions of ERISA. In the event the Plan should be terminated, the entire balance of the participant's account will become fully vested, and all remaining Plan assets shall be allocated to the participants as described in the full text of the Plan documents.

Participant Loans

Participants may borrow from all account balances in their participant accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Each loan is secured by the balance in the participant's account and bears interest at a rate of 1% over prime. Principal and interest are

paid through payroll deductions. The number of outstanding loans held by a participant is limited to two loans.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or in annual installments. Participant's who have attained age 59 ½ may elect to receive either a partial withdrawal or lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may request a hardship withdrawal of a portion of their account attributable to participant deferrals. Any hardship withdrawal is limited to the amount needed to meet the financial need.

Forfeited Accounts

Forfeited non-vested accounts are used to pay Plan expenses and any remaining balance can be used to reduce employer contributions. As of December 31, 2024 and 2023, there were no forfeited nonvested accounts.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statement follow:

Basis of accounting

The accompanying financial statements of the Plan have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

Transactions are recorded on the trade date. Dividends are recorded on the ex-dividend date; interest income is recorded on the accrual basis. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan's investments in mutual funds and common/collective trusts are valued at fair value as noted in Note 4.

Management fees and operating expenses charged to the Plan for investments in mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Employer and participant contributions are reported in the year services are rendered to the Company by the plan participants.

Realized and Unrealized Gain/Losses on Investments

The realized gain or loss on investments represents the difference between the proceeds at the transaction date and the cost or recorded value of the investment. Unrealized gains or losses on investments represent the net change at the year-end between current value and the recorded value of the investments at the time of purchase or the beginning of the year, whichever is later.

Risks and Uncertainties

The Plan provides for various investment options in any combination of stock, bonds, fixed income securities, mutual funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for Plan benefits and the statement of changes in net assets available for Plan benefits.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan administrator to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Contributions

Employer and participant contributions are reported in the year services are rendered to the Company by the plan participants.

Receivables and loans

Employee deferrals, employer contributions, and loan payments are deposited after each pay day. Notes receivable from participant loans are presented at face value of the unpaid principal portion plus accrued interest income. Interest income is recorded on the accrual method. All notes are secured by the remainder of the participant's account balance therefore no allowance for doubtful accounts is recorded or needed.

Payment of benefits

Benefits are recorded when paid.

Recently Issued Accounting Pronouncements

The Trustees have reviewed all recent accounting pronouncements issued by the FASB (including its Emerging Issues Task Force) and the AICPA and feel they did not or will not have a material impact on the Plan's present or future financial statements.

3. Plan Expense

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. During the year ended December 31, 2024, \$27,955 in plan expenses were paid by the Company.

4. Fair Value Measurements

The Plan has adopted ASC Topic 820-10 to measure the fair value of certain of its financial assets required to be measured on a recurring basis. ASC Topic 820-10 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). ASC Topic 820-10 defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. A fair value measurement assumes that the transaction to sell the asset or transfer the liability occurs in the principal market for the asset or liability. The three levels of the fair value hierarchy under ASC Topic 820-10 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds – Valued at the closing price reported on the active market on which the individual securities are traded.

Common/Collective Trusts – The fund manager calculates a net asset value per unit on the Fund’s valuation date and the underlying investments of these funds are valued as described in their respective financial statements.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

6. Related Parties and Party-In-Interest

Ascensus Trust Company is a trustee as defined by the Plan; therefore, transactions between Ascensus Trust Company and the Plan qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than a direct payment. As described in Note 2 above, the Plan made direct payments to the Trustee and financial advisor of \$22,256 for the year ended December 31, 2024, which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants would become 100% vested in all amounts.

8. Income Tax Status

The Plan adopted a non-standardized pre-approved profit-sharing plan sponsored by Ascensus, LLC. The pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The Plan Sponsor can rely on the qualified status to the extent the Plan document does not deviate from the IRS pre-approved provisions. The Plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code and; therefore, believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed the tax positions taken by the Plan, and had concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no IRS audits for any tax periods in progress. The Plan sponsor believes it could be subject to income tax examinations for years of 2024, 2023, 2022, and 2021.

9. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

10. Plan Operational Defect and Related Employer Contributions Receivable

During April of 2024, a change in the data integration process with the Plan Sponsor's payroll provider caused employee deferrals and related employer match contributions to not be calculated properly on bonuses and commissions for the rest of the year. Bonuses and commissions are included in the definition of eligible compensation for the Plan. Subsequent to year end, this error was discovered and is in the process of being remediated. Related to this operational defect, the Plan Sponsor is contributing a Qualified Nonelective Contribution equal to 50% of the missed employee deferral amount, plus 100% of the missed matching amount that would have applied to the full missed employee deferrals, plus lost earnings from the date the employee deferrals should have occurred. The Plan Sponsor will calculate the lost earnings using the IRS-approved methods for earnings calculations. As of December 31, 2024, this employer

contribution receivable related to this issue totals \$95,731. Of this amount, \$39,972 relates to the missed employee deferrals and \$55,759 relates to the missed employer match. This amount will be funded into the Plan during the 2025 calendar year.

11. Subsequent Events

Management has evaluated subsequent events through October 15, 2025, the date these financial statements were issued and has determined that there are no transactions that need to be recorded or disclosed.
