Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Division 5, LLC Profit Sharing Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statement of Net Assets Available for Benefits as of December 31, 2024 and the related Statement of Changes in Net Assets Available for Benefits for the year then ended, and the related notes to the 2024 financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

NOTE 1: Description of Plan

The following brief description of Division 5, LLC Profit Sharing Plan, (the “Plan”), is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering substantially all nonunion eligible employees of Division 5, LLC (the “Plan Sponsor”). The Plan was established in 2004 and most recently restated as of November 21, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan Administrator, as appointed by the Plan Sponsor, has responsibility for the administration of the Plan. Lincoln National Life Insurance Company (“Lincoln”), as custodian and a qualified institution, has responsibility for the operation and administration of the Plan’s Trust Fund. Lincoln also serves as the Plan’s recordkeeper. Fees are charged to the Plan Sponsor for recordkeeping and administrative services. Rhonda Wylie, as trustee of the Plan, has responsibility for the management of the Plan’s trust fund.

Eligibility – Employees of the Plan Sponsor are eligible to enroll in the Plan after attainment of age 21 and completion of one year of service.

Contributions – Participants may contribute a percentage of pretax annual compensation and/or after-tax (Roth) annual compensation, up to the Internal Revenue Code (“IRC”) limitations, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan allows for employer safe harbor matching contributions and discretionary employer profit-sharing contributions. For the year ended December 31, 2024, the Company made a matching contribution equal to 100% of the participants’ salary deferrals up to 3% of compensation plus 50% of the participants’ salary deferrals between 3% and 5% of compensation. The Company made a discretionary profit-sharing contribution for the year ended December 31, 2023 of \$537,047, which was remitted to the Plan in 2024 and is recorded in employer contributions receivable as of December 31, 2023. No discretionary profit-sharing contributions were declared for the year ended December 31, 2024.

Participant Accounts – Each participant’s account is adjusted for the participant’s contributions and distributions and the Plan Sponsor’s matching contributions and discretionary contributions, if any, as well as allocations of Plan earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their voluntary contributions and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the employer’s discretionary profit-sharing contribution portion of their accounts, if any, is based on years of service attained as follows:

<u>YEARS OF SERVICE</u>	<u>VESTING %</u>
Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%
Six or more years	100%

Unallocated Accounts - Unallocated accounts consist of advance deposits made by the Plan Sponsor and forfeitures, which represent the non-vested portion of a participant’s account balance that is forfeited upon termination. They are used to pay Plan expenses and reduce the Plan Sponsor’s contributions in accordance with Plan specifications. These accounts had a balance of approximately \$29,000 and \$5,000 at December 31, 2024 and 2023, respectively. Amounts used to pay Plan administrative expenses totaled approximately \$3,000 while amounts used to reduce the Plan Sponsor’s contributions totaled approximately \$33,000 for the year ended December 31, 2024.

Investment Options – A participant may direct employee and employer contributions in any of the investment options established by the Plan Sponsor.

Payment of Benefits – Upon termination of service due to death, disability, or retirement, a participant is entitled to receive 100% of their account balance in a lump-sum distribution. Plan participants who are terminated for reasons other than retirement, death, or disability are entitled to receive only the vested portion of their account. Vested account balances less than \$5,000 are subject to automatic distribution in accordance with the Plan document. The Plan also allows for in-service withdrawals of a participant’s vested interest upon reaching the age of 59 ½.

Plan Termination – Although there is no present intention to terminate the Plan, the Plan Sponsor may terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination, the participants will become fully vested in their accounts.

NOTE 2: Summary of Significant Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared using the accrual basis of accounting.

Valuation of Investments – The Plan’s investments are stated at fair value (except for fully benefit-responsive investment contracts which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between participants at a measurement date. The plan administrator determines the Plan’s valuation policies, utilizing information provided by the Plan’s investment advisors and custodian. See Note 3 for a description of the valuation methodologies used to determine each investment’s respective fair value.

Net appreciation or depreciation of the fair value of investments consists of the unrealized appreciation or depreciation of investments held during the year, as well as the realized gain or loss on sale of investments which represents the difference between net sales proceeds and cost or previous fair value of the investments sold.

Purchases and sales of securities are recorded on a trade–date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex–dividend date.

Tax Status – The Plan received a favorable determination letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the IRC and are exempt from federal and state income taxes. Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America (“GAAP”) requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or state taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions within the standard statute of limitation periods; however, there are currently no audits for any tax periods in progress.

Benefit Payments – Benefits are recorded when paid.

Plan Expenses – Certain costs of administering the Plan are absorbed by the Plan Sponsor and are not reflected in these financial statements. Certain investment management fees and administrative expenses are incurred and paid by the Plan as disclosed in Note 1. Fees related to the administration of distributions from participants are charged directly to the participant’s account.

Use of Estimates – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events – The Plan has evaluated all subsequent events that may qualify for disclosure through October 14, 2025, which is the date the financial statements were available to be issued. There were no transactions that are required to be disclosed under professional guidance.

NOTE 3: Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy according to GAAP are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Valued at the net asset value ("NAV") of units of the pooled separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Withdrawals can be executed any time, but exchanges are generally limited to two per month. Were the Plan to initiate a full redemption of a pooled separate account, the investment adviser reserves the right to temporarily delay withdrawal from the account in order to ensure that the securities liquidation will be carried out in an orderly business manner. There are no unfunded commitments related to the pooled separate accounts.

NOTE 4: Guaranteed Investment Contract with Insurance Company

The Plan holds investments provided under a benefit-responsive investment contract (the “Contract”) with Lincoln. The Contract is deemed to be fully benefit-responsive. As such, contract value is the relevant measurement attribute for benefits attributable to the Contract because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The Contract includes investments in a guaranteed stable value account and managed principal protected portfolio, both of which are presented at contract value on the face of the Statements of Net Assets Available for Benefits. Contract value represents contributions made to the investments, plus earnings at guaranteed crediting rates less participant withdrawals and administrative fees.

The contract issuer is obligated to repay the principal amount and provide a guaranteed interest rate to the Plan. The crediting rate, determined by the issuer, is based on a specified formula and must not fall below 0% for the guaranteed stable value account and 1% for the managed principal protected portfolio. Lincoln bears the risk that the return on the underlying investments will be sufficient to support the guaranteed rates during each guarantee period.

The Plan’s ability to receive amounts in accordance with fully benefit-responsive investment contracts depends on the issuer’s ability to satisfy its contractual obligations, which may be influenced by future economic and regulatory conditions.

Certain circumstances could restrict the Plan’s ability to transact with the issuer at contract value. Such events include: (1) the Plan’s failure to maintain qualified status under Section 401(a) of the IRC or the related trust’s failure to remain tax-exempt under Section 501(a) of the IRC, (2) early termination of the Contract, (3) termination or merger of the Plan, (4) changes to the Plan’s provisions regarding competing investment options, or (5) bankruptcy of the Plan Sponsor or other Plan Sponsor-related events (such as divestitures or spin-offs of a subsidiary) that substantially impact the Plan’s normal operations. Currently, no such events are considered probable that would limit the Plan’s ability to transact at contract value with either the issuer or participants.

Additionally, the issuer may terminate the Contract and settle for an amount other than contract value under specific conditions, including: (1) an uncured breach of the Plan’s investment guidelines, (2) failure to fulfill material obligations under the Contract, (3) material misrepresentation, or (4) material amendments to the agreements without the issuer’s consent.
