INDEPENDENT AUDITORS' REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Coeur d'Alene Paving, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Coeur d'Alene Paving, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

COEUR D'ALENE PAVING, INC. 401(K) PLAN NOTES TO FINANCIAL STATEMENTS

Note A – Description of Plan

The following description of Coeur d'Alene Paving, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The plan is a defined contribution plan covering all employees of the Plan Sponsor (the “Company”). For employee contribution purposes, employees are eligible for Plan participation on their hire date. To be eligible for Company matching contributions, employees must complete one year of service and a minimum of 1,000 hours. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Contributions

Participants may elect to defer up to the maximum allowable under the Internal Revenue Code of eligible compensation and contribute these amounts to the Plan. In addition, participants over age 50 before the close of the calendar year are eligible to defer an additional catch-up contribution. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. Safe harbor matching contributions to the participants’ accounts will be equal to 100% of the first 4% of the employee’s base compensation that a participant contributes to the Plan. Additional amounts may be contributed at the discretion of the Company’s Board of Directors in the form of profit sharing contributions. No profit sharing contribution was made for the year ended December 31, 2024. Contributions are subject to certain limitations.

Vesting

Participants are vested immediately in their contributions and any employer matching contributions and discretionary profit sharing contributions, plus actual earnings thereon.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions and (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTES TO FINANCIAL STATEMENTS

Note A – Description of Plan (Continued)

Payment of Benefits

On termination of service due to death, disability, termination of employment or retirement, a participant shall receive a lump-sum benefit payment equal to the value of the participant's vested interest in their account. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Administrative Expenses

Expenses of administering the Plan are the responsibility of the Plan's management; however, most of the administration expenses are paid by the Company on behalf of the Plan and will not be reimbursed. Investment related expenses are deducted from the individual participant accounts.

Forfeited Accounts

Forfeitures may be used to reduce future employer contributions or pay plan administrative expenses. At December 31, 2024 and 2023, there were no forfeited nonvested accounts. No funds from forfeited nonvested accounts were used to reduce employer contributions or pay plan administrative expense in 2024.
