## **Note 1 – Description of Plan**

The following description of the Bunting Bearings LLC Retirement Savings 401(k) Plan, (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

### General

The Plan is a defined contribution plan covering all eligible employees of Bunting Bearings, LLC (the Company and Plan Administrator) who have one year of service and are age 21 or older. Employees may enter the Plan on the first day of the quarter coinciding with or following the date these eligibility requirements are satisfied. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### Participant Accounts

Each participant's account is credited with the participant's contributions, company safe harbor matching contributions, company discretionary matching contributions, as well as an allocation of the Company's discretionary profit sharing contributions and Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested value of the participant's account. Participants direct the investment of their account balances among the investment funds offered by the Plan.

### Contributions

Participants may elect to defer on a pretax or Roth basis of up to 90% of annual compensation but not to exceed the maximum allowed by the Internal Revenue Service (IRS), as defined by the Plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan includes auto-enrollment and auto-escalation provisions whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and the rate is increased by 1% each year up until reaching 6% of eligible compensation.

The Plan requires the Company to make a safe harbor matching contribution of 100% of the first 4% and 50% of the next 2% of eligible compensation that a participant contributes to the Plan. Additional discretionary matching contributions and profit sharing contributions may be contributed each year at the employer's discretion. There were no discretionary or profit sharing contributions during 2024 or 2023, respectively.

Vesting

Participants are immediately 100 percent vested in employee salary, rollover contributions, the Company's safe harbor matching contributions, and any income or loss thereon. Vesting in the Company's discretionary matching contributions and profit sharing contributions is based on years of service. A participant is fully vested in these portions of their accounts after six years of credited service.

Forfeitures

Forfeitures are first utilized to pay any administrative expenses or to reduce future employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,533 and \$2,498, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the Employee Retirement Income Security Act of 1974.

Administrative Expenses

Administrative expenses are paid by the Company or by the Plan, as permitted in the Plan document. The services are rendered by parties-in-interest to the Plan.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in lump sum amounts equal to the value of their vested interest. A terminated participant with a balance less than \$1,000 may be automatically paid out by the Plan upon termination. Any terminated participants with a balance between \$1,000 and \$5,000 can still be automatically paid out if their balance is rolled into a qualified Individual Retirement Account. In-service distributions from a participant's account are available to employees over the age of 59½ or hardship, as defined in the Plan document.

**Note 2 – Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In contrast, contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There have been no changes in the valuation methods used. The Plan's investments are held by Empower Annuity Insurance Company of America and Empower Trust Company, LLC as of December 31, 2024 and 2023 (the Custodians).

Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are valued at net asset value.

The Key Guaranteed Portfolio Fund is a guaranteed interest account valued at contract value, which represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Reclassifications

Certain accounts in the prior year have been reclassified for comparative purposes to conform to the presentation of the current year financial statements.

Subsequent Events

Management has evaluated subsequent events through October 10, 2025, the date the financial statements were available to be issued.

Effective October 1, 2025, the Plan was restated and included provisions to allow employees who are 21 to enter the Plan after completing 90 days of service, and allow employees to enter the Plan on the first day of the month coinciding with or following the date these eligibility requirements are satisfied. Management has evaluated the impact of these updates and has determined that they may increase the number of eligible participants and timing of contributions, but are not expected to have a material effect on the Plan's financial position.

**Note 3 – Investments**

All investment information disclosed in the accompanying financial statements and schedule, including investments held at December 31, 2024 and 2023, net appreciation (depreciation) of investments, and dividends and interest for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodians, Empower Annuity Insurance Company of America and Empower Trust Company, LLC.

**Note 4 – Guaranteed Interest Account**

The Plan holds a traditional investment contract that meets the fully-benefit responsive investment contract criteria, and therefore is reported at contract value. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value without adjustment. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer. The guaranteed interest account permits the issuer or the Plan to terminate the agreement prior to the scheduled maturity date as a result of specific occurrences as defined in the contract.

**Note 5 – Fair Value Measurements**

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments valued at fair value in the statements of net assets available for benefits are all mutual funds, which are considered Level 1 investments.

**Note 7 – Income Tax Status**

The IRS ruled on June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA Plan (the prototype plan upon which the Plan is based) qualifies under Section 401 of the Internal Revenue Code (IRC) and the related trust is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator will take the necessary steps, if any, to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9 – Compliance Matters**

The audit identified a compliance issue involving in-service distributions that did not align with the provisions of the Plan document or applicable IRS regulations. The Plan Sponsor is currently assessing the financial reporting implications and determining the appropriate corrective action in accordance with IRS guidance. The potential impact to the financial statements, if any, cannot be reasonably estimated at this time as the assessment and remediation process is ongoing.
