Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Direct Auction Services, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of Plan

The following description of the Direct Auction Services, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits for employees of Direct Auction Services, LLC (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

All employees of the Company who have completed six months of service are eligible to participate in the Plan. Effective January 1, 2023 employees may enter the plan on January 1 or July 1 after meeting the eligibility requirements.

Contributions

Participants may contribute up to 100% of compensation subject to certain Internal Revenue Code (IRC) limitations and participants can choose to suspend elections at any time. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may make post-tax Roth contributions to the Plan and participants who are age 50 by the end of the Plan year are eligible to make additional catch-up contributions to the Plan. The Plan includes an auto-enrollment provision whereby newly eligible participants employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participant have their deferral rate set at 3% of eligible compensation.

The Plan allows for discretionary-matching contributions, as determined annually by the Plan Sponsor. Participants are eligible to receive matching contributions after completing six months of service. During 2024, the Plan Sponsor did not make any matching contributions. Plan Sponsor and participant contributions may not exceed the maximum amount allowable for federal income tax purposes.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollover contributions, and an allocation of the Plan Sponsor's contributions, the Expense Budget account and Plan investment earnings or losses. Plan investment earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Participant accounts are charged with an allocation of administrative expenses based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of contributions into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their elective salary deferral plus actual earnings (losses) thereon. Vesting in the Plan Sponsor's contribution is based on years of continuous service. Participants vest 33% after one year of service, 67% after the second year of service and are 100% vested after three years of service.

Note 1. Description of Plan

Payment of Benefits

Upon termination of service due to death, disability, retirement, or termination of service, a participant may receive a lump-sum distribution equal to the value of the participant's vested account balance.

In-service Withdrawals

Participants may receive all or a portion of their vested account balance upon reaching age 59½. Participants can also withdraw funds from their rollover accounts at any time. Hardship withdrawals from the participant's elective deferral account are permitted only in the case of financial hardship, as determined by the Plan administrator in a uniform and nondiscretionary manner.

Forfeited Accounts

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Plan Sponsor contribution portion of their account. These accounts will be used to reduce the Plan Sponsor's contribution or pay Plan expenses. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$101,701 and \$31,136, respectively. During the year ended December 31, 2024, forfeitures of \$13,929 were used to pay Plan expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Presentation

The financial statements of the Plan are prepared in conformity with accounting principles generally accepted in the United States of America (US GAAP).

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received by the Plan for the sale of an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the processing of distributions and administrative fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change of fair value of investments.

Note 2. Summary of Significant Accounting Policies

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions.

Note 3. Certification

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements, notes, and supplemental schedule was obtained by the Plan Administrator and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (Reliance) as of December 31, 2023 and for the period January 1, 2024 through June 30, 2024 and Transamerica Trust Company (Transamerica) as of December 31, 2024 and for the period July 1, 2024 through December 31, 2024, the trustees of the Plan.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Registered Investment Companies Funds (Mutual Funds): Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4. Fair Value Measurements

Collective Trust Fund: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value. Pursuant to Financial Accounting Standards Board Accounting Standards Update 2015-07, *Fair Value Measurements*, the collective trust funds measured at NAV have not been classified in the fair value hierarchy. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Interest bearing cash: Investments in interest bearing cash transact at \$1.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023.

The collective trust fund invests in high-quality guaranteed investment contracts and similar contracts issued by insurance companies, banks and other financial institutions and seeks to provide income while preventing price fluctuations.

Note 5. Excess Contributions and Other Employer Contributions Receivable

Contributions received from participants for 2024 are net of refunds of \$6,168 recorded for amounts refundable by the Plan to participants for contributions made in excess of amounts allowed by the IRS, as required to satisfy the relevant nondiscrimination provisions of the Plan. Excess contributions refundable from the Plan include refunds for 2024, 2023 and 2022 in the amounts of \$6,168, \$15,199 and \$11,006, respectively. Further, as the refunds for 2023 and 2022 were not made by the required deadline, the Plan Sponsor will make qualified non-elective corrections under the one-to-one method and a receivable for the corrective contributions, less investment earnings or losses, in the amount of \$15,199 and \$27,890 has been recorded as of December 31, 2024 and 2023, respectively. The 2022 other employer contribution of \$12,691 was remitted to the Plan in 2024.

The Plan was audited by the Employee Benefit Security Administration and received a closing letter on March 24, 2025. As a result of the audit, the Plan Sponsor has included a receivable to the Plan in the amount of \$85,439 at December 31, 2023 representing late and missed participant contributions, plus lost earnings, for the year 2018 through 2022. The Plan Sponsor submitted the remittances to the Plan in 2024.

Note 6. Related Party and Party-in-interest Transactions

Certain Plan investments are managed by Transamerica, the Trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in investment income, as they are indirect fees paid through revenue sharing, rather than a direct payment. The Plan pays certain fees related to the Plan's operations, which are included as administrative expenses.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan under the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts and the accounts will be distributed to the participants or their beneficiaries under the terms of the Plan document.

Note 8. Tax Status

The Plan Sponsor adopted a non-standardized pre-approved plan document, which received a favorable opinion letter dated June 30, 2020, from the IRS as to the non-standardized plan's qualified status. The non-standardized plan's opinion letter has been relied upon by the Plan. The Plan itself has not received a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. However, the Plan Sponsor believes the plan is designed and is being operated in compliance with the applicable requirements of the IRC and was, therefore, qualified and exempt from taxation.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. Plan administrator believes it is no longer subject to IRS examination for years prior to 2021.

Note 9. Plan Expenses

Pursuant to Transamerica's Fund Revenue Equalization method, Transamerica uses certain revenue sharing payments it receives from the investment options available in the Plan to offset the costs of administration of the Plan on an individual fund basis. If the revenue Transamerica collects from a fund provider is greater than the administrative fee negotiated, Transamerica refunds the difference to the participants invested in the fund. If the revenue Transamerica collects from a fund provider is less than the negotiated fee, it collects the difference by deducting an administrative fee from the participants invested in the fund. Transamerica's Fund Revenue Equalization method ensures that all participants bear a similar percentage charge for the Plan's administrative fees irrespective of the investment funds they choose. Additional amounts in excess of its required revenue are credited to the Expense Budget Account. If the amount received by Transamerica is less than its required revenue and the funds in the Expense Budget Account are insufficient to cover the shortfall, the Plan Sponsor pays the shortfall.

The Expense Budget Account may be used for Plan expenses or allocated to participants as additional income. During the year ended December 31, 2024, the Plan reallocated to participants \$1,099,998 and paid Plan expenses of \$47,658. As of December 31, 2024 and 2023, the Expense Budget Account maintained a balance of \$101,701 and \$916,931, respectively, which is included in investments on the statements of net assets available for benefits.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note 11. **Subsequent Events**

Management has evaluated subsequent events through October 15, 2025, the date on which the financial statements were available for issuance.

The Plan was amended effective January 1, 2025 to eliminate the auto-enrollment feature of the Plan.
