Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Ag Express Electronics, Inc. Safe Harbor 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements (2024 financial statements).

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Auditor's Report on the 2023 Financial Statements

Their report dated October 11, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with GAAP, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedules, other than the information in the 2023 supplemental schedules that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 — DESCRIPTION OF PLAN

The following brief description of the Ag Express Electronics, Inc. Safe Harbor 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan, covering substantially all eligible employees of Ag Express Electronics, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code (IRC) provisions. The Company controls and manages the operation and administration of the Plan (Plan Administrator). Principal Trust Company and Principal Life Insurance Company (collectively, Principal) respectively serve as the asset custodian and recordkeeper of the Plan at December 31, 2024. Prior to December 1, 2024, Mid Atlantic Trust Company served as custodian and Paco, Inc. was the Plan's recordkeeper.

Eligibility

All employees, other than union employees and nonresident aliens, are eligible to participate in the Plan after turning 18 years of age and satisfying the service conditions. Effective September 1, 2023, employees may contribute to the Plan after completing three months of service. Prior to September 1, 2023, employees were required to complete 500 hours within six months of their date of hire to contribute to the Plan. Employees are eligible to receive employer contributions once they have completed 500 hours within six months of their date of hire. To share in the Company's discretionary contribution, an employee must also be employed on the last day of the year and work a minimum of 1,000 hours during the year.

Entry Date

Effective September 1, 2023, employees may enter the Plan on the first day of the month following the date on which they satisfy the eligibility requirements. Entry for purposes of Company contributions is semi-annually on January 1 and July 1 after becoming eligible. Prior to September 1, 2023, the Plan allowed for semi-annual entry for all participant and Company contributions.

Contributions

Each year, participants may contribute up to 100% of their annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Company makes safe harbor nonelective contributions equal to 3% of a participant's eligible compensation. Additional amounts may be contributed at the discretion of the Company's Board of Directors. For the years ended December 31, 2024 and 2023, the Company did not make an additional discretionary contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations

Investments

Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, pooled separate accounts, common collective trusts and a guaranteed interest contract as investment options for participants.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company safe harbor nonelective contributions, as well as allocations of the Company discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions as well as the Company safe harbor nonelective contributions, plus actual earnings thereon. Vesting in the Company's additional discretionary contributions is based on years of continuous service as set forth in the following table:

Participants will also vest immediately upon death, disability or reaching the normal retirement age (59½) while employed.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,656 and \$533, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses. For the years ended December 31, 2024 and 2023, administrative expenses of \$3,018 and \$6,521, respectively, were paid from forfeited non-vested accounts.

Payment of Benefits

Upon termination of service with the Company (including termination of service due to death, disability, or retirement), vested benefits will be distributed in a lump sum or in equal annual installments, based on the terms in the Plan document if the participant's vested account balance (excluding rollover contributions) exceeds \$5,000. Participants are also eligible to receive in-service distributions and hardship withdrawals if certain conditions are met.

NOTE 2 — SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the participant's contributions are withheld from compensation. Safe harbor nonelective contributions and additional discretionary contributions are recorded in the year in which the related eligible compensation is paid to the participant.

Payments of Benefits

Benefit payments to participants are recorded upon distribution. Amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not yet been paid, totaled \$51,452 at December 31, 2023. There were no outstanding distribution requests at December 31, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Self-directed brokerage accounts included in investments at fair value amounting to \$630,743 and \$1,202,258 as of December 31, 2024 and 2023, respectively, and related interest and dividends and net appreciation in fair value of investments for the years ended December 31, 2024 and 2023 are not certified. NOTE 4 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in active markets; inputs other than quoted prices that are observable for the assets or liabilities; and inputs that are derived principally from or corroborated by observable market data by correlation or other means;

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds (including money market mutual funds):* Value based on quoted prices of identical assets in active markets.
- *Common collective trusts and pooled separate accounts:* Valued based on quoted redemption values, also known as net asset value (NAV), determined by using available market information and appropriate valuation methods, as provided by Principal and represent the value at which the Plan (or the participant) could initiate a transaction with Principal.
- *Self-directed brokerage accounts –* Accounts consist of exchange traded funds, mutual funds invested cash, and publicly-traded stocks. Exchange traded funds and mutual funds are valued at the daily closing price as reported by the fund. These funds are required to publish their daily NAV and to transact at that price and are deemed to be actively traded. Common stock is valued at the closing price reported on the active market on which the individual securities are traded.

NOTE 5 — FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

During 2024, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal with a balance of \$3,649 at December 31, 2024. Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Under the terms of the contract, the crediting rate is reset on a semiannual basis. There is no minimum crediting rate.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events, such as termination of the Plan's interest in the guaranteed investment contract, might limit the ability of the Plan to transact at contract value with the issuer. If the Plan Administrator wishes to terminate the Plan's interest, the value of the Plan's interest will be paid out 12 months after the recordkeeper receives notification. In lieu of the 12-month delay, the recordkeeper may request immediate payment of the amounts requested subject to a 5% surrender fee. A 5% surrender charge will also apply if the cumulative percentage of participant transfers from the guaranteed interest account exceed 25% of the Plan's interest in the contract during the 12-month period immediately preceding the employer-level surrender of the Plan's interest in the contract. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable to occur.

There are no circumstances that would allow Principal to terminate the contract and settle at a value other than the contract value.

NOTE 6 — TAX STATUS

The Plan uses a prototype plan document sponsored by Qualified Plan Consultants (QPC). QPC received an opinion letter from the IRS, dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024 and 2023, no such positions exist.

NOTE 7 — RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in shares of common collective trusts and pooled separate accounts managed by Principal, as well as a guaranteed interest contract underwritten by Principal. Principal is the asset custodian as defined by the Plan document and these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each fund.

NOTE 8 — PLAN TERMINATION

Although it has not expressed an intention to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions set forth in ERISA. In the event the Plan is terminated, participants would become 100% vested in their accounts.

NOTE 9 — RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 — DELINQUENT PARTICIPANT CONTRIBUTIONS

During the years ended December 31, 2024 and 2023, it was noted that there were delays by the Company in submitting \$21,940 and \$19,511, respectively, of employee contributions to the trustee or custodian. The Company is in the process of filing Form 5330 and correcting for lost earnings on these delinquent participant contributions.

NOTE 11 — SUBSEQUENT EVENTS

The Company closed one of its locations on June 30, 2025 and is currently evaluating what impact, if any, the closure will have on the Plan.

The Company has evaluated subsequent events through October 14, 2025, the date which the financial statements were available to be issued.
