1) Description of plan and summary of significant accounting policies -

- A) **Description of Plan:** The following description of Trafon Group Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established as by Trafon Group, Inc. on July 1, 2017 (the Plan Sponsor) under the provisions of Section 1081.01(a) of the Internal Revenue Code for a New Puerto Rico of 2011 (the Code), which includes a qualified cash or deferred compensation arrangement, for the benefit of eligible employees of the Plan Sponsor. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - The Plan covers substantially all qualified employees of the Plan Sponsor, who have completed 9 months or services or become permanent employee.

Contributions - Each year, participants may contribute pre-tax and post-tax annual compensation up to the maximum limit allowed by the "Código de Rentas Internas para un Nuevo Puerto Rico", as amended, (\$15,000 and for participants who have attained 50 years old up \$16,500). Participants may also contribute to the Plan amounts representing distributions from other qualified benefit plans (rollover contributions). The Plan provides for participants to direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor makes a matching contribution of \$.25 of each dollar contributed (including pre - and post-tax contributions) by employees up to 6% of compensation as defined by the Plan, which excludes severance payments and others related and after completing 1 year of service. Additional profit-sharing amounts may be contributed at the option of the Plan's Sponsor board of members and are invested in a portfolio of investments as directed by the Plan's Sponsor.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contribution and, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations to each participant's account of the Plan Sponsor's discretionary contributions, as defined, are based on a pro-rata basis on the ratio the participant's compensation bears to the total compensation of all participants for the Plan year.

Allocation of Plan earnings and administrative expenses are based on the participant's account balance, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan Sponsor's matching and discretionary contributions portion of their accounts plus actual earnings thereon is based on years of service. The contribution vest as follows: 20% percent after the first 2 years of service and 20% each other year until 100% in the six years of service.

Loans to participants - Are not allowed.

Payment of benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Plan termination - Although it has not expressed any intent to do so, the Plan's Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

Forfeitures - As established by Plan document, forfeitures may be used to reduce Plan's administrative expenses, future Company contributions or to allocated to participants in a non-discriminatory basis. During the year ended December 31, 2024, forfeitures were used to finance key guaranteed insurance contract.

Party-in-interest - During the years ended December 31, 2024 and 2023, certain Plan assets are investments funds managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. which acted as the trustee of the Plan. Accordingly, transactions qualify as party-in-interest under ERISA regulations.

- B) Summary of significant accounting policies:** The accounting and financial reporting policies followed by the Plan conform with accounting principles generally accepted in the United States of America and to prevailing practices within its industry. The following is a description of the most significant of these policies:

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of estimates - Preparing the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of benefits - Normal retirement age is when participants reach 65 years of age. On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. For participants that elect early retirement, the pension benefits are payable upon the date a participant reaches 55 years old.

Hardship withdrawals - Under certain conditions, participants, while still employed by the Company, are permitted to withdraw, in a single sum, its portion of their account balance. These conditions include un-reimbursed medical expenses, the purchase of a principal residence and others.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Operating expenses - The majority of expenses for maintaining the Plan are paid by the Company.

Risk and uncertainties - The Plan's investments are exposed to various risks, such as interest rates, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes, could materially affect the amounts reported in the statements of net assets available for benefits presentation.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following is a description of the valuation methodology used for assets measurement at fair value: Level 1 fair value measurements - The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end. Level 2 fair value measurements - The fair value of investment funds for which quoted market price are not available are valued based on the market approach which utilizes process and other relevant information generated by market transactions involving identical generated assets or liabilities. Observable inputs reflect the assumptions market participants would use in valuing a financial instrument based on market data obtained from independent sources. The availability of observable market data is monitored to assess the appropriate classification of financial instruments with the fair value hierarchy.

The Key Guaranteed Portfolio Fund which is issued by Empower Annuity Insurance Company of America is a fully-benefit responsive contract which is invested in the general account of the insurance company. It has no maturity value. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. Interest credit rate is reset quarterly.

For collective trust funds valuation is made based on the net asset value. If available, an attempt is made to receive share prices from more than one source, and before the share price is entered into the recordkeeping system, a systematic comparison is performed and any difference in quoted share prices for the same fund is resolved by contacting the investment provider directly to ensure the correct share price is recorded. Variance reports are also reviewed showing percentage of share price changes from the prior day. The internal pricing analyst and management will review the overall movement of market indices and will apply judgement in determining whether any further research with investment providers will be pursued for share price variances from the prior day. Daily, after all research and validation has been performed, and variances have been resolved, share prices are closed and loaded to the recordkeeping system.

Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. The Plan evaluated the significance of the transfers between levels based upon the nature of the financial information and size of the transfer relative to total net assets available for benefits. During the years ended December 31, 2024 and 2023, there were no significant transfers in or out levels 1, 2 or 3. Plan's fiduciary of the Plan set Investment policies and strategies for trust. Long-term strategic investment objectives include preserving the funded status of the trust and balancing risk and return. The plan's fiduciary oversees the investment allocation process, which includes selecting investment managers, commissioning periodic asset-liability studies, setting long-term strategic targets and monitoring asset allocations.

4) Investment contract with insurance company -

The Plan entered into a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America. It maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. As described in the basis of accounting disclosure, because the guaranteed investment contract is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The fair value of the investment contract approximates the contract value. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than zero percent. Such interest rates are reviewed on a quarterly basis for resetting.

During the years ended December 31, 2024 and 2023, the average yield earned and credited amounted to 1.60% and 1.40%, respectively.

5) Plan termination -

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to reduce, suspend, or discontinued their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, the interest of each participating employee in the Plan shall be fully vested and such termination shall not reduce the interest of any participating employee or their beneficiaries accrued under the Plan up to the date of such termination.

6) Tax status -

The Puerto Rico Treasury Department has determined and informed the Company by letter dated April 19, 2018 (amended period), that the Plan and the related trust, as designed, qualified for tax-exempt status. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize tax liability or asset if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by regulatory agencies. The Plan's Administrator has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

7) Subsequent events -

The Plan's sponsor management evaluated subsequent events up to October 6, 2025, the date these financial statements were available to be issued. There is no subsequent events that require adjustments and/or disclosure to the financial statements.
