Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Schilling Paradise Corp. 401(k) Prevailing Wage Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (an ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Schilling Paradise Corp. 401(k) Prevailing Wage Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTE 1. DESCRIPTION OF PLAN

The following description of Schilling Paradise Corp. 401(k) Prevailing Wage Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan, which became effective on January 1, 2012, is a defined contribution plan covering all eligible employees of Schilling Paradise Corp. (the "Company" or "Sponsor") and JAAM Builders Inc., an affiliate of the Company and participating employer in the Plan. Principal Trust Company and Principal Life Insurance Company are the custodians of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the provisions of the Internal Revenue Code (the "IRC").

Eligibility

Employees of the Company are eligible to participate in the Plan with the exception of those whose employment is governed by a collective bargaining agreement under which retirement benefits were negotiated, nonresident aliens with no United States sourced earned income, and leased employees. All other employees are generally eligible to enter the Plan immediately upon their date of hire.

Contributions

Participant contributions:

Eligible participants may elect to contribute up to 100% of their pre-tax compensation, as defined, subject to limitations imposed by the IRC. Participants may elect to designate all or a portion of their contributions as Roth (after-tax) deferrals. Participants who are age 50 or older may elect to contribute additional amounts (called "catch-up contributions") to the Plan. Participants may also contribute amounts representing rollover distributions from other qualified sources.

Employer matching and profit-sharing contributions:

The Company may make matching contributions equal to a discretionary percentage of participant contributions, as determined by the employer. The Company may also make discretionary profit-sharing contributions to the Plan each year.

To share in any employer matching or profit-sharing contributions, a participant must be employed on the last day of the Plan year. In the event an employee dies during the year, or terminates employment due to becoming disabled or after reaching normal retirement age (65), this condition is waived.

In March 2025, the Company made matching contributions to the Plan for 2024 in the amount of \$313,111, which is reflected as an employer contribution receivable as of December 31, 2024. The Company matched 100% of participant contributions up to 3% for the year ended December 31, 2024. The Company made no profit-sharing contributions to the Plan for 2024.

NOTE 1. DESCRIPTION OF PLAN (Continued)

Employer prevailing wage contributions:

The Company makes prevailing wage contributions on behalf of each participant who performs services subject to certain federal, state, or municipal prevailing wage statutes. The prevailing wage contribution is equal to the balance of the fringe benefit payment for health and welfare for each participant (after deducting the cost of cash differential payments for the participant) based on the hourly contribution rate for the participant's employment classification, as defined. The prevailing wage contributions are not subject to age and service requirements and are fully vested upon contribution. For 2024, the Company made prevailing wage contributions to the Plan in the amount of \$300,626, of which \$9,751 is a receivable at December 31, 2024.

Participant Accounts

All investments are participant-directed. Each participant's account is credited with the participant's contributions, any employer matching and prevailing wage contributions, and an allocation of (a) any profit-sharing contributions made by the employer, (b) investment earnings and losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are always fully vested in their contributions and employer prevailing wage contributions, plus actual earnings thereon. Participants vest in any employer matching and profit-sharing contributions in accordance with the following schedule:

In the event of termination due to death or total and permanent disability, or upon reaching normal retirement age, participants shall become 100% vested in all aspects of their accounts.

Investment Options

Upon enrollment in the Plan, participants may direct their contributions and any employer contributions to any of the Plan's investment options. Subsequently, participants may change their allocations and transfer account balances between investment options in accordance with Plan provisions.

NOTE 1. DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants (Participant Loans)

Participants may borrow against their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested interests in their account balances, reduced by the highest outstanding loan balance in their account during the prior twelve-month period. Participants may have up to four loans outstanding at any one time. Such loans are required to be repaid within five years. Loans are secured by a participant's vested account balance. Participant loans bear a fixed rate of interest set at the time of the loan and equal to the prime interest rate, as defined, plus 1%. Principal and interest are paid regularly to the Plan directly by participants who receive a monthly remittance notice and/or through payroll deductions. As of December 31, 2024, the interest rate on outstanding loans ranged from 4.25% to 9.50%.

Payment of Benefits

Upon disability, death, termination, or retirement, participants or their beneficiaries may receive a distribution of their vested accounts in a lump sum, partial payments, or defer distribution until a later date if the account exceeds \$5,000. Pursuant to the provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 (the "SECURE" Act), which became law on December 20, 2019, and the SECURE 2.0 Act of 2022 (the "SECURE 2.0 Act"), which became law on December 29, 2022, participants may defer taking distributions as follows:

- If a participant reached the age of 70½ in 2019, the participant may defer receiving distributions until the later of April 1, 2020, or the April following the calendar year in which the participant retires;
- If a participant reached the age of 70½ in 2020 or later, the participant may defer receiving distributions until the later of the April following the calendar year in which the participant reaches age 72 or retires, except that –
- Beginning in 2023, the age a participant must begin taking distributions was raised to 73. If a participant reached the age of 72 during 2023, the participant may defer receiving distributions until April 1, 2025, the latest date that a required minimum distribution may be taken for 2024.

Upon termination of employment, if a participant's vested account balance is less than \$5,000, but greater than \$1,000, and if the participant has not elected to receive a cash distribution or have the balance rolled over into another qualified retirement account of his/her choosing, the Plan may roll the balance into an individual retirement account designated by the Plan administrator. Also, at its discretion, the Plan may elect to distribute vested account balances of less than \$1,000.

A terminated participant may withdraw all or a portion of their vested employer contribution account balances as defined in the Plan document. In certain other situations, participants may also withdraw their vested funds while still employed with the Company. Participants may withdraw all or part of their vested account balances once they reach age 59½. At any time and at any age, participants may withdraw any amounts representing rollover contributions into the Plan. In addition, participants may withdraw all or a portion of their salary deferral account balances upon approval of the Plan administrator and subject to Internal Revenue Service ("IRS") hardship withdrawal rules.

Forfeitures

The nonvested balance of a separated participant's account is forfeited when a distribution of vested benefits is made. For separated participants who do not receive a distribution of vested benefits, the nonvested balance is forfeited after five consecutive years of breaks in service have occurred (as defined). Forfeitures may be used at the discretion of the Company for any allowable purpose. The forfeitures balances and activity are minimal as of December 31, 2024 and 2023 and for the year ended December 31, 2023.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan, such as legal, accounting, and other fees are paid by the Company. Certain account-specific fees, such as any distribution or loan fees, are paid from the accounts of the transacting participants.

Notes Receivable from Participants (Participant Loans)

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Subsequent Events

The Plan has evaluated subsequent events through the date of the independent auditors' report, which is the date these financial statements were available to be issued.

NOTE 3. INFORMATION CERTIFIED BY THE CUSTODIANS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the ERISA-required supplemental schedule (Schedule H, Part IV, Line 4i), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net realized and unrealized appreciation or depreciation in fair value of investments, and interest and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company, the custodians of the Plan.

NOTE 4. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain of the Plan's operating expenses are paid by the Company. The Company also provides administrative services for the Plan at no cost to the Plan. In addition, certain investments are managed by the custodians of the Plan's assets. These transactions qualify as exempt party-in-interest transactions.

NOTE 5. INCOME TAX STATUS

The Sponsor has adopted a non-standardized pre-approved profit sharing plan and relies upon the opinion letter from the Internal Revenue Service ("IRS") which states that, in its opinion, the pre-approved plan and related trust are designed in accordance with applicable sections of the IRC. The Company has not applied for a determination letter from the IRS specific to the Plan. In addition, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the accompanying financial statements.

NOTE 5. INCOME TAX STATUS (Continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 6. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement for the asset or liability at the measurement date. These inputs reflect Plan management’s best estimate of what market participants would use in pricing the asset or liability at the measurement date. Consideration is given to the risk inherent in the valuation technique and in the inputs to the model.

NOTE 6. FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments measured at fair value at December 31, 2024 and 2023. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts: Valued at the net asset value which is not publicly traded but is available to current investors. The common/collective trusts' annual report with underlying asset information is available. The net asset value is the basis for current transactions and the common/collective trusts can be redeemed at net asset value as of the measurement date for its readily determinable fair value.

Pooled separate accounts: Valued at the net asset value which is not publicly traded but is available to current investors. The net asset value is the basis for current transactions and the pooled separate accounts can be redeemed at net asset value as of the measurement date for their readily determinable fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7. RISKS AND UNCERTAINTIES

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the accompanying financial statements.

NOTE 8. EXCESS CONTRIBUTIONS DUE TO PARTICIPANTS

To satisfy certain nondiscrimination provisions of the Plan for the years ended December 31, 2024 and 2023, \$14,478 and \$23,668, respectively, of excess participant contributions were disbursed from the Plan subsequent to each respective year end. The December 31, 2024 amount has been netted against participant contributions in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. The 2024 IRS Form 5500, Schedule H, Part II presents the excess contributions as corrective distributions, a separate category of deductions from net assets.

NOTE 9. SECURE 2.0 ACT

On December 29, 2022, the SECURE 2.0 Act became law. The purpose of the legislation is to expand access to retirement plans and to help working Americans increase their retirement saving. In addition to the changes to required minimum distributions described in Note 1, the SECURE 2.0 Act includes various required and optional provisions that become effective through 2033, certain of which are described below:

- Beginning in 2027, catch-up contributions will be made on a Roth basis, unless the participant earns \$145,000 or less.
- Beginning January 1, 2025, a participant from the ages 60 to 63 can elect catch-up contributions up to the limit of the greater of \$10,000 or 150% of the catch-up contribution limit imposed by the IRS.
- Starting January 1, 2025, long-term part-time workers (defined as employees who have worked for two consecutive twelve-month periods during each of which they have at least 500 hours of service) will become eligible to enroll in their employer's retirement plan after two years.

Plan management has not yet determined which of the optional provisions, if any, the Plan will implement. Plan management expects to formally amend the Plan by December 31, 2026.
