## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ancora 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## **NOTES TO FINANCIAL STATEMENTS**

### **NOTE A - DESCRIPTION OF PLAN**

The following description of the Ancora 401(k) Plan (Plan) only provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Management has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued and, except for the disclosure in Note G, has no material subsequent events to report.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of STVT-AAI Education Inc. (Company, Employer, or Sponsor). The Plan is qualified under the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). For salary deferrals, employer discretionary matching, and discretionary contributions, employees must be at least 21 years of age and have completed 2 months of service.

#### **Contributions**

Participants may make pretax contributions and Roth contributions to the Plan up to the maximum percentage allowable by the IRC. Plan limits are indexed to follow changes in the federal limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Roth deferrals are also permitted by the Plan. If a participant has not selected their salary deferral percentage upon meeting the eligibility requirements, the Plan Sponsor will automatically withhold 3% of a participant's compensation and contribute that amount as a salary deferral. The withholding percentage automatically increases 1% at the beginning of each calendar year, to a maximum rate of 10%. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants.

The Employer may also elect to make a discretionary matching contribution. Discretionary matching contributions, if any, are determined annually by management. The participant must complete at least 1,000 hours during the Plan year and be employed on the last day of the Plan year to be eligible. The participant's share of discretionary matching contribution is equal to a percentage of the participant's salary deferral. During 2024, the Employer's discretionary match was for the first 2% of the employee's salary deferral.

#### **Participant Accounts**

Each participant account is credited with the participant's contribution and an allocation of (a) the Employer's matching, Non-Elective and Qualified Non-Elective contributions, if any, (b) Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

#### **Vesting**

Participants are immediately vested in their contributions and associated earnings thereon. Vesting in the Employer contribution portion of their accounts is based on years of continuous service. Participants hired before January 1, 2020 are 100% vested in employer contributions after one year of service. Participants hired subsequent to January 1, 2020, become vested in employer contributions after five years of service, earning 20% after each year of service.

#### **Notes Receivable from Participants**

The Plan allows for a participant loan in amounts not less than \$1,000. The maximum amount of any loan is the lesser of (i) 50% of the participant's vest account, reduced by any outstanding loan balance or (ii) \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan is made. The loans are secured by the balance in the participant's account and bear interest at an agreed-upon percentage based on prevailing market rates. Loans must be repaid in level payments through payroll deductions over a five-year period unless for the purchase of a principal residence, in which case the note repayment period shall be limited to a period consistent with commercial home loan practices. The loans outstanding at December 31, 2024 have interest rates of 5.25% to 9.50%.

#### **Payment of Benefits**

Participants receive benefit payments based on the vested portion of their account balance upon death, retirement or attainment of age 59½, disability, or termination of employment. Benefit payments in amounts defined by law as "required minimum distributions" must commence by age 73, unless the participant is an active employee. All benefits other than "required minimum distributions" may be paid in the form of a lump sum or in installment payments over a period not to exceed the participant's and beneficiary's expected life expectancies.

Employees may request a distribution of a portion of their contributions in the event of a documented financial hardship. The distribution is limited to the amount of the hardship, which must arise from certain events prescribed by law.

#### **Forfeited Accounts**

Forfeited accounts may be used to offset Plan administrative expenses or to reduce future Employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$74,856 and \$21,291, respectively. During the year ended December 31, 2024, there were no forfeitures were used to pay Plan administrative expenses or to reduce employer contributions.

#### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's guaranteed interest contract is deemed to be fully-benefit responsive at December 31, 2023.

### **NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Use of Estimates in the Preparation of Financial Statements**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### **Valuation of Investments and Investment Income**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses are determined on the basis of specific identified cost. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

#### **Notes Receivable from Participants**

Participant loans are presented at their unpaid principal balance plus accrued interest. Interest income is recognized monthly on the accrual basis. When a borrower does not make a loan repayment by the end of the calendar quarter following the quarter when payment was due, the loan is deemed to be in default and is deemed a distribution to the participant.

As of December 31, 2024 and 2023, there were approximately \$99,000 and \$71,000, respectively, of loans classified in default under the terms of the plan included in the notes receivable from participants balance on the accompanying statement of net assets available for benefits.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Operating Expenses**

The Plan's custodian and third-party administrator charge various administrative fees relating to recordkeeping services performed under contract to the Plan. Under no circumstances will compensation be paid by the Plan to the Employer for services rendered as administrator. Certain expenses of maintaining the Plan may be paid by the Employer. The Employer paid approximately \$76,000 in operating expenses on behalf of the Plan during the year ended December 31, 2024.

### **NOTE C - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820 - *Fair Value Measurements and Disclosures* establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB Codification Topic 820 are described as follows:

**Level 1** - Inputs in the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation methodology include:

Quoted prices for similar assets in active markets.

Quoted prices for identical or similar assets in inactive markets.

Inputs other than quoted prices that are observable for the asset.

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual funds:** Valued at the net asset value (NAV) of shares held by the Plan at year end.

**Pooled separate accounts:** Valued at unit value calculated based on the net asset value of the underlying investments. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value.

## **NOTES TO FINANCIAL STATEMENTS**

### **NOTE D – INVESTMENT CONTRACT WITH INSURANCE COMPANY**

The Plan previously had a benefit-responsive guaranteed interest account with Principal Life Insurance Company (Principal) through a group annuity contract. During 2023, the plan switched to a new custodian, as such the contract with Principal was terminated, which included the decision to no longer utilize the benefit-responsive guaranteed interest account with Principal through a group annuity contract. Principal maintained the contributions in a general account. The account was credited with earnings on the underlying investments and was charged for participant withdrawals and administrative expenses. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Principal considers this investment option to be fully benefit-responsive notwithstanding the liquidation value events (see below) under the contract that limit the ability of the Plan to transact at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2023 was \$157,834. The crediting interest rate is based on the earnings of the underlying assets used to determine the guaranteed interest account's crediting rate, as compared to the minimum interest crediting rate and prevailing market conditions. In no case will the minimum crediting interest rate be less than 1% or greater than 3% based on the Plan's group annuity contract. The crediting interest rate is reviewed on a quarterly basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value. Such events include but may not be limited to the following: (1) temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the Employer; (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the Plan Sponsor's business; (5) removal from the Plan of one or more groups or classifications of participants; (6) partial or complete Plan termination; or (7) Plan disqualification. Consult the Plan's group annuity contract for further information.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

During 2023, the plan changed custodians, however, the investment contract included a 12-month put and was not transferred to the new custodian at the time all other plans assets were transferred. During 2024, once allowed under the investment contract, the investment contract with the insurance company was liquidated, and the Plan on longer holds any such contracts as of December 31, 2024.

## **NOTES TO FINANCIAL STATEMENTS**

### **NOTE E - INFORMATION CERTIFIED BY CUSTODIANS (UNAUDITED)**

Management has elected the method of annual reporting permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. BOKF, NA held the Plan's investment assets and executed investment transactions from October 10, 2023 to December 31, 2023, and for all of 2024. Principal Life Insurance Company and its affiliates held the Plan's investment assets and executed investment transactions for the period January 1, 2023 to October 9, 2023, with the exception of the plan's investment in insurance contracts and pooled separate accounts, which were held for the year ended December 31, 2023 and until liquidation occurred during 2024. Accordingly, Principal Life Insurance Company and its affiliates, and BOKF, NA, qualified institutions, have certified that the following information included in the accompanying financial statements and the ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest (including interest on notes receivable from participants), dividends and net appreciation of investments as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of the year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of management, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statement and ERISA-required supplemental schedule.

### **NOTE F - RISK AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **NOTE G - PLAN TERMINATION AND SUBSEQUENT EVENT**

The Employer may discontinue its contributions to the Plan at any time, and terminate the Plan subject to regulations under ERISA. In the event of a Plan termination, participants will become 100% vested in their entire account balance (Note H). Effective April 1, 2025, the Employer was acquired, and the determination was made to terminate the Plan.

### **NOTE H - COMMITMENT**

The Plan's investments include \$1,904,036 allocated to participants who have withdrawn from the Plan as of December 31, 2024 but have not yet been paid. These participants may elect to withdraw their vested balances at any time. Due to the decision to terminate the Plan in 2025 (Note G), participants will become 100% vested in their entire account balance.

## **NOTES TO FINANCIAL STATEMENTS**

### **NOTE I - TAX STATUS**

The Internal Revenue Service has determined and informed the Plan by letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### **NOTE J - PARTY-IN-INTEREST TRANSACTIONS**

Participant loans are managed by BOKF, NA, which is the custodian and record keeper of the Plan (Note E). Therefore, these transactions qualify as party-in-interest transactions.

### **NOTE K - PROHIBITED TRANSACTIONS**

During the Plan years ended December 31, 2024 and 2023, employee elective deferrals in the amount of \$456,780 and \$101,035, respectively, were not remitted within the appropriate time period by the Employer. These transactions constituted prohibited transactions as defined by ERISA. During 2024, all corrections for late contributions that occurred during 2023 were made. The Employer intends to correct the situation and implement a procedure to ensure all future remittances are done within the prescribed time period.

### **NOTE L - EXCESS EMPLOYER MATCHING CONTRIBUTION**

During 2021, the Employer contributed excess matching contributions to participant accounts in the amount of approximately \$51,000. The Employer is in the process of taking steps to correct the situation. During a previous year, \$40,146 had been refunded to the Plan's suspense account. The remaining balance due to the Plan Sponsor for the excess employer match of \$11,141 is recorded as a liability on the statement of net assets available for benefits as of December 31, 2024 and 2023.
