Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of Albert & Mackenzie, LLP 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants and other interested parties should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that was established by Albert & Mackenzie, LLP (the Employer) effective January 1, 2001. Effective July 1, 2021, employees become eligible to participate and contribute to the Plan after completing at least 250 hours of service in three consecutive months. Employees become eligible to receive Employer Safe Harbor matching contributions after completing one year of service. Enrollment relative to employee deferrals, Employer Safe Harbor matching contributions, and Employer discretionary matching contributions is effective on January 1 and July 1 of each Plan year coinciding with or following satisfaction of the eligibility requirements. Employees become eligible for Employer Safe Harbor matching contributions and Employer discretionary matching contributions after completing one year with 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may contribute up to 100 percent of their pretax annual compensation as defined in the Plan, subject to certain limitations as prescribed by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions or rollovers from other qualified defined benefit or defined contribution plans. The Plan offers a Roth 401(k) option. Participants direct the investment of their contributions and Employer matching and profit sharing contributions into various investment options offered by the Plan.

The Employer may elect to make discretionary matching and profit sharing contributions, subject to certain limitations, to the Plan in an amount determined by the Employer. For the year ended December 31, 2024, the Employer made a discretionary profit sharing contribution in the amount of approximately \$507,000 included in employer contributions in the statement of changes in net assets available for benefits.

The Employer adopted a 401(k) Safe Harbor provision to satisfy certain IRC requirements and eliminate the need for the Plan to perform certain annual nondiscrimination tests. Under the provision, the Employer has elected to make guaranteed company contributions to all participants equal to 3 percent of participant compensation, determined on an annual basis. The participants are immediately fully vested in these contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) Employer contributions, (b) Plan earnings net of certain investment and management fees and (c) forfeitures. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 reduced by the highest outstanding loan balance in the participant's account during the prior 12-month period, or 50 percent of their vested account balance. Loan terms range from 1 to 5 years, or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at local prevailing rates as determined quarterly by the plan administrator. Principal and interest is paid ratably through bi-weekly payroll deductions.

**Withdrawals**

The government places certain restrictions on withdrawals in order to retain the special tax-saving benefits associated with the Plan. The Plan allows withdrawals at retirement, disability, separation of service, or upon death. Other withdrawals are available only in cases of immediate and heavy financial hardship, subject to Internal Revenue Service (IRS) regulations.

**Vesting**

Participants are immediately vested in their contributions and Employer contributions made under the Safe Harbor provision plus accumulated earnings thereon. Employer contributions other than Safe Harbor plus accumulated earnings thereon are vested based on a graded vesting schedule whereby a participant is 100 percent vested after 6 years of credited service. A participant is 100 percent vested upon reaching retirement age, death, permanent disability or termination of the Plan by the Employer.

**Benefit Payments**

Upon termination of service due to retirement or permanent disability, participants will receive cash in one lump-sum payment equal to the value of the participants' vested interest in their account. In the event of a participant's death, payment of the vested value of the participant's account is made to their beneficiary in one lump-sum payment.

**Forfeited Amounts**

These accounts may be used to either pay for Plan expenses or reduce future Employer contributions. As of December 31, 2024 and 2023, there were approximately \$75,000 and \$69,000, respectively, of forfeited nonvested accounts included in Plan assets.

**Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their Employer contributions.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

**Investments and Valuation Techniques**

Investments, other than common collective trusts (CCT), are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan invests in T. Rowe Price Retirement Blend Select Trusts with various target dates, which primarily invests in equity and fixed income mutual funds that represent various asset classes and sectors. The Plan's interest in the fund is valued at the Net Asset Value (NAV) practical expedient of the underlying investments reported by the issuer of the CCT at year-end. This practical expedient would not be used if it was determined to be probable that the Plan will sell the investments for an amount different from the reported NAV. See Note 3 for discussion of fair value measurements.

Cash and cash equivalents are recorded at cost, which approximates market value. Mutual funds are valued at quoted market price, which represents the net asset value of shares. The underlying securities in each pooled separate account are listed on national securities exchanges and valued on the basis of year-end closing prices. Securities traded in the over-the-counter market are valued at closing price on the last business day of the year. Net appreciation and depreciation in fair value of investments includes realized and unrealized gains and losses on investments sold or held during the year.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from investments is recorded on the cash basis, which approximates the accrual method of accounting. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

**Expenses**

Non-investment costs, primarily accounting and administrative expenses of the Plan are paid for by the Employer, which is a party-in-interest. These expenses, which are not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions. Investment advisory services and certain administrative fees paid by the Plan or charged against Plan investment activities are included in the statement of changes in net assets available for benefits.

**Payment of Benefits**

Benefits are recorded when paid.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**NOTE 3 - FAIR VALUE MEASUREMENTS**

Fair value measurements establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active and inactive markets, inputs other than quoted prices that are observable for the asset or liability for substantially the full term of the financial instrument, and inputs that are derived from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

There have been no changes in methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - TAX STATUS**

The Plan was formed using a pre-approved format by the IRS for qualification under Section 401(a). This format last received approval by the IRS on March 31, 2014. The Plan has been amended since receiving the determination letter. However, the Employer believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, qualifies under Section 401(a) and the related trust is tax-exempt. Thus, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets Available for benefits.

**NOTE 8 - RELATED-PARTY TRANSACTIONS**

Certain plan investments are interests in an investment contract and mutual funds managed by the Custodian. These transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services and certain administrative costs approximated \$38,000 for the year ended December 31, 2024.

**NOTE 9 - SUBSEQUENT EVENTS**

The date to which events occurring after December 31, 2024 have been evaluated for possible adjustment to the financial statements or disclosure is October 14, 2025, the date on which the financial statements were issued.
