## INDEPENDENT AUDITOR'S REPORT

To the Trustees of the  
Coversafe 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of the Coversafe 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution, Charles Schwab Trust Bank, as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion on the 2024 Financial Statements**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAS.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

#### **NOTE 1. DESCRIPTION OF PLAN**

The following description of the Coversafe 401(k) Plan (the Plan) provides general information. Participants should refer to the plan document for a more comprehensive description of the Plan's provisions.

**General** - The Plan is a single employer plan established on November 1, 2020. All employees of the Company, except for certain ineligible classes of employees (union employees whose employment is governed by a collective bargaining agreement, non-resident aliens and leased employees) who have completed nine months of consecutive employment and 1,000 hours of service and are at least 21 years old are eligible to make contributions and receive employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The plan administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors.

**Contributions** - Each year participants may contribute the maximum amount allowed under the Internal Revenue Code (IRC) of pre-tax and Roth reduction contributions. If a participant elects to contribute to the Plan, they may contribute by a specific percentage or dollar amount of their compensation. Participants' contributions to the Plan are made by means of payroll deductions during each regular payroll period. Participants direct investments of their contributions into various investment options offered by the Plan. Employees may also choose to end their participation in the Plan at any time.

The Plan allows for discretionary employer matching contributions to be made. Employees are eligible for the employer contribution matching contribution if they have attained the age 21 and nine months of consecutive employment and completed 1,000 hours. Employees are eligible for the profit sharing contribution if they have reached the age 21 and completed one year of service. In addition, the Plan provides for a safe-harbor contributions matching 100% of salary deferrals that do not exceed 3% of the employee's compensation plus 50% of employee salary deferrals between 3% and 5% of compensation. This safe harbor matching contribution is 100% vested.

Rollover contributions from other qualified plans and individual retirement accounts are allowed by the Plan.

**Participant accounts** - Each participant's account is credited with their own salary deferral contributions, their rollover contributions from other plans and the Company's contributions as well as investment earnings (losses) within the participant's account. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**NOTE 1. DESCRIPTION OF PLAN (continued)**

**Vesting** - Participants are vested immediately in their deferred contributions and their rollover contributions plus actual earnings (losses) thereon, as well as the Company's contribution plus actual earnings (losses) thereon. Vesting in the Company's discretionary contributions portion and net earnings (losses) is based on years of continuous service. A participant is 100% vested after five years of credited service.

**Notes Receivable from Participants** - Participants may receive loans of up to 50% of their vested account balances. Amounts may be borrowed between \$1,000 and \$50,000, utilizing the participant's remaining account balance as security for the loan. The interest rate for any loan is calculated at 1% above the prime rate. Loans must be repaid through payroll deductions within five years unless the loan is used for the purchase of the participant's primary residence, in which case the loan may be repaid under an alternative time frame as determined by the plan administrator. Participants who do not repay their loans under certain circumstances, as defined in the Plan, will be deemed to have received a distribution for federal income tax purposes under the Plan. Principal and interest are paid ratably through weekly payroll deductions.

**Hardship Withdrawals** - In the event of financial hardship, as defined under the Plan and under current Internal Revenue Service rules, participants are permitted to receive hardship withdrawals from the vested portion of own elective deferrals.

**Payment of Benefits** - On separation of service due to death, disability, termination or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In the event of a participant's death or disability before termination of employment and before distribution of benefits has begun the amount of the participant's vested account balance will be payable in a single lump-sum to the participant's beneficiary(ies).

Participants may withdraw their vested account balances once they reach age 59½.

Other distribution methods under the Plan are available to beneficiaries depending on vested account balances.

**Forfeited Accounts** - There was \$-0- of forfeited non-vested account balances that were used to reduce employer contributions and Plan expenses during 2024.

**Investment Options** - Participants direct the investment of all contributions within their own accounts into various investment options consisting of various mutual funds and a common/collective trust account offered by the Plan.

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting generally accepted in the United States of America.

## NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Use of Estimates** - The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America (GAAP), requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition** - Plan investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's plan administrator determines the Plan's valuation policies utilizing information provided by investment advisers and the custodian. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. In the event a participant separates from employment while any loan is outstanding, the unpaid balance and any interest due thereon shall become due and payable by the end of the cure period.

**Payments of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - Participants of the Plan are charged fees by the custodian for the processing of loans and distributions from the Plan. Investment related expenses are included in net change in fair value of investments.

Investment advisory fees, as well as other administrative expenses of the Plan, such as third party administrator fees and Plan audit fees, are paid by the employer.

## NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIAN

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been prepared and certified to as complete and accurate by Charles Schwab Trust Bank, the custodian of the Plan.

**NOTE 4. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Charles Schwab Trust Bank is the investment custodian of the Plan as of December 31, 2024 and 2023. As a provider of services to the Plan, Charles Schwab Trust Bank is custodian and is considered a party-in-interest as defined under ERISA. These party-in-interest transactions have been denoted as such on the Supplemental Schedule of Assets Held at End of Year. Charles Schwab Trust Bank receives fees for their services from the employer.

Notes receivable from participants totaled \$83,160 at December 31, 2024 and interest income on notes receivable from participants totaled \$4,156 for the year ended December 31, 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 6. TAX STATUS**

Management believes the Plan is designed and currently being operated in compliance with the applicable requirements of the Internal Revenue Code (IRC).

The Plan, as of September 1, 2021, has been re-stated under the Defined Contribution Pre-Approved Plan of the Plan's third party administrator, Blue Star. Their latest determination letter for its preapproved plan is dated June 30, 2020, which the Company is relying on with respect to qualification of its Plan.

## **NOTE 6. TAX STATUS (continued)**

Accounting principles generally accepted in the United States of America, require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE 7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statements of net assets available for benefits. Given recent volatility in the financial markets, it is reasonably possible that investment values could decline in subsequent periods.

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

## **NOTE 8. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

## NOTE 8. FAIR VALUE MEASUREMENTS (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value, as well as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trusts:* Valued using the NAV per share provided by the investment fund's trustee and is determined by the fair value of the underlying assets within the portfolio. NAV is used as a practical expedient to estimate fair value.
