## Independent Auditors' Report

To the Plan Administrator and Plan Trustees

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Lucky Star Casino 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## NOTES TO FINANCIAL STATEMENTS

### LUCKY STAR CASINO 401(K) RETIREMENT SAVINGS PLAN

DECEMBER 31, 2024

#### NOTE A--DESCRIPTION OF THE PLAN

The following description of the Lucky Star Casino 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan with a cash or deferred arrangement covering all permanent, full-time employees who have one year of service, as defined in the Plan agreement, and are age 18 or older. Employees of the Lucky Star Casino locations in Concho, Clinton, Canton, Hammon and Watonga, Oklahoma, and employees of the Travel Plaza Casino and C-Stores in Concho and Hammon, Oklahoma (collectively the "Casino") are allowed to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees may enter the Plan on the first day of the Plan year and the first day of the fourth, seventh, and tenth months of the Plan year coinciding with the date on which the employee satisfies the applicable eligibility requirements. All newly hired employees are automatically enrolled in the Plan at a 3% withholding rate upon becoming eligible to participate in the Plan. Employees can elect out of automatic enrollment by signing a waiver not to participate in the Plan.

Contributions: Each participant may elect to contribute up to the lesser of the participant's eligible compensation or the maximum amount allowed by the Internal Revenue Service (IRS). The IRS' limit was \$23,000 for 2024. Plan participants age 50 and older were eligible to make catch-up contributions of an additional \$7,500 for 2024. The Plan also permits participants to make rollover contributions from other qualified plans.

The Casino contributes a safe harbor matching contribution of an amount equal to 100% of each participant's elective contributions, up to a maximum of 3% of the participant's eligible compensation plus an additional matching contribution of an amount equal to 50% of each participant's elective contributions that exceed 3% of the participant's eligible compensation, up to a maximum of 6% of the participant's eligible compensation.

Participant Accounts and Investment Options: Participants may direct the investment of their contributions into a group annuity contract, common collective trust, and various mutual funds, which are registered under the Investment Company Act of 1940.

Each participant's account is credited with the participant's contribution, an allocation of the Casino's contribution and Plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

NOTE A--DESCRIPTION OF THE PLAN--CONTINUED

Vesting: Participants are immediately vested in their contributions and the Casino's matching contributions and any earnings thereon.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes receivable from participants are secured by the balance in the participant's account and bear interest at reasonable rates determined by the Plan Administrator. Principal and interest are paid ratably through weekly payroll deductions. A loan is considered in default as of the last day of the calendar quarter following the calendar quarter in which an unpaid installment payment was due.

Payment of Benefits: Upon termination of employment for reasons other than death, disability, or retirement, the participant is entitled to receive a lump sum payment equal to his or her vested interest. If the participant's vested benefit in the Plan exceeds \$1,000, the participant must consent to the distribution before it can be made. Participants that have a vested benefit that does not exceed \$1,000 will receive a lump sum payment as soon as practicable following the event entitling the participant to a distribution. Certain early distributions made upon termination of employment may be subject to a penalty.

At December 31, 2024, net assets available for benefits included approximately \$2,632,000 relating to former participants who have elected, for the present time, to leave their balances intact with the Plan.

Upon retirement at age 65, retirement due to disability or the death of the participant, the participant or participant's designated beneficiary is entitled to receive the participant's entire account balance.

Hardship withdrawals are permitted up to the amount of the participant's account balance attributable to their contributions made to the Plan. Hardship withdrawals are only permitted for certain specific uses as defined in the Plan agreement.

Plan Termination: Although it has not expressed any intent to do so, the Casino has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits: Benefits are recorded as expenses when paid.

Administrative Expenses: Certain administrative functions of the Plan are performed by employees of the Casino. Neither the employees nor the Casino receive any compensation from the Plan for these services.

The majority of administrative expenses of the Plan are paid by the Casino. Account transaction costs are deducted from participant accounts. Any administrative fees for services are paid from the assets of the funds and therefore reduce the overall return offered by the funds.

Income Tax Status: The Plan was initially adopted September 1, 2007, and effective May 19, 2021, the Casino restated the Plan with the adoption of the Adoption Agreement #001 Non-Standardized Defined Contribution Pre-Approved Plan. The Plan adopted the Empower Trust Company, LLC Defined Contribution Pre-Approved Plan. The Plan has been amended since receiving the latest approved determination letter from the IRS. However, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of December 31, 2024 and 2023. Accordingly, no provision for income taxes has been included in the accompanying financial statements.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

#### NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES--CONTINUED

Notes Receivable from Participants: Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant's loan balance is reduced and a benefit payment is recorded.

Subsequent Events: Plan management has evaluated subsequent events through September 24, 2025, which is the date the financial statements were available to be issued, and determined that there were no subsequent events requiring recognition or disclosure.

#### NOTE C--INVESTMENT CONCENTRATION, RISKS AND UNCERTAINTIES

As of December 31, 2024, approximately 25% of Plan assets consist of the two mutual funds.

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### NOTE D--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820-10-35-39 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to contract at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value.

*Group annuity contract:* Valued at fair value by the issuer based on the published value of the underlying variable investments and by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer of the fixed income investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
