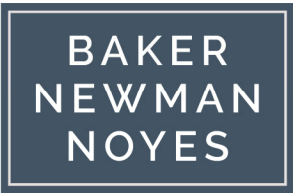

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Barton & Gray Mariners Club, LLC 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. Description of the Plan

The following description of the Barton & Gray Mariners Club, LLC 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Barton & Gray Mariners Club, LLC (the Company) for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The Company is the sponsor of the Plan. John Hancock Life Insurance Company serves as the trustee of the Plan.

The Plan was restated effective July 1, 2024. As a result of this restatement, notes receivable from participants are allowed within the Plan effective July 1, 2024. No other significant changes to plan operations resulted from this restatement.

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

Eligibility and Participation

Employees are eligible to participate in the Plan after having completed six months of consecutive service. If the service requirement is not met in the first consecutive period of months, employees can become eligible if they complete 1,000 hours of service in a Plan year. A participant can enter the Plan on the first day of the quarter coinciding with or next following the date on which eligibility is established.

The SECURE 2.0 Act expanded eligibility for certain long-term part-time (LTPT) employees. Effective January 1, 2024, part-time employees who have completed at least 500 hours of service in the three most recent consecutive years (2021-2023) are eligible to participate in the Plan. Effective January 1, 2025, the requirement is being reduced from three to the most recent two consecutive years (2023-2024).

Contributions

Each participant may elect to defer pretax compensation or post-tax Roth compensation, as defined in the Plan, up to the maximum amounts allowed by the Internal Revenue Service (IRS). The Plan permits catch-up contributions for eligible participants who are 50 years or older by the end of the calendar year and who are currently making deferral contributions. Participants may elect to rollover distributions from other qualified retirement plans. Participants may change their salary reduction contribution at each pay period. At the participant's option, contributions may be invested in certain funds offered by the Plan.

The Company's safe harbor matching contributions are 100% of each participant's first 3% of eligible compensation deferred, and then 50% of the next 2% of eligible compensation deferred. The Plan allows the Company to make discretionary profit-sharing and matching contributions. No such discretionary profit-sharing or matching contributions were made for the year ending December 31, 2024.

1. Description of the Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) any Company contributions and, (b) Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and employer safe harbor matching contributions, plus investment earnings or losses thereon. Participants are vested in employer discretionary profit-sharing and matching contributions on a six-year schedule, starting at 20% vesting after 2 years of service and increasing 20% each year thereafter.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts included in net assets available for benefits were not material. Forfeitures may be used to pay Plan administrative expenses or reduce employer contributions. For the year ended December 31, 2024, the amount of forfeitures used was not material.

Payment of Benefits

In-service withdrawals from the participant's elective accounts are permitted only due to financial hardship or upon reaching age 59 ½. Participants are entitled to a distribution upon their death, disability, retirement, or termination of employment. The method of distribution is elected by the participant, subject to the terms and conditions of the Plan. Participants may withdraw from their rollover fund account at any time. The Plan allows the Plan Administrator to automatically distribute to terminated participants their entire account balance if it is less than \$5,000. Effective July 1, 2024, the Plan provided for the optional provision with the SECURE 2.0 Act to increase the mandatory cash out threshold from \$5,000 to \$7,000.

Notes Receivable from Participants

Effective July 1, 2024, participants may borrow from their elective deferral fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of the participant's vested balance or \$50,000 (reduced by any outstanding note balance in the previous 12 months). Notes are secured by the balance in the participant's elective deferral account and bear interest at the prime rate at issuance plus 1%. A participant may have a maximum of one note outstanding at any time. Repayments of principal plus interest is required within five years unless the note is for the purchase of a principal residence. Principal and interest are paid ratably through payroll deductions.

1. **Description of the Plan (Continued)**

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid by the Plan, to the extent they are not paid by the Company. Certain fees incurred by the Plan for investment management and certain administrative services are paid through revenue sharing rather than direct payment.

Plan Termination

Although it has not expressed any intent to terminate the Plan, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their account balances.

2. **Summary of Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Risks and Uncertainties

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Payment of Benefits

Benefit payments are recorded when paid.

Contributions

Contributions are recorded in the period in which payroll deductions are made; employer matching and safe harbor matching contributions are recorded in the same period as the related participant contributions. Employer discretionary profit-sharing contributions are determined on an annual basis and recorded in the year for which the related employee service was performed.

Notes Receivable from Participants

Effective July 1, 2024, notes receivable from participants are allowed within the Plan. Notes receivable are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

Subsequent Events

Events occurring after the date of the statement of net assets available for benefits are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through October 10, 2025, which is the date the financial statements were available to be issued.

3. Tax Status

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. The Plan has been amended since adopting the pre-approved plan document. The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

4. Information Certified by the Trustee

The Plan's investments, related investment income and investment transactions, including net appreciation in fair value of investments, and notes receivable from participants, interest associated with the notes receivable and notes receivable transactions were certified by John Hancock Life Insurance Company, the trustee, as of and for the year ended December 31, 2024 and as of December 31, 2023. The Plan Administrator has determined that John Hancock Life Insurance Company meets the requirements of a qualified institution as defined by the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, in accordance with the request of the Plan Administrator and as permitted by CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, this information was not subjected to generally accepted auditing procedures by the Plan's independent public accountants.

5. Fair Value Measurements

Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurements* (ASC 820), has established a framework for measuring fair value that provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted market prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled separate accounts: Valued based upon net asset value as determined by the trustees using the fair value of the underlying investments held by the fund, less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

In accordance with Accounting Standards Update (ASU) 2015-07, pooled separate account investments measured at fair value using the net asset value per share practical expedient have not been classified in the fair value hierarchy at December 31, 2024 and 2023.

There are no restrictions on the sale or transfer of investments in pooled separate accounts and there are no unfunded commitments at December 31, 2024 and 2023.

The significant investment strategies of the pooled separate accounts measured at net asset value using the net asset value per share practical expedient are as follows:

Asset Allocation – Target Date: These funds are model portfolios that seek to provide a high total return through the balance of growth, income and capital conservatism through a mix of equity and fixed income exposures through the target retirement date, with a greater focus on income beyond the target date.

Stable Value: These funds seek to preserve capital and provide stability of principal while earning current income that exceeds money market rates over the long term.

Income: These funds seek current income with capital appreciation and growth of income, primarily by investing in fixed income securities through broad sectors of the bond market and gaining exposure to various types of credit and interest rate risk.

International Growth: These funds seek capital appreciation foremost by investing in international equity securities. The secondary focus on these funds is current income.

Growth: These funds seek capital appreciation foremost by investing in equity securities. The secondary focus on these funds is current income.

6. **Party-in-Interest Transactions**

The Plan's assets are invested in pooled separate accounts managed by the trustee. Therefore, transactions involving the Plan's investments qualify as party-in-interest. Notes receivable from participants also qualify as exempt party-in-interest transactions. Administrative expenses charged to the Plan during 2024 totaled \$50,081 and included amounts paid for investment management and recordkeeping fees.

7. **Reconciliation to Form 5500**

Notes receivable from participants are reflected as a receivable on the financial statements which is different from the Form 5500 presentation. On the Form 5500, notes receivable are classified as investments under the caption "participant loans."
