Opinion

NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023

(1) DESCRIPTION OF PLAN:

The following description of the Bretford Manufacturing, Inc. Employee Benefit Trust (Plan) provides only general information about the Plan's provisions. Participants should refer to the plan agreement for a complete description of the Plan's provisions, copies of which may be obtained from the Plan sponsor.

General -

The Plan provides health and other benefits to eligible employees of Bretford Manufacturing, Inc. (the Sponsor) and covered dependents.

Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Benefits -

The Plan provides health benefits (medical, vision, dental, and prescription drugs), basic life insurance, accidental death and dismemberment and temporary disability benefits to all participants and covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Stop Loss Coverage -

The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Self-Insured Benefits -

All other Plan benefits are self-insured. The claims for self-insured benefits (other than short-term disability) are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA trust or the general assets of the Sponsor. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

(1) DESCRIPTION OF PLAN (CONTINUED):

Contributions -

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Sponsor pays the full cost of basic life insurance, basic accidental death and dismemberment insurance and stop loss insurance. The Sponsor makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Sponsor on a pay as you go basis.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting and Use of Estimates -

The accompanying financial statements have been prepared using the accrual basis of accounting. The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits -

Premiums paid by either the Sponsor or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processors. Amounts due to claims processors or the Sponsor that have yet to be reimbursed by the Plan are recorded as accounts payable in the accompanying statements of net assets available for benefits. Short-term disability payments are processed through the Sponsor's payroll system and paid from the general assets of the Sponsor. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

Stop Loss -

Premiums for stop loss insurance are included in premium payments in the accompanying statement of changes in net assets available for benefits. For the years ended December 31, 2024 and 2023, stop loss refunds totaling \$101,888 and \$228,765 have been netted with claims paid in the accompanying statement of changes in net assets.

Refunds -

Pharmacy rebates are reported when received. For the years ended December 31, 2024 and 2023, pharmacy rebates totaling \$166,345 and \$132,023 have been netted with claims paid in the accompanying statement of changes in net assets.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Investment Valuation and Income Recognition -

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies and procedures and reports to the Plan management. See note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned.

Subsequent Events -

Management has evaluated subsequent events for the Plan through October 14, 2025, the date the financial statements were available to be issued.

(3) CLAIMS INCURRED BUT NOT REPORTED:

Plan obligations at December 31, 2024 and 2023, for benefit claims incurred by participants but not reported at that date are estimated by the Plan based mainly on health benefits lag reports provided by the administrator. Such estimated amounts are reported in the accompanying statements of the Plan's benefit obligations at estimated present value. These amounts are paid by the Plan only if claims are submitted and approved for payment.

(4) FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
- quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

(4) FAIR VALUE MEASUREMENTS (CONTINUED):

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The money market fund is valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily Net Asset Value (“NAV”) and to transact at that price.

(5) ADMINISTRATIVE EXPENSES:

The Plan pays administrative expenses that consist primarily of administrative fees paid to third-party claims administrators. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. All other administrative expenses, such as professional fees, are paid by the Sponsor on behalf of the Plan.

(6) TAX STATUS:

The VEBA trust established under the Plan to hold the Plan’s assets is intended to qualify pursuant to Section 501(c)9 of the Internal Revenue Code and, accordingly, the Trust’s net investment income is exempt from income taxes. The trust has obtained a favorable tax determination letter from the Internal Revenue Service, and the Plan sponsor believes that the trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the appropriate taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) TERMINATION OF THE PLAN:

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

(8) RISKS AND UNCERTAINTIES:

The Plan invests in a money market fund with a bank. This money market fund is not covered by the bank's FDIC insurance.

The present value of benefit obligations is reported based on certain assumptions noted on health benefit lag reports. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
