### **1. Description of Plan**

The following description of the Tri-Eagle Sales 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan originally established and made effective August 1, 1996, and restated effective July 8, 2024, for the benefit of the employees of Busch-Transou, L.C. d/b/a Tri Eagle Sales (the Company). The Plan and the Trust of which it is a part of are intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the Plan's sponsor and administrator. The Plan's directed Trustee was Ascensus Trust Company, and Ascensus, Inc. (Ascensus) served as the Plan's third party administrator until July 5, 2024, when the plan transferred assets and services to John Hancock Trust Company (John Hancock). The Company's Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

Effective July 8, 2024, the Plan was restated to adopt a John Hancock nonstandardized pre-approved profit sharing plan. There were no significant changes in plan provisions.

#### **Eligibility**

The Plan covers all employees of the Company with the exception of leased employees, employees classified as an independent contractor, and other individuals not considered to be an actual employee. Employees may become a participant on the first day of the next month following the attainment of their nineteenth birthday and sixty days of service.

## Notes to Financial Statements

### 1. Description of Plan (continued)

#### Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation. Each year, participants may contribute up to 100% of pretax and post-tax annual compensation, as defined in the Plan, limited by the provisions of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make “catch-up” contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes 25% of the first 6% of compensation that a participant contributes to the Plan. Additional profit sharing contributions may be made at the discretion of the Company's Board of Directors. The matching and profit sharing contributions are invested directly into the investment options selected by the participant. Contributions are subject to certain Internal Revenue Service (IRS) limitations. The Company did not make profit sharing contributions for the year ended December 31, 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as allocations of the Company's profit sharing contribution, when applicable, and Plan earnings.

Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching and profit sharing contributions and earnings thereon is based on years of continuous service. Participants become 20% vested after two years of service, 20% more each year thereafter, until 100% vested when the participant attains six continuous years of service.

## Notes to Financial Statements

### 1. Description of Plan (continued)

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and only one loan per participant may be outstanding at a time. Loan terms range from one to five years and are repaid in equal payroll period installments. Loans outstanding at December 31, 2024 have interest rates of 3.25% - 8.5%. The interest rates for loans are computed using the prime interest rate.

#### Payment of Benefits

On termination of service due to retirement, death, disability, or termination of employment, a participant may elect to receive a lump-sum cash payment. Partial withdrawals are also allowed by the Plan. A single lump-sum cash distribution will be made to terminated participants, or the designated beneficiary, whose vested balance is equal to or less than \$7,000 without the participant's consent.

#### Forfeitures

At December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$21,100 and \$10,537, respectively. These accounts will be used to pay qualified plan expenses or reduce employer contributions. During 2024, \$237 of forfeitures were used to pay employer match contributions and \$4,535 of forfeitures were used to pay plan expenses.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Payment of Benefits

Benefits are recorded when paid.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### 2. Summary of Significant Accounting Policies (continued)

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors and Trustee. See Note 3 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### **Operating Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### **Subsequent Events**

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. During the period from December 31, 2024 to October 13, 2025, the Plan did not have any material recognizable subsequent events.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Cash and cash equivalents:* Valued at the closing account balance held by the Plan at year end.

### 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

### 5. Tax Status

The Plan has not requested a determination letter from the Internal Revenue Service (IRS) regarding the Plan's exemption from federal income tax under Section 401(a) of the IRC. However, the Plan adopted a nonstandardized pre-approved plan sponsored by Ascensus effective until July 8, 2024 when the Plan adopted a nonstandardized pre-approved plan sponsored by John Hancock. The pre-approved plans have received opinion letters from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letters have been relied upon by the Plan. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC, and as such, no provision for income tax has been included in the Plan's financial statements.

### **6. Accounting for Uncertainty in Income**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

### **7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **8. Information Certified by Ascensus and John Hancock**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company (the Trustee and Recordkeeper until July 5, 2024) and John Hancock Trust Company (the Trustee and Recordkeeper starting July 5, 2024), qualified institutions.

### **9. Related Party Transactions and Party In Interest Transactions**

Certain Plan investments are managed by Ascensus and John Hancock. Ascensus and John Hancock are the Trustees of the Plan and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$42,832 for year ended December 31, 2024.
