## INDEPENDENT AUDITORS' REPORT

To the Board of Administration  
Joe Jurgielewicz & Son, Ltd. Group Medical Plan  
Hamburg, Pennsylvania

### *Opinion*

We have audited the financial statements of Joe Jurgielewicz & Son, Ltd. Group Medical Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the period ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and plan benefit obligations for the period then ended, in accordance with accounting principles generally accepted in the United States of America.

### *Basis for Opinion*

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### *Responsibilities of Management for the Financial Statements*

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Joe Jurgielewicz & Son, Ltd. Group Medical Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS

#### Note 1. Description of Plan

The following description of Joe Jurgielewicz & Son, Ltd, Group Medical Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General:

The Plan is a defined benefit health and welfare plan that was established October 1, 2022. The Plan covers all regular full-time employees working at least thirty hours per week of Joe Jurgielewicz & Son, Ltd., Mountain Breeze Farm, Ltd., and White Ducks, Ltd. (the "Company") after completion of thirty days of employment, and former employees electing coverage under the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA) provisions. Medical benefits are also provided to dependents of these individuals who elect coverage on their behalf. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### Contributions

The Plan records contributions on the accrual basis. The Company makes monthly contributions at rates that are estimated to cover all of the claims and administrative expenses of the Plan. The rate paid has a fixed component for administrative fees and a variable rate based upon the employee election of individual or eligible dependent coverage. Should the estimated rates be insufficient to cover Plan expenses, the Company is responsible for any shortage.

##### Benefits:

The Plan provides health benefits (hospital, surgical, and major medical), and prescription drugs to substantially all employees of the Company who meet the age and service requirements of the Plan and to their covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through COBRA, as defined in the plan document.

All medical and prescription benefits are self-insured.

The Plan includes a health reimbursement account ("HRA") plan. Employees are required to pay the first \$1,000 for individual coverage or \$2,000 for family coverage of the deductible. The Plan will reimburse the participant's deductible in excess of the base amount up to \$4,000 for an individual or \$8,000 for a family during the Plan year. No amount is carried over to the next Plan year.

Benefits:

The self-insured health and prescription claims and HRA payments are processed by Capital Blue Cross, the Plan's third-party claims processor under administrative services only ("ASO") arrangements. The claims processor pays claims directly to or on behalf of participants and then are reimbursed by the Plan's trust account. Despite the utilization of a claims processor, ultimate responsibility for payments to providers and participants is retained by the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of accounting:

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred, but not reported, claims payable and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of benefits:

Claim payments are recorded when paid to the third-party claims processor.

Stop loss insurance:

The Plan has a stop loss insurance arrangement, whereby the stop loss insurance will cover the Plan's obligations for any plan participant's claims in excess of a fixed dollar amount (self-insured retention). The self-insured retention for the Company was \$50,000 per covered person for the years ended December 31, 2024 and 2023. In addition, the Plan has an aggregate stop loss insurance arrangement, whereby the aggregate stop loss insurance will cover the Plan's obligations if all claims exceed a fixed dollar amount. Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. For the year ended December 31, 2024 and three months ended December 31, 2023, stop loss refunds of \$597,871 and \$90,627, respectively, have been netted with claims paid in the accompanying statement of changes in net assets available for benefits.

Note 2. Summary of Significant Accounting Policies (Continued)

Plan benefit obligations:

Plan obligations at December 31, 2024 and 2023 for health claims incurred by active participants, but not reported at that date, are estimated by the Plan's actuary. Such estimated amounts are reported in the accompanying statement of benefit obligations. Due to the short-term nature of the reserve liability, time value of money was not used to discount future payments. As of December 31, 2024 and 2023, benefit obligations for claims payable and claims that had been incurred, but not reported, totaled \$294,284 and \$225,948, respectively. The amounts were paid in the plan year immediately following the period end date noted above. It is the Plan's policy that deductions for claims are recorded when paid.

Note 3. Plan Administration

The Plan has entered into a service agreement with VERIS Benefits Consortium to provide consulting and administrative services. Capital Blue Cross is responsible for determining eligibility of the claiming person, evaluating the validity of the claim, calculating the amount of the claim payable, if any, and issuing a check payable to the provider of services or to the employee in accordance with the terms of the Plan. Both VERIS Benefits Consortium and Capital Blue Cross charge a fee based on the number of employees participating in the Plan. Substantially all administrative expenses of the Plan, including, but not limited to, costs related to claims processing are paid from plan assets. Certain other administrative expenses of the Plan, including certain recordkeeping services and professional fees, are also paid from plan assets. Certain other administrative expenses are paid by the Plan Sponsor.

Note 4. Fair Value Measurements:

FASB ASC 820 provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

At measurement date, the Plan estimates fair value of the financial instruments using various valuation techniques. The extent available, quoted market prices in active markets or observable market inputs in estimating the fair value of the investments are utilized. When quoted market prices or observable market inputs are not available, valuation techniques that rely on unobservable inputs to estimate fair value of investments are used.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Interest bearing Cash and Money Market Accounts: Value relates to the net asset value as reported by the bank holding the cash.

Note 5. Tax Status

The accounting standard on accounting for uncertainty in income taxes addresses the determination of whether tax benefits claimed or expected to be claimed on a tax return should be recorded in the financial statements.

The Plan's policy would be to recognize interest and penalties, if any, on tax positions related to its unrecognized tax benefits in income tax expense in the financial statements. No interest and penalties were assessed or recorded during the year ended December 31, 2024 and 2023. A trust was established under the Plan to hold the Plan's assets. The Plan has not obtained a determination letter from the Internal Revenue Service. Management is of the opinion that the Plan and related trust are not exempt from federal taxes on interest earned on cash accounts. Since this is the third year of the organization, all years remain open for tax examination.

Note 6. Related Party Transactions

The Company paid certain indirect expenses on behalf on the Plan, the Benecon Group, LLC provides program management services and Capital Blue Cross provides claims administration services. These transactions qualify as party-in-interest transactions.

Employees of the Company provide oversight to the Plan operations and do not accumulate the cost of the time spent on these services. These expenses are not included in the statement of changes in net assets available for benefits.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to modify the benefits provided to active employees, discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for, or an account of, the participants. No assets of the Plan may revert to the Company to be used for purposes other than for the exclusive benefit of the Plan's participants.

Note 8. Risks and Uncertainties

The Plan maintained cash in a bank deposit account, which may, at times, exceed federally insured limits. The Plan has not experienced any losses in such account. The Plan believes it is not exposed to any significant credit risk on cash.

The Plan's estimated benefit obligations are reported based on certain assumptions, including level of past claims, which are subject to change. Due to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.
