### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

**1. Description of the Plan**

The following description of Childers Oil 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General**

The Plan is a controlled group plan covering substantially all full-time employees of Childers Oil Company, Hometown Convenience, LLC, Childers Contracting, Inc., London Auto Truck Center, Inc., Childers Transport, Inc., Childers Tire & Supply Co., Inc., and Kwik Shop Concepts, Inc (collectively referred to as the “Plan Sponsor”), who are at least 21 years of age. Participation in the Plan is voluntary, and eligible employees can elect to participate as soon as becoming eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Contributions**

Each year, participants may contribute, on a pre-tax or Roth basis, up to 100% of their eligible compensation, as defined by the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time.

The Plan Sponsor makes safe harbor matching contributions equal to 100% of the first 4% of compensation that a participant contributes to the Plan.

The Plan Sponsor may also make discretionary matching contributions and discretionary profit-sharing contributions. No such contributions were made during 2024.

Receivables, if any, from the Plan Sponsor for contributions are unsecured.

**Participant Accounts**

Individual accounts are maintained for each participant to reflect the participant’s contributions, Plan Sponsor contributions, and investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Notes to Financial Statements (continued)

#### 1. Description of the Plan (continued)

##### Excess Contributions Payable

Amounts payable to participants totaling \$1,647 as of December 31, 2023 for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to cash contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

##### Vesting

Participants are immediately vested in their contributions, their rollover contributions, and the Plan Sponsor safe harbor matching contributions, plus actual earnings thereon. For any Plan Sponsor discretionary matching contributions or discretionary profit-sharing contributions, vesting is based on years of credited service as follows:

##### Forfeitures

Forfeitures are created when participants terminate employment before becoming fully vested in the Plan Sponsor discretionary matching contributions or discretionary profit-sharing contributions. Forfeitures of terminated participants' non-vested accounts may be used to reduce future Plan Sponsor contributions to the Plan or to pay expenses of the Plan. If a terminated participant is rehired by the Plan Sponsor, the participant may be entitled to a restoration of certain amounts forfeited, based on provisions in the Plan Document. Forfeitures totaled \$4,723 during 2024. As of December 31, 2024 and 2023, the forfeiture account totaled \$8,211 and \$3,288, respectively.

### Notes to Financial Statements (continued)

#### **1. Description of the Plan (continued)**

##### **Notes Receivables from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. One loan can be outstanding at a time per participant, and loans bear interest at prime plus 1%. The loans are generally repayable in level periodic payments over various terms of up to five years, except for those utilized for the acquisition of a principal residence, which may be repaid over an increased reasonable period of time as determined at the time the loan was made. Principal and interest are paid ratably through payroll deductions.

##### **Payment of Benefits**

On termination of service due to death or disability, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants electing to receive benefits after the normal retirement age may choose either a lump-sum amount or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or roll over their account into another individual retirement account. The Plan permits in-service and hardship withdrawals under certain conditions.

##### **Termination of the Plan**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

##### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

### Notes to Financial Statements (continued)

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Investment Valuation and Income Recognition**

The Plan's investments are invested in mutual funds offered by Capital Bank and Trust Company (the "Custodian"), which are reported at fair value. The Plan Sponsor's management determines the Plan's valuation policies utilizing information provided by the Custodian.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Generally, the Plan's investments are collateralized by the proportionate share of the respective fund's underlying net assets. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Upon default of notes receivable from participants, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the IRC, has occurred, the note receivable will be foreclosed on and be offset against the participant's account balance. If a participant's note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net realized and unrealized appreciation or depreciation in the fair value of investments.

### Notes to Financial Statements (continued)

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Subsequent Events**

Plan management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. During January 2025, the Plan's assets were transferred to Reliance Trust Company, which will serve as the Plan's new custodian.

#### **3. Tax Status**

The Plan Sponsor adopted a prototype plan sponsored by Benefits Administrators, LLC that received a favorable opinion letter from the IRS dated June 30, 2020, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC.

The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes that the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

#### **4. Certified Information (Unaudited)**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net realized and unrealized appreciation in the fair value of investments, interest income on notes receivable from participants, and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian.

#### **5. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

### Notes to Financial Statements (continued)

#### 5. Fair Value Measurements (continued)

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows.

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes to the methodologies used as of December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management of the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**1. Description of the Plan**

The following description of Childers Oil 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

**General**

The Plan is a controlled group plan covering substantially all full-time employees of Childers Oil Company, Hometown Convenience, LLC, Childers Contracting, Inc., London Auto Truck Center, Inc., Childers Transport, Inc., Childers Tire & Supply Co., Inc., and Kwik Shop Concepts, Inc (collectively referred to as the “Plan Sponsor”), who are at least 21 years of age. Participation in the Plan is voluntary, and eligible employees can elect to participate as soon as becoming eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan Contributions**

Each year, participants may contribute, on a pre-tax or Roth basis, up to 100% of their eligible compensation, as defined by the Plan Document, subject to certain Internal Revenue Service (IRS) limitations. In addition, participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Participants can change the investment options previously elected at any time.

The Plan Sponsor makes safe harbor matching contributions equal to 100% of the first 4% of compensation that a participant contributes to the Plan.

The Plan Sponsor may also make discretionary matching contributions and discretionary profit-sharing contributions. No such contributions were made during 2024.

Receivables, if any, from the Plan Sponsor for contributions are unsecured.

**Participant Accounts**

Individual accounts are maintained for each participant to reflect the participant’s contributions, Plan Sponsor contributions, and investment earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Notes to Financial Statements (continued)

#### 1. Description of the Plan (continued)

##### Excess Contributions Payable

Amounts payable to participants totaling \$1,647 as of December 31, 2023 for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to cash contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

##### Vesting

Participants are immediately vested in their contributions, their rollover contributions, and the Plan Sponsor safe harbor matching contributions, plus actual earnings thereon. For any Plan Sponsor discretionary matching contributions or discretionary profit-sharing contributions, vesting is based on years of credited service as follows:

##### Forfeitures

Forfeitures are created when participants terminate employment before becoming fully vested in the Plan Sponsor discretionary matching contributions or discretionary profit-sharing contributions. Forfeitures of terminated participants' non-vested accounts may be used to reduce future Plan Sponsor contributions to the Plan or to pay expenses of the Plan. If a terminated participant is rehired by the Plan Sponsor, the participant may be entitled to a restoration of certain amounts forfeited, based on provisions in the Plan Document. Forfeitures totaled \$4,723 during 2024. As of December 31, 2024 and 2023, the forfeiture account totaled \$8,211 and \$3,288, respectively.

#### **1. Description of the Plan (continued)**

##### **Notes Receivables from Participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. One loan can be outstanding at a time per participant, and loans bear interest at prime plus 1%. The loans are generally repayable in level periodic payments over various terms of up to five years, except for those utilized for the acquisition of a principal residence, which may be repaid over an increased reasonable period of time as determined at the time the loan was made. Principal and interest are paid ratably through payroll deductions.

##### **Payment of Benefits**

On termination of service due to death or disability, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants electing to receive benefits after the normal retirement age may choose either a lump-sum amount or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or roll over their account into another individual retirement account. The Plan permits in-service and hardship withdrawals under certain conditions.

##### **Termination of the Plan**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under plan provisions to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts.

#### **2. Summary of Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

##### **Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts in the Plan's financial statements. Accordingly, actual results may differ from those estimates.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Investment Valuation and Income Recognition**

The Plan's investments are invested in mutual funds offered by Capital Bank and Trust Company (the "Custodian"), which are reported at fair value. The Plan Sponsor's management determines the Plan's valuation policies utilizing information provided by the Custodian.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Generally, the Plan's investments are collateralized by the proportionate share of the respective fund's underlying net assets. The maximum loss, if any, that would be incurred by the Plan if the counterparties to the Plan's investments failed to perform is the recorded amount of such investments.

##### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Upon default of notes receivable from participants, the entire outstanding principal and interest shall be immediately due and payable. If a distributable event, as defined by the IRC, has occurred, the note receivable will be foreclosed on and be offset against the participant's account balance. If a participant's note receivable is in default, the participant shall be treated as having a taxable deemed distribution whether or not a distribution event has occurred.

##### **Payment of Benefits**

Benefits are recorded when paid.

##### **Administrative Expenses**

Certain plan administrative expenses are paid by the Plan Sponsor and are excluded from these financial statements. Fees related to administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net realized and unrealized appreciation or depreciation in the fair value of investments.

#### **2. Summary of Significant Accounting Policies (continued)**

##### **Subsequent Events**

Plan management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued. During January 2025, the Plan's assets were transferred to Reliance Trust Company, which will serve as the Plan's new custodian.

##### **3. Tax Status**

The Plan Sponsor adopted a prototype plan sponsored by Benefits Administrators, LLC that received a favorable opinion letter from the IRS dated June 30, 2020, which states the form of the prototype plan is acceptable for use under applicable sections of the IRC.

The Plan has been amended since the latest opinion letter date; however, the Plan Administrator believes that the Plan is being operated in accordance with applicable requirements of the IRC and, accordingly, remains exempt from income taxes.

##### **4. Certified Information (Unaudited)**

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net realized and unrealized appreciation in the fair value of investments, interest income on notes receivable from participants, and dividend income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodian.

##### **5. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

#### 5. Fair Value Measurements (continued)

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurement (Topic 820)*, are described as follows.

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets the Plan has the ability to access.
- Level 2 Inputs to the methodology include:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes to the methodologies used as of December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although management of the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 6. Party-in-Interest Transactions

The Plan's investments are managed by the Custodian and are in mutual funds of American Funds, which is a related company to the Custodian; therefore, these transactions are considered to be party-in-interest transactions.

#### 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
