Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Montgomery Baptist Outreach Services Corporation 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge and belief.

Opinion

Note 1 - Plan Description

The following description of the Montgomery Baptist Outreach Services Corporation 403(b) Plan (the Plan), provides only general information. The Health Care Authority for Baptist Health, an Affiliate of the UAB Health System (the Company) is the Plan Sponsor. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan was established for the benefit of all eligible employees of the nonprofit subsidiaries of the Company. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - Employees shall become eligible for the Plan on the date of employment. Employees of Outreach Management Services, Inc. are not eligible to participate in the Plan.

Employer contributions - The Company contributes a matching contribution based on a fixed contribution formula up to 6% of compensation each Plan year into the Health Care Authority for Baptist Health Matching Dollar Plan (a separate plan established by the Company). The fixed matching contribution formula is \$0.35 for every \$1 of the participant's salary reduction for employees with less than 10 years of continuous service and \$0.50 for every \$1 of the participant's salary reduction for employees with 10 or more years of continuous service. For the years ended December 31, 2024 and 2023, the matching contribution was \$80,118 and \$74,511, respectively. Refer to the Plan agreement for the Health Care Authority for Baptist Health Matching Dollar Plan for a more complete description of the provisions of that plan.

Participant contributions - Participants are automatically enrolled at an automatic elective deferrals percentage of 3% with an automatic increase of 1% annually beginning on the anniversary of the employee's automatic enrollment date, but not in excess of 6% (maximum automatic elective deferrals percentage). Employees and participants have the right to amend the stated automatic elective deferrals percentage. The automatic escalation feature applies to all automatically enrolled employees and participants who have not elected to amend the stated automatic elective deferrals percentage of 3%. Amounts are subject to certain limitations under the Internal Revenue Code (IRC). The Plan allows for Roth deferrals.

Participants who have attained the age of 50 before the end of the Plan year are eligible for catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant accounts - Each participant's account is credited with the participant's contributions and allocations of plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon.

Notes receivable from participants - Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are available from one to five years (10 years for the purchase of a principal residence) with various maturity dates. The loans are secured by the balances in the participants' accounts. For December 31, 2024 and 2023, the interest rate ranges from 4.25% to 9.50%.

Notes receivable from participants are issued directly from a participant's account. Repayments on the notes are made through payroll deduction. At December 31, 2024 and 2023, there were \$185,256 and \$243,479 in outstanding notes receivable from participants, respectively. At December 31, 2024 and 2023, notes receivable from participants includes \$53,998 and \$59,160, respectively, of receivables from active participants that have defaulted on repayment, but for which a distributable event, as defined in the Plan document, has not occurred.

Policy loans - Policy loans are issued directly from funds owned by Variable Annuity Life Insurance Company and not directly from a participant's account. Adequate security is required and a portion of the participant's account is reserved, or held in collateral, to cover the outstanding loan, accrued interest, and administrative charges in case of default. Repayments on policy loans are made directly by the participant. Policy loans are not shown in the statements of net assets available for benefits or in the statements of changes in net assets available for benefits. At December 31, 2024 and 2023, there were \$28,208 and \$55,554 in policy loans, respectively.

Payment of benefits - Upon discontinuance of service due to termination of employment, normal retirement (age 65), early retirement (age 55 and five years of service), death or disability, a participant or his/her beneficiary may elect to receive the value of the vested interest in his/her account. The normal form of payment of benefits is a lump sum. Optional forms of payments the participant can elect to receive are installments, partial withdrawals or different forms of annuities.

In-service withdrawals are allowed for financial hardships, early retirement (age 55) or age 59½ without requiring the participant to terminate employment.

Forfeited accounts - The Plan does not contain forfeited accounts due to immediate 100% vesting of participant accounts.

Note 2 - Summary of Significant Policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The Plan has guaranteed investment contracts with Transamerica Financial Life Insurance Company (TFLIC) and Variable Annuity Life Insurance Company (VALIC), which the Plan Sponsor has determined meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. See Note 5 for discussion of the investment contracts.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the Custodians and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the loan is reclassified as a benefit payment to the participant when a distributable event, as defined in the Plan document, occurs.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included with Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end as reported on the active market.

TFLIC guaranteed investment option (TFLIC GIO) - The Plan invests in a stable value product that guarantees principal and interest which has been determined to be fully benefit-responsive. The guarantees are provided through a group annuity contract issued by TLIC. The contract has a portfolio interest rate design in which all deposits are credited with the same interest rate, are credited on a daily basis and there is no set maturity date. The contract issuer is contractually obligated to repay the principal and interest at a specified rate. The declared rate shall be set periodically, but shall not be reduced for a period of at least 12 months following the reset date. The declaration rate may be increased at any time, but a reduction requires 45-day notice. In no event would the declared rate of interest be less than the contracts minimum guaranteed interest rate. The minimum guaranteed interest rate is 1.3%. The TFLIC GIO does not have a maturity date or penalties for qualified participant withdrawals.

Certain events within control of the Plan Sponsor could limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) mergers, (2) layoffs, (3) bankruptcy, (4) the creation of a competing fund, (5) employee communications that influence contributions to or withdrawals or loans from the plan option (6) the occurrence of an insolvency event, (7) the disqualification of the plan, and (7) early retirement incentive programs. The Plan Administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

VALIC investment contracts - The Plan invests in investment contracts at VALIC which have been determined to be fully benefit-responsive investment contracts. The VALIC contracts consist of the Portfolio Director Group Fixed and Variable Deferred Annuity Contract. VALIC maintains the contributions in its general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan, with a minimum guaranteed rate of 3%. There are no reserves against the contract value for credit risk of the contract issuers or otherwise. The crediting interest rates are based on formulas agreed upon with the issuers. Such interest rates are reviewed monthly and reset at least as frequently as monthly.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan document (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contracts do not permit the insurance company to terminate the agreements prior to the scheduled maturity dates.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 7 - Tax Status

Effective June 28, 2013, the Internal Revenue Service (IRS) established a plan to approve prototype and volume submitter 403(b) Plan documents in accordance with applicable sections of the Internal Revenue Code (IRC). The volume submitter plan document was approved on March 31, 2017. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9 - Related Party Transactions

Certain Plan investments are managed by TFLIC and VALIC. State Street Bank and Trust Company, TFLIC, and VALIC are the Custodians of the Plan investments. Therefore, these transactions qualify as party-in-interest. Fees paid by the Plan for the investment services are included in net appreciation (depreciation) in fair value of investments. Total Plan recordkeeping fees were \$16,883 and \$16,623 for the years ended December 31, 2024 and 2023, respectively.
