Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Metro Homes, Inc. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Metro Homes, Inc. NOTE A – DESCRIPTION OF PLAN

The following description of the Metro Homes, Inc. Profit Sharing Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Metro Homes, Inc. Profit Sharing Plan (the “Plan”) is a defined contribution plan covering all full-time employees of Metro Homes, Inc. and Metro Day Treatment Center, Inc. (collectively, the “Company”) who have completed three months of service and have attained age twenty-one or older. Eligible employees may enter the Plan on the first day of the Plan Year or the first day of the seventh month of the Plan Year following satisfaction of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Contributions

Participants may contribute up to 100% of their eligible compensation, as defined in the Plan and Summary Plan Description (“SPD”), on a pretax basis, subject to Internal Revenue Code limitations. For the 2024 Plan year, the maximum elective deferral was \$23,000. Participants who were age 50 or older during the year were eligible to make additional catch-up contributions of up to \$7,500.

The Company may make discretionary matching and/or profit-sharing contributions as determined annually by management. Participant accounts are credited with employee contributions, employer contributions, and an allocation of investment earnings or losses, and are charged with an allocation of administrative expenses.

There were no employer profit-sharing contributions made for the year ended December 31, 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer contributions, and investment earnings and charged with applicable expenses. The benefit to which a participant is entitled is the balance of the participant’s vested account at the time of distribution.

NOTE A – DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their salary-deferral and rollover accounts. Employer profit-sharing contributions vest at 20% per year of service and are fully vested after six years of credited service.

Investment Options

Participants direct the investment of their account balances among various investment options offered under the Plan. Investments are held by Standard Insurance Company, the Plan's custodian and recordkeeper.

Notes Receivable from Participants

Participants may borrow from their accounts up to 50% of their vested account balance, not to exceed \$50,000, reduced by their highest outstanding loan balance during the prior twelve months. Loans bear interest at rates determined by the Plan Administrator and are repaid through payroll deductions. Loan repayments, including interest, are credited back to participants' accounts.

Payment of Benefits

Upon termination of employment, retirement, disability, or death, participants are entitled to receive the value of their vested account balances. Participants may also take in-service withdrawals upon attainment of age 59½ or hardship withdrawals as defined under IRS Regulation §1.401(k)-1(d)(3). Distributions are made in a lump sum or, if applicable, in installments as elected by the participant.

Administrative Expenses

Certain administrative expenses of maintaining the Plan are paid directly by the Company as permitted under ERISA Section 408(b)(2). Other expenses, including recordkeeping and trustee fees, are paid from Plan assets and allocated to participants' accounts based on account balances.

Forfeitures

Forfeitures of non-vested accounts are used to offset employer contributions or pay allowable Plan expenses, in accordance with the Plan.

NOTE B – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value as determined by quoted market prices on the last business day of the Plan year. The Stable Asset Fund II is a fully benefit-responsive investment contract and is reported at contract value in accordance with ASC 962-325-45.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Loans shall bear interest at a reasonable rate at the time of application. Loans are to be repaid within 5 years of the date of the loan except if proceeds are to acquire the principle residence of the participant. Delinquent participant loans are reclassified as distributions based on the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid. Amounts allocated to withdrawing participants that have not been paid as of year-end are included in net assets available for benefits.

Expenses

The Company pays certain administrative expenses; others are paid by the Plan as described in Note A. Investment-related expenses are presented as a reduction of investment income.

NOTE C – INVESTMENTS

The investments of the Plan are held by Standard Insurance Company and are reported at fair value. The Stable Asset Fund II, a guaranteed investment contract, is reported at contract value as it is fully benefit-responsive. The fair value of the Plan's remaining investments represents quoted market prices for mutual funds and other investments held as of year-end.

NOTE D – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. It is reasonably possible that changes in the value of investment securities could occur in the near term and that such changes could materially affect participants' account balances.

NOTE E – TAX STATUS

The Plan is part of a prototype plan provided by The Standard Insurance Company. No determination letter is provided to the Company, but the Internal Revenue Service has determined and informed The Standard Insurance Company, by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities for a period of three years after the date of filing; however, there are currently no audits for any tax periods in progress.

The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2022.

NOTE F – PLAN TERMINATION

Although the Company has not expressed any intent to terminate the Plan, it reserves the right to amend or terminate the Plan at any time. In the event of Plan termination, participants become fully vested in their accounts and are entitled to the full value of their vested benefits.

NOTE H – RELATED PARTY TRANSACTIONS

Certain Plan investments are managed by Standard Insurance Company, the Plan’s trustee, and therefore qualify as party-in-interest transactions under ERISA. Fees paid to the trustee and other service providers for administrative services are included in administrative expenses or are deducted from investment returns.

Fees paid by the Plan for the investment management services amounted to \$13,209 in 2024.

NOTE I – FAIR VALUE MEASUREMENTS

Investment Policy

The Plan provides participants with various investment options through Standard Insurance Company (“The Standard”). Participants direct the investment of their account balances among the available funds in accordance with the provisions of the Plan. Investment options generally include pooled separate accounts, mutual funds, and a stable value fund.

Fully Benefit-Responsive Investment Contract

The Plan holds a group annuity contract with The Standard known as the Stable Asset Fund II. This investment contract is a fully benefit-responsive investment contract, meaning that participant transactions (purchases and withdrawals) are executed at contract value rather than fair value. Under the terms of the contract, The Standard maintains the contributions made to the fund, plus interest credit, less withdrawals and administrative expenses. Participants may ordinarily direct withdrawals or transfers to other investment options at contract value. Contract value represents the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Contract Value and Crediting Rate

On December 31, 2024, the contract value of the Stable Asset Fund II was \$154,271 (2023 – \$164,253). The average annual crediting rate for the year ended December 31, 2024, was 0.88 percent (2023 – 0.77 percent). Crediting rates are established monthly by The Standard based on anticipated portfolio yields, market interest rates, and other factors, and may be adjusted periodically. Crediting rates are designed to maintain a stable value of participants’ account balances.

Certifications and ERISA Section 103(a)(3)(C) Audit

Investment information related to the Stable Asset Fund II has been certified by Standard Insurance Company as complete and accurate pursuant to 29 CFR 2520.103-5(c). Accordingly, this investment information was not subject to audit procedures in accordance with the Plan’s ERISA Section 103(a)(3)(C) audit election. The auditor’s opinion on the financial statements is based, in part, on this certification.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The three levels of the fair value hierarchy are described as follows:

- Level 1 Fair values are based on quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access at the measurement date (e.g., prices derived from NYSE, NASDAQ or Chicago Board of Trade).
- Level 2 Fair values are based on inputs other than quoted price included within Level 1 that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted price for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE I – FAIR VALUE MEASUREMENTS (CONTINUED)

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Level 2 Fair Value Measurements

Pooled separate accounts are primarily valued at net asset value (NAV) per share based on quoted market prices of the underlying investments.

Level 3 Fair Value Measurements

The stable fund value is reported at contract value without adjustments and additional disclosures. It is the position of the trustee that FASB Staff Position 94-4 does not apply to the stable fund in the Plan’s portfolio.

NOTE J – DELINQUENT PARTICIPANT CONTRIBUTIONS

During the plan year ended December 31, 2024, certain employee elective deferrals were not remitted to the 401(k) Plan within the time frame required by the Department of Labor’s rules and regulations. The contributions were deposited late, approximately seven months after the date of withholding from employee payroll.

Upon discovery of the late deposits, the Plan Sponsor promptly corrected the deficiency under the Department of Labor’s Voluntary Fiduciary Correction Program, depositing the delinquent contributions along with applicable lost earnings calculated in accordance with Department of Labor guidance. The lost earnings compensate participants for investment gains that may have been foregone during the period the contributions were held outside the Plan.

The Plan Administrator has implemented additional controls and procedures to prevent recurrence of late deposits going forward.

The Plan’s auditor has reviewed these corrections and the associated disclosures in the Plan’s Form 5500 filing. The financial statements for the year acknowledge this operational failure and the corrective actions taken, in compliance with applicable regulations.

NOTE K – INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

At December 31, 2024 and 2023, the Plan’s investments were held by The Standard Insurance Company, (“the Trustee”).

The Plan Sponsor subsequently filed a Voluntary Fiduciary Correction Program (VFCP) application with the EBSA Washington, DC Field Office, remitted the delinquent contributions of \$11,708.24 on June 12, 2024, and paid lost earnings of \$628.34 on September 19, 2025, as calculated using the DOL’s VFCP online calculator.

The Plan Sponsor also implemented control enhancements—moving deposit responsibilities from payroll to the staff accountant, with controller review and sign-off—to prevent recurrence of late deposits.
