INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Argus Consulting, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Argus Consulting, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit needs not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by the institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 — DESCRIPTION OF PLAN

The following description of the Argus Consulting, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Argus Consulting, Inc. and participating employers (together referred to as the "Company") who have attained age 18. Employees may enter the Plan on the first pay date after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Through March 1, 2024, BOK Financial provided recordkeeping services to the Plan and Charles Schwab Trust Bank was the custodian and trustee for the Plan. Effective March 1, 2024, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust) is the custodian trustee. Principal Life Insurance Company (Principal Life) provides recordkeeping services and is the issuer of the guaranteed investment contract. The Company is the plan administrator and has overall responsibility for the operation and administration of the Plan.

Effective March 1, 2024, the plan document was restated in its entirety due to the change in service providers described above.

Effective July 1, 2024, the plan document was amended to add two participating employers, SAIM LLC and ACM, LLC.

Contributions

Participants may contribute up to 100% of annual eligible compensation, as defined in the Plan, and designate those contributions as either pre-tax or Roth. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Participants are permitted to transfer the vested portion of their accounts to an In-Plan Roth transfer account subject to the Plan's provisions.

The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled employees have their pre-tax deferral rate set at 6% of eligible compensation. Also, the Plan includes an automatic increase provision whereby participants who were automatically enrolled are automatically increased by 1% each January 1, with a ceiling of 10%, unless the participant elects otherwise.

The Plan provides a safe harbor contribution equal to 3% of a participant's eligible compensation. The Company made safe harbor contributions of \$399,359 for the year ended December 31, 2024.

Contributions (Continued)

The Plan provides a discretionary matching contribution which is determined as a percentage of participant elected deferrals. In addition, the Plan provides a discretionary profit sharing contribution in an amount determined by the Company. Profit sharing contributions are allocated to each participant based upon the ratio of the participant's compensation to the total compensation of all eligible participants. Participants must be employed by the Company on the last day of the Plan year and must have completed a minimum of 1,000 hours of service during the Plan year in order to receive a profit sharing contribution. There were no matching or profit sharing contributions for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants elect investment accounts in which their contributions, as well as Company contributions, are invested. The investment account options comprise various degrees of risk and return.

Investment options include a self-directed brokerage account option held at Charles Schwab which provides participants the opportunity to invest all or a portion of their account balance into investment options that are not otherwise available under the Plan. The investment options may include U.S government securities, stocks, bonds, mutual funds, limited partnerships and private equity investments. The investment returns for these accounts are separately disclosed on the statement of changes in net assets available for benefits.

Participant Accounts

Each participant's account is credited with the participant's contribution and Company safe harbor contributions, as well as any matching contributions and allocations of the Company's profit sharing contribution, and investment earnings based on their selected investments. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of the participant's vested account balance, whichever is less. The loans are secured by the balance in the participant's account. The loan interest rate is set at the prime rate that was effective at the time the loan was issued, as defined. A participant may be granted two loans during a rolling 12-month period but have only one loan outstanding at a time. Principal and interest is paid ratably through monthly payroll deductions.

Vesting

Participants are vested immediately in their contributions and Company safe harbor contributions plus earnings thereon. Vesting in the Company's matching and profit sharing contribution portions of their accounts is based on years of service as follows. After two years of service, a participant becomes 20% vested; the vesting increases by 20% each year. A participant is 100% vested after six years of credited service, or upon reaching plan normal retirement age of 65, death, or disability.

Payment of Benefits

On termination of service, death, disability or retirement, participants may elect to receive an amount equal to the value of the vested interest in their accounts in a lump sum amount, installments, or partial payments depending on the size of the participant's account balance at the time of termination. Distributions of shares of stock from self-directed brokerage accounts are also available. Participants with a vested account balance of less than \$7,000 must take a lump-sum distribution. The account of a participant with a vested account balance between \$1,000 and \$7,000 who does not request a distribution will be rolled to an individual retirement account in the participant's name.

The Company may authorize certain withdrawals from a participant's account in the event of proven financial hardship. Hardship withdrawals are allowed from all vested accounts and are subject to specific statutory and regulatory requirements.

In-service distributions are permitted from all vested accounts when a participant has attained age 59½.

Distributions from rollover accounts are permitted at any time.

Forfeitures

Forfeited nonvested accounts may be used to reduce Company contributions or pay plan expenses. For the year ended December 31, 2024, no forfeitures were used to reduce Company matching contributions and to pay plan expenses, respectively. Unallocated forfeitures were \$11,563 and \$0 at December 31, 2024 and 2023, respectively.

NOTE 2 — SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract which is valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when they are incurred.

Contributions and Contributions Receivable

Contributions from participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Plan expenses primarily consist of plan administration fees. Fees related to the administration of notes receivable from participants and benefit payments to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Subsequent Events

Subsequent events were evaluated through October 14, 2024, which is the date the financial statements were available to be issued.

NOTE 3 — INFORMATION CERTIFIED BY THE TRUSTEES

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, self-directed brokerage account investment return, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank through March 1, 2024 and by Principal Trust from March 1, 2024 to December 31, 2024.

NOTE 4 — FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price reported by the fund, which is the quoted net asset value (NAV) of shares.

Common stocks, exchange traded funds, and U.S. government securities: Valued at the closing price reported on the active market on which the individual securities are traded.

Pooled separate accounts: Valued at the NAV of units of the fund, which is based on the readily determined fair value of the underlying investments less its liabilities.

Common/collective trusts: Valued at the NAV of units of the fund, which is based on the readily determined fair value of the underlying investments less its liabilities. The stable value collective investment trust invests in funds in which the underlying assets consist primarily of fully benefit-responsive investment contracts. The fund is valued at NAV, the practical expedient to estimate fair value. Participant transactions may occur daily.

NOTE 5 — INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a traditional fully benefit-responsive guaranteed investment contract issued by Principal Life. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 was \$6,155. The crediting interest rate is based on a formula agreed upon with the issuer ranging from .15% to 3%, depending on market conditions. Such interest rates are reviewed on a semiannual basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Principal Life. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

Principal Life may terminate the guaranteed investment contract for reasonable cause with 30 days advance written notice to the Plan. Termination of the plan sponsor's interest in the guaranteed investment contract is subject to either 12 months' advance notice (subject to additional contractual limitations) or a 5% surrender charge calculated using the 12-month average value of the contract, whichever the plan sponsor chooses. Upon termination by either party, the payout value may be subject to adjustment, either in a lump-sum payment or in installment payments.

NOTE 6 — PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in Company contributions.

NOTE 7 — PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by Principal Trust, Principal Life, and Charles Schwab Trust Bank. Creative Planning is the investment advisor for the Plan. Total fees paid from the Plan to these entities for plan administration for the year ended December 31, 2024 were \$38,228. These transactions qualify as party-in-interest transactions.

NOTE 8 — TAX STATUS

As this Plan is a pre-approved defined contribution plan, the IRS issued an opinion letter dated June 30, 2020, stating that while they do not issue a determination as to whether a specific employer's plan is qualified, any employer who adopts this plan document will be considered to have a plan qualified under code Section 401(a) of the Internal Revenue Code (IRC) provided all the terms are not more favorable for officers, owners, or highly compensated employees than for other employees. Management believes that the Plan is operating in compliance with all the terms provided in the nonstandardized plan document. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

The Plan is subject to examination by the IRS for the statutory period.

NOTE 9 — RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 — DELINQUENT CONTRIBUTIONS

During the years ended December 31, 2024 and 2022, the Company failed to remit to the Plan's custodian certain employee contributions and loan repayments totaling \$319,895 and \$28,036, respectively, within the period prescribed by the Department of Labor's regulations. The Company intends to correct these prohibited transactions by restoring the affected participants' accounts for potential lost income due to the delayed remittances.

NOTE 11 — SUBSEQUENT EVENT

Effective January 1, 2025, the name of the Plan Sponsor was changed to Argus Companies, Inc. In addition, the plan document was amended to change the name of the Plan to Argus Companies, Inc. 401(k) Plan. At this time, Argus Consulting, Inc. was added as a participating employer. There were no changes to the provisions of the Plan.
