**Opinion**

We have audited the accompanying financial statements of Libby Perszyk Kathman Holdings, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets in liquidation available for benefits as of December 31, 2024, the statement of net assets available for benefits as of December 31, 2023, and the related statement of changes in net assets in liquidation available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets in liquidation available for benefits of Libby Perszyk Kathman Holdings, Inc. Employee Stock Ownership Plan as of December 31, 2024, the net assets available for benefits as of December 31, 2023, and the changes in its net assets in liquidation available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

**Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Libby Perszyk Kathman Holdings, Inc. Employee Stock Ownership Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

**Emphasis of Matter – Plan Termination and Basis of Accounting**

As discussed in Note 1 to the financial statements, on December 31, 2024, the Board of Directors of Libby Perszyk Kathman Holdings, Inc. approved a resolution to terminate the Plan and to effectuate the Plan's termination provisions. In accordance with accounting principles generally accepted in the United States, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Libby Perszyk Kathman Holdings, Inc. Employee Stock Ownership Plan's ability to continue as a going concern within one year after the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**NOTES TO FINANCIAL STATEMENTS  
December 31, 2024 and 2023**

**NOTE 1 – DESCRIPTION OF PLAN**

The following description of Libby Perszyk Kathman Holdings, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan was organized by Libby Perszyk Kathman Holdings, Inc. (the Employer) effective January 1, 1994, as a leveraged employee stock ownership plan (ESOP) designed to comply with Sections 401 and 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by an Administration Committee comprising up to three persons appointed by the Employer's Board of Directors and is responsible for oversight of the Plan. An employee of an independent third-party provider serves as the Plan's trustee.

Effective October 11, 1994, the Plan purchased 100% of the outstanding common stock of the Employer using bank borrowings (which the Plan repaid in 2008) and holds the common stock in a trust established under the Plan. In 2007, the Plan purchased 30,000 shares of newly issued Employer common stock, which was funded with an acquisition loan from the Employer. The Employer has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. The note was repaid by the Plan during 2023, and all shares were allocated as of December 31, 2023.

**Plan Termination:** Effective August 31, 2024, the Employer froze the Plan and all employer contributions ceased, and all participants became 100% vested in their respective account balances. Effective December 31, 2024, the Employer elected to terminate the Plan and to effectuate the Plan's termination provisions. Liquidation of assets through distributions to participants is expected to be completed over the next five years. The description of the Plan's provisions below is applicable to the period prior to the termination date.

**Eligibility:** Prior to termination of the Plan, employees of the Employer were generally eligible to participate in the Plan after completion of one year of service, provided that they had worked at least 1,000 hours during such plan year, and attained age 21, as defined in the Plan Agreement. Once the Plan was frozen, a participant was eligible for an allocation of the Employer's contribution for the year if the participant was employed as of the date the Plan was frozen, August 31, 2024.

**Employer Contributions:** Prior to freezing the Plan, the Employer could elect to make discretionary contributions to the Plan. In 2024, the Employer made a discretionary contribution totaling \$507,395 to the Plan. Contributions were allocated to participants based on their respective eligible compensation during the year and their respective number of years of service, subject to the maximum amount permitted under the IRC.

Once the Plan was frozen, a participant was eligible for an allocation of the Employer's contribution for the year if the participant was employed as of the date the Plan was frozen, August 31, 2024. Prior to freezing the Plan, participants who did not have at least 1,000 hours of service during such Plan year and were not employed as of December 31st were generally not eligible for an allocation of Employer contributions for such year.

**Participant Accounts:** The Plan is a defined contribution plan under which a separate individual account is established for each participant. Prior to the Plan termination, each participant's account was credited with Employer discretionary contributions, as well as allocations of Plan earnings. Plan earnings were allocated to each participant's account based on the ratio of the participant's account balance, as defined in the Plan Agreement.

## NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

**Voting Rights:** Each participant was entitled to exercise voting rights attributable to the shares allocated to his or her account and was notified by the Trustee prior to the time that such rights were to be exercised. The Trustee was not permitted to vote any allocated share for which instructions had not been given by a participant.

**Vesting and Forfeitures:** As a result of the Plan's termination, all Plan participants became 100% vested in their respective account balances. Prior to the Plan's termination, if a participant's employment with the Employer ended for any reason other than retirement, permanent disability, or death, they would vest in the balances in their account based on total years of service with the Employer. A participant became 100% vested after six years of credited service, vesting 20% per year, beginning in year two. Although participants became vested in their account balances, the timing of the payment of their benefits is subject to certain restrictions as specified below under *Benefits*.

Prior to the Plan's termination, Plan forfeitures were first used to pay plan expenses. The remaining balance was allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the plan year. During 2024, there were no forfeited non-vested accounts used to pay plan expenses or allocated to plan participants.

**Benefits:** Prior to the Plan's termination, distributions from the Plan were made in lump-sum payments, as soon as practicable in the first Plan year following the Plan year in which a participant attained the Normal Retirement Age (65) or as a result of a participant's death or disability.

For a participant who was terminated for a reason other than attaining age 65, disability or death, the timing of when the Plan commenced distributions was based on the participant's vested account balance. If the participant's vested account balance was less than \$5,000, a distribution was made in a single lump-sum as soon as administratively practicable in the first Plan year following the year of termination. If a participant's vested account balance was greater than \$5,000, the distributions were made in annual installments up to five years depending on the participant's vested account balance as soon as administratively practicable following the earlier of the end of the fifth Plan year following the year of termination, or the end of the Plan year in which the participant attained age 65. Vested account balances that exceeded a certain dollar threshold as defined in the Plan Agreement could be paid in annual installments exceeding five years.

**Put Option:** Under federal income tax regulations, the Employer's common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, included a put option. The put option was a right to demand that the Employer buy any shares of its common stock distributed to participants for which there was no market. The put price was representative of the current appraised value of the stock. The Employer could have paid for the purchase with interest over a period of five years. However, it could have been extended to a date no later than the earlier of 10 years from the date the put option was exercised or from the date the proceeds of the loan were used by the Plan to acquire the Employer stock subject to the put option were entirely repaid. The purpose of the put option was to ensure that the participant has the ability to ultimately obtain cash.

**Diversification:** Diversification was offered to participants close to retirement so that they may have had the opportunity to move part of the value of their investment in the Employer's common stock into investments that were more diversified. Participants who were at least age 55 with at least 10 years of participation in the Plan may have elected to diversify a portion of their account. Diversification was offered to each eligible participant over a six-year period. In each of the first five years, a participant may have diversified up to 25% of the shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changed to 50%. Participants who were at least age 60 with at least 15 years of participation in the Plan may have also diversified 25% of their investment in Employer common stock each year for a total of 10 years beginning with the year in which the participant was first eligible to make the election. The election to diversify was made subsequent to year-end based upon the shares of the Employer's common stock in the participant's account at year-end. Participants who elected to diversify may have transferred the balance to their account in the Libby Perszyk Kathman Holdings, Inc. Profit Sharing 401(k) Plan or directly rolled over the account to another eligible retirement plan.

## NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting:** Due to the Plan's termination and in accordance with accounting principles generally accepted in the United States of America, the Plan changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements, to the liquidation basis used in presenting the 2024 financial statements.

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

**Estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Cash** is maintained in bank deposit accounts which, at times, may exceed federally insured limits. The Plan has not experienced any losses in such accounts.

**Investment Valuation and Income Recognition:** The shares of the Employer's common stock are valued at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administration Committee determined the Plan's valuation policies utilizing information provided by the Plan's investment advisor, independent valuation specialist, and Trustee. See Note 4 for a discussion of the fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:** Benefits are recorded when paid.

**Expenses:** Administrative expenses for maintaining the Plan may be paid by the Employer or the Plan, at the Employer's discretion. Certain administrative fees were charged directly to participants' accounts and were included in administrative expenses.

**Tax Status:** The Internal Revenue Service (IRS) has determined and informed the Employer by a letter dated December 11, 2014, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, the Plan Administrator believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or other taxing authorities.

The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in process.

**Subsequent Events:** The Plan Administrator has evaluated the financial statements for subsequent events occurring through October 15, 2025, the date the financial statements were available to be issued.

### NOTE 3 – PARTIAL PLAN TERMINATION

On December 31, 2023, the Plan Sponsor completed the sale of a participating employer, Spicefire, Inc. As a result of this transaction, the Plan experienced a partial plan termination due to an approximately 20% reduction in active participants. In connection with the partial plan termination, all affected participants became fully vested in their account balances, regardless of years of service.

### NOTE 4 – FAIR VALUE MEASUREMENTS

The Plan has categorized its assets and liabilities that are measured at fair value into a three-level fair value hierarchy. The hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described as follows:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. In situations where there is little or no market activity for the asset or liability, the Plan makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

Following is a description of the valuation methodologies used by the Plan for assets that are measured at fair value on a recurring basis. There was a change in the methodologies used at December 31, 2024 and 2023. This change is considered a change in valuation technique under ASC 820 and is accounted for prospectively as a change in estimate. Comparative periods were not adjusted.

**Common Stock of Libby Perszyk Kathman Holdings, Inc.:** Valued at the aggregate fair value as determined annually by the Trustee based on a report from an independent valuation specialist. At December 31, 2024, the independent valuation specialist utilized a weighted valuation considering the discounted cash flow method based on the Employer's future financial projections, with a certain adjustment related to a lack of marketability to determine fair value. At December 31, 2023, the independent valuation specialist utilized a weighted valuation considering the discounted cash flow and guideline public company method based on the Employer's historical operations and future financial projections, with a certain adjustment related to a lack of marketability to determine fair value.

**Money Market Fund Shares:** Valued at the daily closing price as reported by the fund. This fund is required to publish its daily net asset value (NAV) and to transact at that price. This fund held by the Plan is deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain assets could result in a different fair value measurement at the reporting date.

## **NOTE 6 – TERMINATED PARTICIPANTS**

Included in net assets in liquidation available for benefits were amounts allocated to terminated participants who had vested account balances but were not eligible for a withdrawal from the Plan until they reached retirement age, became disabled, deceased, or the earlier of the end of the fifth Plan year following the year of termination or the year following the Plan year in which the stock acquisition loan is repaid to the Employer. Net assets available for benefits allocated to these individuals totaled \$8,162,197 at December 31, 2023. Due to the plan termination as described in Note 1, all individuals became fully vested and are due the remaining net assets available for benefits to be paid over the next five years.

## **NOTE 7 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan's assets are primarily invested in the Employer's common stock. These transactions qualified as exempt party-in-interest transactions.

The Employer provided certain accounting and administrative services to the Plan for which it received no compensation.

## **NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan's investment securities, including the investment in the Employer's common stock, are exposed to various risks, such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the Employer's common stock and money market fund and to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in the value of the Employer's common stock and money market fund will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Plan's financial statements.
