We have performed audits of the financial statements of the D'Arcy 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) and Schedule H, Line 4a – Schedule of Delinquent Participant Contributions are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following brief description of the D'Arcy 401(k) Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution profit sharing plan covering eligible employees of D'Arcy Buick GMC, Inc. (D'Arcy) who have completed two months of service as defined by the Plan and have attained age 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan is funded by voluntary contributions of participants and matching and discretionary profit sharing contributions of D'Arcy. Participants may contribute to the Plan, through payroll deductions, an amount subject to limitations imposed by the Internal Revenue Code. Participants may also roll over amounts representing distributions from other qualified employee benefit plans. D'Arcy made a \$488,689 matching contribution and \$1,128 of correcting contributions for the year ended December 31, 2024. The matching contribution and correcting contributions were deposited to the plan in 2025.

Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and guaranteed investment contracts as investment options for participants. Each participant's account is credited with his or her voluntary contributions and allocations of D'Arcy's contribution and Plan earnings. The allocation of Plan earnings is based on participant earnings or account balances, as defined by the Plan. To receive an allocation of Plan earnings, participants must complete 1,000 hours of service. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant-Directed Investments

Participants must select from various investment options in which to invest their account balances. If a participant does not designate any investment option, all contributions to their account will be deposited into a default investment option designated by the Plan's trustee. Participants may change their investment options at any time.

Vesting

Participants are immediately fully vested in their voluntary contributions plus actual earnings thereon. The portion of the participants' accounts attributable to D'Arcy's profit sharing and matching contributions becomes 20% vested after two years of service and continues to vest at a rate of 20% for each successive year. The participant is fully vested after six years of credited service from the date of employment.

Payment of Benefits

Upon termination of service, a participant may elect to receive an amount equal to the value of his or her vested account balance in one lump-sum payment in cash or a direct rollover distribution. Hardship withdrawals are also permitted by the Plan.

1. Description of Plan

Forfeitures

Forfeitures of terminated participants' nonvested accounts are held in a cash account at year-end. Unused forfeitures included in net assets available for benefits were \$3,291 as of December 31, 2024.

Notes Receivable from Participants

Participants can borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance of the participants account and bear interest varying with prevailing rates at the time of the loan. Principal and interest are paid ratably through payroll deductions. Related interest income totaled \$9,936 for the year ended December 31, 2024.

Plan Amendment

Effective January 1, 2024, the Plan was amended to allow D'Arcy Imports, LLC employees to participate in the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (USGAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan invests in various mutual funds and guaranteed investment contracts. Investments in mutual funds are carried at fair value, as determined by quoted market prices. The guaranteed investment contracts are considered fully benefit responsive and may require a market value adjustment upon plan termination.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

2. Summary of Significant Accounting Policies

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

All expenses of maintaining the Plan are paid by the Plan.

3. Investments

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock Life Insurance Company (U.S.A.), the trustee as of December 31, 2024 and 2023 has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- a. Total investments as shown in the accompanying statements of net assets available for benefits of \$8,940,095 and \$7,491,164 as of December 31, 2024 and 2023, respectively.
- b. Total investment income (loss) as shown in the accompanying statement of changes in assets available for benefits was \$1,142,852 for the year ended December 31, 2024.

4. Fair Value Measurements

Accounting principles generally accepted in the United States of America provide the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under US GAAP are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:
quoted prices for similar assets or liabilities in active markets;
quoted prices for identical or similar assets or liabilities in active markets;
inputs other than quoted prices that are observable for the asset or liability;
inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Pooled Separate Accounts (PSA): Valued at the net asset value (NAV) of shares held by the plan at year-end. The NAV of a Pooled Separate Account (PSA) is based on the market value of its underlying investments. The PSA NAV is not a publicly-quoted price in an active market. The determination of where an investment falls in the fair value hierarchy was determined based on the lowest level input that is significant to the fair value measurement in its entirety. The lowest level of input are securities quoted on private markets that are not active, or securities traded on active markets.

Pooled separate accounts are valued at the NAV or equivalent based on units of the pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

Guaranteed Investment Contracts: Contract values of guaranteed investment fund investments are used as an approximation for fair value (level 2 inputs). The guaranteed investment contracts held by the Plan are considered fully benefit responsive. Upon termination of the plan, guaranteed investment contracts may require a market adjustment.

5. Income Tax Status

The Plan is a defined contribution profit-sharing prototype sponsored by D'Arcy Buick GMC, Inc. The plan is based on a prototype that has received a letter from the Internal Revenue Service as to its qualified status. The Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Risk and Uncertainties

The Plan invests in various mutual funds (investment securities). The mutual funds are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain mutual funds, it is at least reasonably possible that changes in the value of mutual funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Related-Party Transactions

Plan investments are managed by wealth management advisors. John Hancock Life Insurance Company (U.S.A.) is the trustee, as defined by the Plan. The Plan utilizes a third-party administrator. Fees paid to the third-party administrator qualify as party-in-interest transactions. The Plan paid fees amounting to \$53,213 for the third-party administrator services, including contract administration and investment advisory services. Fees paid by the Plan for investment management services were reported as administrative and other expenses.

8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan at any time to terminate the Plan subject to the provisions of ERISA. In the event of such a termination, the accounts of all participating employees would become fully vested. Upon termination, all benefits would be distributed to participants after payment of any administrative expenses and upon Internal Revenue Service approval.

9. Subsequent Events

Plan management has performed an analysis of the activities and transactions subsequent to December 31, 2024 to determine the need for any adjustments to and/or disclosures within the audited statements of net assets available for benefits and statement of changes in net assets available for benefits for the year ended December 31, 2024. Management has performed their analysis through October 15, 2025, the date when the financial statements were available to be issued.
