Report of Independent Auditors

To the Administrator of West Monroe Partners, Inc. Frozen Capital Accumulation Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of West Monroe Partners, Inc. Frozen Capital Accumulation Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management has obtained certifications from a qualified institution as of December 31, 2024 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, applied on a liquidation basis of accounting described in Note 2.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (US GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Other Matter – 2023 Financial Statements

Other auditors performed an audit of the 2023 financial statements of the Plan. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated October 10, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agreed to, or were derived from, in all material respects, the information prepared and certified by an institution management determined meets the requirements of ERISA Section 103(a)(3)(C) and (c) included a paragraph regarding the Plan's termination and change to liquidation basis of accounting. Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or was derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.



Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with US GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Notes to Financial Statements

1. Description of the Plan

The following brief description of the West Monroe Partners, Inc. Frozen Capital Accumulation Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete explanation of the Plan's provisions.

General

The Plan is a defined contribution plan for all eligible employees of West Monroe Partners, Inc. (the Company or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended by subsequent legislation.

On November 9, 2021, the Company was acquired by West Monroe Enterprises, Inc., a holding company formed by MSD Partners, LP, and the beneficial equity holders of West Monroe Partners, LLC to facilitate the acquisition of the Company (the Transaction). In 2023, MSD Partners merged with Chicago-based merchant bank BDT & Company and are known as BDT & MSD Partners.

Prior to November 9, 2021 (the Transaction Date), the equity ownership and governance structure of the Company was an S corporation, owned by an Employee Stock Ownership Plan (the ESOP). On the Transaction Date, West Monroe Enterprises, Inc., through its wholly owned intermediary companies, acquired 100% of the ESOP and all the outstanding shares of the Company previously held in the West Monroe Partners, Inc. Employee Stock Ownership Trust (the Trust) by Argent Trust Company (the Plan Trustee). The Transaction was completed pursuant to a stock purchase agreement. The primary purpose for the Transaction was to utilize the additional capital to expand the Company's product development platform and drive other key initiatives.

As a result of the Transaction, the ESOP was amended and terminated effective as of the Transaction Date, contingent upon receiving a favorable determination letter from the Internal Revenue Service (IRS) (the Closing Amendment). The receipt from the IRS of a favorable determination letter dated January 19, 2023 found that the termination of the Plan didn't affect its qualification for federal tax purposes. Among other things, the Closing Amendment converted the ESOP from a qualified employee stock ownership plan to a capital accumulation plan and changed the ESOP's name to the West Monroe Partners, Inc. Frozen Capital Accumulation Plan. The Plan is no longer designed to invest in employer securities or to qualify as an employee stock ownership plan.

Eligibility

Pursuant to the Closing Amendment, no new participants were eligible to enter the Plan on or after January 1, 2021.

Contributions

Effective as of the Closing Amendment, no contributions are to be made to the Plan with respect to any year beginning on or after January 1, 2021.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Starting in 2021, each participant's account is credited with allocations of the Plan earnings and administrative expenses. Allocations are based on participant account balances, as defined by the Plan.

Payment of Benefits

Pursuant to the Closing Amendment, the Plan was amended to allow participant account balances, including the proceeds from the Transaction, net of any Transaction escrow adjustments, to be distributed in lump-sum as soon as administratively possible.

The Closing Amendment requires that an aggregate of \$50,000,000 (allocated pro rata) (the holdback) must remain in the Plan until the later of (i) the Company's receipt of a favorable determination letter from the IRS in connection with the termination of the Plan or (ii) the second anniversary of the Transaction Date (November 9, 2023), so long as there have not been any claims pertaining to the administration or operation of the Plan by such date and, if such have been claimed, the later date upon which such claims have been resolved, or as soon as administratively practicable thereafter (the Final Distribution Date). In December 2021 a lawsuit was filed that is pending resolution (Note 8). Pursuant to the Closing Amendment, the holdback is available to satisfy legal claims relating to the administration of the Plan.

Upon the Final Distribution Date, the remaining balance in each participant's account, including net earnings, if any, shall be distributable in a lump-sum. Each participant and beneficiary will be given a notice of their distributable amount to be paid from the Plan and will be given at least 30 days to elect a rollover of such balance. If a participant or beneficiary cannot be located or does not respond to such notice of distribution, the Plan administrator may direct that the distribution of the account balance of such participant or beneficiary be transferred to the Frozen Capital Accumulations Plan transfer account, established on behalf of such participant or beneficiary in the West Monroe Partners, Inc. 401(k) Plan (the 401(k) Plan).

Vesting

Effective with the Closing Amendment, each eligible participant became 100% vested and the vesting schedules applicable to prior years no longer applied, regardless of such participant's actual years of service.

2. Summary of Accounting Policies

Basis of Accounting

As a result of the Transaction, and in accordance with accounting principles generally accepted in the United States of America (GAAP), the Plan's financial statements are prepared using the liquidation basis of accounting.

This basis was adopted when liquidation was deemed imminent in accordance with Accounting Standards Update (ASU) 2013-07, *Liquidation Basis of Accounting*. Plan management determined that liquidation was imminent upon Plan termination on November 9, 2021. Under the liquidation basis of accounting, assets are measured at their net realizable value, estimated by fair value reduced by surrender charges, penalties and redemption charges, and disposal expenses, to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process. Liabilities are measured using the accrual basis of accounting, including any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. There were no changes to the fair value of investments due to liquidation accounting as of December 31, 2024 or 2023. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Following the Transaction, all Plan expenses are charged to Plan assets on a pro rata basis.

Distributions

Following the Transaction Date, substantially all balances eligible for distribution were paid by December 31, 2022. For the years ended December 31, 2024, \$109,766 in eligible participant balances were distributed from the Plan in lump sum.

Subsequent Events

The financial statements and related disclosures include evaluations of events up through and including October 15, 2025, the date the financial statements were available to be issued.

No other additional subsequent events have occurred through that date that required recognition or disclosure in the financial statements.

3. Administration of Plan Assets

The Plan's assets following the Transaction, consist of a money market fund investing in a portfolio of short-term U.S. Treasury securities, held in the Trust by the Plan Trustee.

Effective February 1, 2024, the Company engaged Creative Planning as the ERISA 3(21) Investment Advisor to the Plan.

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan.

4. Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024, and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Argent Trust Company, a qualified institution.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required

supplemental schedules, including assessing whether the supplemental schedules are in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

5. Fair Value Measurements

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures* establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Fund – This asset is valued using amortized costs, which approximate fair values. The fund is considered a Level 1 investment.

6. Related Party and Party-in-Interest Transactions

Argent Trust Company is the Plan Trustee and Principal Financial Group provides certain recordkeeping and administrative services to the Plan. These organizations are considered to be parties-in-interest under ERISA. Expenses for services rendered paid to Argent Trust Company and Principal Financial Group for the year ended December 31, 2024 totaled \$298 and \$650, respectively.

7. Tax Status

On February 25, 2022, the Company filed an application for a favorable determination letter for a terminating plan to receive confirmation from the IRS that the Closing Amendment and Plan termination do not adversely impact the Plan's tax-exempt status. A favorable determination letter dated January 19, 2023 was received by the Company confirming the Plan's tax-exempt status.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

8. Risks and Uncertainties

The Plan provides for investments that, in general, are exposed to various risks, such as interest rates, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

On December 22, 2021, a putative class action lawsuit was filed in the United States District Court for the Northern District of Illinois against the Company, the Board of Directors of the Company, the Plan Administrator Committee, and the Plan Trustee (together Defendants), asserting claims under ERISA against Defendants for breach of fiduciary duty and prohibited transactions resulting in alleged losses to certain Plan participants in connection with the distribution of benefits to them prior to the Transaction. Defendant's motion to dismiss was granted in part and denied in part by the Court on March 15, 2023, dismissing individual Board and Plan Administrator Committee members without prejudice, but otherwise denying Defendant's motion to dismiss. The Court has yet to rule on the motion for class certification and the motion remains pending. On January 17, 2025, Defendants filed motions for summary judgement and Plaintiff filed a motion for partial summary judgment. The parties completed briefing on these motions on April 17, 2025, which remain pending. At this time, the Company believes the likelihood of any material loss to the Plan relating to this matter is remote given the strength of Defendant's defense should the case go forward.

9. Plan Termination

The Plan was terminated on November 9, 2021, immediately following and coinciding with the Transaction, and contingent upon the receipt of a favorable determination letter from the IRS. Upon Plan termination, the Plan was amended by the Closing Amendment to convert the Plan from an employee stock ownership plan under IRC Section 4975(e)(7), to a capital accumulation plan under IRC Section 401(a). A favorable determination letter from the IRS, dated January 19, 2023, was received by the Company confirming the tax-exempt status of the terminating plan.

10. Concentrations

The Plan holds certain investments that represent 10% or more of the Plan's net assets available for benefits. As of December 31, 2024 and 2023, the Plan had investments of \$55,960,861 and \$53,314,356, respectively, that were concentrated in one fund.
