## Notes to Financial Statements

### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### ***Basis of Presentation***

The accompanying financial statements of The Ralph J. Stolle Company Retirement Plan (the "Plan") have been prepared on the modified cash basis. That basis differs from accounting principles generally accepted in the United States of America primarily because the Plan has not recognized balances, and the related effects on earnings, of receivables for employer contributions.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or global conflict. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### ***Related-Party Transactions***

Several employees of the Sheffer Corporation and The Ralph J. Stolle Company (collectively, the "Company") provide administrative services to the Plan. These services include Plan oversight and day-to-day Plan administration. The Plan is not charged by the Company for the services of the employees to the Plan.

#### ***Estimates***

The preparation of financial statements requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

#### ***Benefit Payments***

Benefit payments are recorded when paid.

#### NOTE 1 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

##### *Expenses*

The Plan has an agreement with its third party trustee in which the Plan receives a revenue sharing credit, based on the investments held in the Plan, to be accumulated in an unallocated account for the purposes of paying administrative expenses of the Plan. During 2024, the Plan received \$-0- which is recorded against the administrative expenses on the Statements of Changes in Net Assets Available for Benefits (Modified Cash Basis).

Certain expenses and costs of the Plan were paid by the Company and, accordingly, are not reflected in the Plan's financial statements. Certain investment related expenses are included in net appreciation of fair value of investments.

##### *Subsequent Events*

The Company has evaluated subsequent events to the date of the statement of net assets available for benefits through October 14, 2025, which is the date these financial statements were available to be issued.

#### NOTE 2 DESCRIPTION OF THE PLAN

The following description of The Ralph J. Stolle Company Retirement Plan provides only general information. Participants should refer to their The Ralph J. Stolle Company Retirement Plan agreement for a more complete description of the Plan's provisions.

##### *General*

The original effective date of the Plan was January 1, 1997. The Plan is a defined contribution plan covering substantially all employees. Employees become eligible to participate in the plan on the first day of the month following the completion of 60 days of service and having attained the age of 18 years old. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

##### *Contributions*

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan, on a pretax or Roth basis. However, contributions may not exceed limitations established under Section 402(g) of the Internal Revenue Code of 1986 as amended (\$23,000 at December 31, 2024). For December 31, 2024, Section 414(v) of the Internal Revenue Code of 1986 as amended allowed a maximum catch-up contribution of \$7,500. Participants may change the percentage of contribution invested in each account and may make transfers between accounts anytime during the year. In 2024, the Company made discretionary matching contributions equal to 25% of the first 5% of deferrals that a participant contributed to the Plan for the 2023 Plan year.

The Plan allows for automatic enrollment of eligible employees at a 5% deferral rate.

The Company may also make a profit sharing contribution to the Plan. The Company did not elect to make a profit sharing contribution in 2024.

### Notes to Financial Statements (Continued)

#### NOTE 2 DESCRIPTION OF THE PLAN (CONTINUED)

##### ***Rollover Contributions***

Participants may roll over their taxable portion of funds previously held for their account in another qualified employee benefit plan to the Plan on a tax-free basis.

##### ***Participant Accounts***

Each participant's account is credited with the participant's and Company's contributions and a pro-rata allocation of the Plan's earnings and expenses. The pro-rata allocation is based upon each participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### ***Vesting***

Participants become immediately vested at the time of participation in the Plan in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts, plus actual earnings thereon is based on years of continuous service. Participants become partially vested after one year of service and 100 percent vested after 5 years of credited service. Forfeited balances of terminated participants' non-vested accounts are applied to offset administrative expenses of the Plan. Forfeitures exceeding these expenses shall be used to reduce employer contributions. During 2024, \$1,971 of forfeited funds were used to offset administrative expenses of the Plan. The balance of unallocated forfeitures was \$1,094 and \$386 as of December 31, 2024 and 2023, respectively.

##### ***Payment of Benefits***

Upon a participant's retirement, death, total and permanent disability, or other termination of employment with the company, the participant may elect to receive their benefit in a lump sum distribution.

In-service distributions are permissible from the Plan for participants that have attained the age of 59 1/2.

In conditions of "financial hardship", as defined, a participant may apply to the Plan administrator for approval to withdraw that portion of his 401(k) retirement account balance necessary to meet the financial hardship, subject to the limitations of the Plan and the Internal Revenue Code.

##### ***Notes Receivable from Participants***

Notes receivable are available on amounts in the participant's account. The minimum note amount is \$1,000 and the maximum is the lesser of one-half of the participant's vested account balance or \$50,000. The vested participant account balance will be used as collateral for any note. All notes shall bear a reasonable rate of interest as determined by the Plan administrator. All notes must be repaid within five years except in the case of a note for the purpose of acquiring a home. Participants may only have one note outstanding at a given time.

#### NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs.

The hierarchy is broken down into three levels based on the ability to observe inputs as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued using quoted market prices of the shares of each applicable mutual fund.

*Common collective trust:* Values based on the NAV of units of a collective trust as published by the trustee.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different approaches or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### NOTE 4 TAX STATUS

The Plan Sponsor has adopted a prototype plan which has received an opinion letter from the Internal Revenue Service dated June 30, 2020, which states the provider's prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. The Plan has been amended since adoption of the prototype plan. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, therefore, no provision for income taxes has been included in the Plan's financial statements.
