# Notes to Financial Statements

---

## Sutherlin Automotive Group, LLC 401(k) Plan Wetumpka, Alabama December 31, 2024 and 2023

### Note 1 – Description of the Plan

The following description of the Sutherlin Automotive Group, LLC 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering substantially all employees of Sutherlin Automotive Group, LLC (the "Company") who are at least 21 years old and completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

During 2024, various participating employer locations were sold and participants were terminated. Plan management determined that there was a partial plan termination, and the terminated participants are being treated as fully vested. The following locations were sold during 2024: Sutherlin Nissan Fort Myers, Inc sold January 29, 2024, Sutherlin Nissan Cape Coral, Inc. sold January 29, 2024, Sutherlin GMA Fort Myers, LLC sold January 29, 2024. Sutherlin Nissan Vero Beach, Inc. sold October 31, 2024. Sutherlin Nissan Vero Beach was removed as a participating employer as of December 1, 2024.

Contributions - Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Roth contributions are also permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company contributes 25 percent of the participants' contributions to the Plan up to 3 percent of gross compensation. Non-elective amounts may be contributed at the discretion of the Company. Participants must be employed on the last day of the Plan year to receive an allocation of any discretionary non-elective contribution. There were no such contributions for the Plan year ended December 31, 2024. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant accounts - Each participant's account is credited with the participant's contributions, the Company's matching contributions, the Company's discretionary nonelective contributions, if any, and Plan earnings. Investment earnings and losses are allocated based upon the investment performance of each investment in the participant's account. Allocations of the Company's discretionary non-elective contributions, if any, are based on the ratio of the participant's eligible compensation to total eligible compensation for the Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company matching and discretionary non-elective contributions is based on years of continuous service. A participant is 20 percent vested after two years of service is completed, and vests an additional 20 percent per year until full vesting after six years.

Notes receivable from participants – Prior to transfer of plan assets to Newport Trust Company, LLC, now Ascensus, participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan terms ranged from one to five years. The loans were secured by the balance in the participant's account and bore interest at the prime interest rate plus one percent. Principal and interest were paid through payroll deductions.

At the time of the transfer of the plan's assets, a new adoption agreement was signed which no longer allowed loans. All participants with outstanding loans at the time of transfer had their loans deemed distributed.

Payment of benefits - Benefits are payable upon retirement at age 65, disability, death, or termination of employment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document. Withdrawals from rollover contributions are permitted at age 59 1/2. Benefits are payable in lump sum, installment, or ad-hoc payments.

Forfeited accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$46,694 and \$88,564, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During 2024, \$12,241 forfeited nonvested accounts were used to reduce employer contributions and \$42,546 was used to pay Plan expenses.

Administrative expenses - Certain expenses of maintaining the Plan are paid by the Company. Transaction expenses, such as loan and distribution administration fees, are charged directly to the participant's account. Participants are also charged an asset-based fee for recordkeeping. These fees are included in administrative expenses.

Amendment and Restatement – The Plan was formally amended January 1, 2024, to remove the locations sold in 2023 as participating employers. It added Sutherlin GMA Fort Myers, LLC, Sutherlin North Knoxville, LLC and Sutherlin Automotive Group, LLC as participating employers with a retro active date of April 1, 2023. The amendment also added Sutherlin Motors Montgomery, Inc. and Montgomery LMA, Inc. as participating employers effective January 1, 2024. The Plan was further amended to change the service requirement to six months and remove automatic enrollment and loans. During 2024, various participating employer locations were sold and participants were terminated. Plan management determined that there was a partial plan termination and the terminated participants are being treated as fully vested. Sutherlin Nissan Fort Myers, Inc., Sutherlin Nissan Cape Coral, Inc., and Sutherlin GMA Fort Myers, LLC all sold on January 29, 2024.

Effective July 5, 2024 the Plan was amended and restated to adopt a pre-approved plan of Newport Group, Inc. With this amendment and restatement, the Plan sponsor was changed to Sutherlin Automotive Group, LLC, the Plan name changed to Sutherlin Automotive Group, LLC 401(k) Plan, Sutherlin Nissan Vero Beach, Inc. was added as a participating employer effective January 1, 2024 and Sutherlin IOM Inc. was added as a participating employer effective June 10, 2024. All assets were transferred to Newport Group, Inc. on July 2, 2024.

Note 2 – Significant Accounting Policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein. Actual results could differ from those estimates.

Note 2 – Significant Accounting Policies (Continued)

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in a orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Contributions - Participant contributions and the related Company matching contributions are recognized in the period the participant contribution is withheld from compensation. The Company discretionary non-elective contribution is recognized in the period the related compensation is paid to the participant.

Payment of benefits - Benefits are recorded when paid.

Subsequent events - The Plan has evaluated subsequent events for disclosure in these financial statements through October 14, 2025, which is the date the financial statements were available to be issued.

Note 3 – Information Prepared and Certified by the Custodian

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, and Newport Trust Company, LLC the custodians of the Plan.

Note 4 – Fair Value Measurements

The Plan reports its assets at fair value based on a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of the shares of mutual funds owned by the Plan is based upon the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

The fair value of the collective trust funds is based on the net asset value ("NAV") on the last business day of the Plan year provided by the entity holding the trust funds. The NAV of the collective trust is used as a practical expedient to estimate fair value and is determined by the fund trustee based on the fair value of underlying assets in the trust, less its liabilities.

- (a) In accordance with ASC 820, certain investments that were measured at net asset value per share (or its equivalent) as of December 31, 2023 have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the Statements of Net Assets Available for Benefits.

Investments in all collective trust funds, except the Drive Income Fund and the MFS Mid Cap Value Fund, can be redeemed each business day at the current net asset value based on the fair value of the underlying assets. Redemptions from the Drive Income Fund and the MFS Mid Cap Value Fund for participant withdrawals are permitted each business day. Plan level redemptions from the Drive Income Fund require 90 days written notice. Plan level redemptions which will exceed \$1 million from the MFS Mid Cap Value Fund require five business days written notice. The investment objective of the MFS Mid Cap Value Fund is capital appreciation. There are no other withdrawal limits, redemption frequency limits or redemption notice periods. There were no unfunded commitments for these investments as of December 31, 2023.

Note 5 – Risks and Uncertainties

The Plan provides for investments in various securities that are exposed to risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future statements of net assets available for benefits.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

Note 7 – Income Tax Status

The Plan is a pre-approved plan of Newport Trust Company, LLC which received an opinion letter on June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the form of the plan document was acceptable under the applicable requirements of the Internal Revenue Code (“IRC”). The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Party-in-Interest Transactions

Certain Plan investments are managed by Newport Trust Company, LLC. Newport is the custodian as defined by the Plan. In addition, the Plan paid certain expenses related to plan operations and investment activity to various service providers. For the first half of the year investments were managed by Empower. Empower was a custodian as defined by the Plan. These transactions qualify as exempt party-in-interest transactions.

Note 9 – Reconciliation to Form 5500
