## **EFFECTIVE DATE**

The effective date of the plan was January 1, 2019. The plan was last amended effective January 15, 2021.

## **PLAN YEAR**

January 1 through December 31.

## **ELIGIBILITY**

Any employee of the Employer except the Secretary/Treasurer.

## **ENTRY DATE**

First day of calendar quarter coincident with or next following one (1) Year of Service. The service requirement is waived for any Eligible Employee employed on January 1, 2019.

## **NORMAL RETIREMENT AGE**

Age 65, or the participant's 5th anniversary of joining the Plan, if later.

## **NORMAL RETIREMENT DATE**

First of the month coincident with or next following Normal Retirement Age.

## **ACCRUED BENEFIT**

The Accrued Benefit means, as of any determination date, the Participant's Cash Balance Account, offset by the participant's profit sharing account (but only reflecting the portion of the account related to a 5% compensation) under the defined contribution plan, on such date projected, if necessary, with estimated Interest Credits between the determination date and the Participant's Normal Retirement Date, and then converted to an Actuarial Equivalent immediate annuity.

## **CASH BALANCE ACCOUNT**

The sum of Contribution Credits and Interest Credits, defined by the Plan as the Cash Balance Account. In no event shall a distribution of the Cash Balance Account be less than the sum of all Contribution Credits credited to the Participant's Cash Balance Account. The Cash Balance Account as of the Effective Date for a Direct Owner shall be \$285,516.

## **COMPENSATION**

Compensation as defined under Code Section 415(c) and the Treasury Regulations thereunder.

## **CONTRIBUTION CREDITS**

As of the last day of each Plan Year, a Contribution Credit shall be credited to the Cash Balance Account of each participant. The Contribution Credit shall be as follows:

- (a) For a Direct Owner, \$0.
  
- (b) For all other non-highly compensated employees, 3% of Compensation.

## **INTEREST CREDITS**

At the end of each Plan Year an Interest Credit shall be credited to the Cash Balance Account. The Interest Credit is equal to the 30-year Treasury Rate for the third month prior to the Plan Year, multiplied by the Participant's Cash Balance Account as of the beginning of the Plan Year, reduced for any distributions during such Plan Year. Interest Credits shall cease to be credited to a Participant's Cash Balance Account after (1) a lump sum distribution occurs, or (2) a monthly annuity commences.

## **Payment of Retirement Benefits**

### **BENEFIT AMOUNT**

The Cash Balance Account, or its Actuarial Equivalent payable as an annuity, subject to IRS maximums.

### **BENEFIT ELIGIBILITY**

#### Normal Retirement Benefit

Reaching Normal Retirement Date.

#### Terminated Vested Benefit

Termination of employment after having earned a vested Accrued Benefit.

#### Death Benefit

The spouse or other named beneficiary of an active or terminated participant is eligible upon the participant's death prior to Normal Retirement Age and before benefit payments commence.

### **BENEFIT PAYMENT FORMS**

The normal form of payment for a single participant is a straight life annuity and for a married participant is a reduced qualified joint and survivor annuity, with 50% of the benefit continuing to the surviving spouse upon the earlier death of the participant.

In lieu of the normal form of payment, a participant may elect a single lump sum payment (with proper spousal consent, if married). A married participant may elect a 75% joint & survivor annuity.

### **VESTING**

A Participant is fully vested in his or her Cash Balance Account after 3 years of service (ignoring any service prior to the Effective Date).
