## Notes to Financial Statements

December 31, 2024 and 2023

### Note 1 - Plan Description

The following description of Convergent Technologies LLC 401(k) Profit-Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan, established on June 1, 2003, is a defined contribution plan covering substantially all full-time, part-time, temporary, and seasonal employees of Convergent Technologies LLC (the "Company"). Leased employees, nonresident aliens, and members of a collective bargaining unit are not covered by the Plan. Employees become eligible to participate, and can enroll, in the Plan immediately upon hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

During the year ended December 31, 2024, the Company acquired several companies with employees who entered the Plan under the same participant eligibility requirements noted above, resulting in a significant amount of rollovers, which are included in the balance of \$9,902,502 in the accompanying statement of changes in net assets available for benefits.

#### **Contributions**

The Plan provides for employee 401(k) deferral contributions at a percentage of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants who have attained age 50 before the end of a plan year are eligible to make catch-up contributions in addition to regular deferral contributions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Company employees are automatically enrolled in the Plan, after 30 days of eligibility, at a 4 percent contribution rate unless the employee elects otherwise.

The Plan provides for discretionary employer matching and profit-sharing contributions. Participants must be employed on the last day of a plan year and work at least 1,000 hours during that year in order to receive an allocation of employer contributions. In 2024, employer matching and profit-sharing contributions were equal to 50 percent of each participant's contributions up to \$6,500.

Certain participant contributions in 2022, 2023, and 2024 were paid after the time frame required by the Department of Labor. The Company remitted these contributions to the Plan during 2022, 2023, and 2024, respectively. Lost interest on the 2022 and 2023 delinquent contributions were remitted to the Plan during 2024. The lost earnings on the 2024 delinquent contributions were remitted to the Plan in 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, if any, and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

#### **Vesting**

Participants are fully vested at all times in employee contributions plus earnings thereon. Participants vest in discretionary employer matching and profit-sharing contributions and actual earnings thereon based on years of continuous service. Participants become vested at 20 percent after one year of service and 50 percent after two years of service, becoming fully vested after three years of service.

#### **Forfeitures**

If a participant is not fully vested on his or her termination date, nonvested amounts are forfeited. Forfeitures are used to reduce future employer contributions.

### Note 1 - Plan Description (Continued)

The Plan used approximately \$223,000 for the year ended December 31, 2024 to reduce employer contributions.

#### ***Benefit Payments***

Upon termination of service due to death, disability, retirement, or separation from service, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions are available to employees who reach normal retirement age, as defined by the Plan.

Participants may request that all or a portion of their accounts be distributed in the case of financial hardship, as defined in the plan agreement.

#### ***Participant Notes Receivable***

Participants may borrow up to the lesser of \$50,000 or 50 percent of their vested account balances, reduced by the excess of the highest outstanding balance of all prior loans under all qualified plans of the Company in the previous 12 months. Notes receivable are collateralized by the participant's account balance and bear interest at a reasonable rate of interest commensurate with the prevailing rate charged by lenders for a loan of a similar type.

#### ***Party-in-interest Transactions***

Certain plan investments are invested in funds managed by Principal Life Insurance Company (Principal Life), Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust), and Principal Global Investors Trust Company (Principal Global). Principal Life, Principal Trust, and Principal Global are the custodians, as defined in the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value.

The common/collective trust fund and pooled separate account are valued at net asset value per share (NAV) or its equivalent, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 4 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Benefit Payments***

Benefits are recorded when paid.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Administrative Expenses***

Expenses incurred in administering the Plan are paid by the Plan. All other expenses are paid by the Company.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including October 14, 2025, which is the date the financial statements were available to be issued.

**Note 3 - Certified Information**

Principal Life, Principal Trust, and Principal Global (collectively, the "Custodians") hold the Plan's investments and execute all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by Principal Life; Principal Trust; and Principal Life, on behalf of Principal Global.

**Note 4 - Fair Value Measurements**

Accounting standards require that certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.
