Opinion on the 2024 Financial Statements

1. Plan Description and Basis of Presentation

The following brief description of the Commerce Bank and Trust Holding Company Employee Stock Ownership Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

General

Commerce Bank and Trust Holding Company (the Company) established the Plan effective as of February 10, 1976. The Plan is a defined contribution plan intended to constitute an employee stock ownership plan (ESOP), and was designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended and subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by an ESOP/401(k) committee appointed by the Company's board of directors. The trust department of CoreFirst Bank and Trust, a wholly-owned subsidiary of the Company, is the Plan's trustee. The Plan was last restated in 2016, with an effective date for the restatement of January 1, 2016.

All shares are allocated to participants.

Eligibility

Employees of the Company and its participating subsidiaries are generally eligible to participate in the Plan after attaining age 21 and two years of service providing they worked at least 1,000 hours during each plan year.

Contributions

Each year, the Company may contribute to the Plan up to 25% of covered compensation as determined annually by the Company's board of directors. Contributions may be in the form of shares of common stock or cash. Contributions for each year are never less than the amount required to enable the Plan to fulfill the current obligations, without regard to whether some or all of such contributions may fail to qualify for an income tax deduction by the Company. In order to receive an allocation of company contributions, a participant must complete 1,000 hours of service and be employed on the last day of the Plan year unless termination is due to death, disability or retirement. Contributions are subject to IRC limitations.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of the Company's contribution. Only those participants who are eligible employees of the Company as of the last day of each plan year will receive an allocation. Allocations are based on the participant's eligible compensation, relative to total eligible compensation. Plan earnings or losses are allocated based on each participant's share of the total plan investment at the beginning of the year, less distributions and withdrawals during the year. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are 100 percent vested in their account balances upon entrance to the Plan.

Payment of Benefits

Generally, no distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company and its participating subsidiaries. A participant's account balance shall be distributed following his separation from service, but only at the time and in the manner determined by the Plan.

Upon termination of service, a participant will receive a lump sum distribution of their account balance without consent if their balance does not exceed \$1,000. If the amount is between \$1,000 and \$7,000, the balance will be rolled into an individual retirement account in the participant's name. For accounts of not more than \$1,380,000 and \$1,330,000 for 2024 and 2023, respectively, the distribution will be made in substantially equal annual installments over a period of five years. If the account exceeds \$1,380,000 and \$1,330,000 for 2024 and 2023, respectively, the Plan administrator may extend the five-year distribution period by an additional three years. The amount to be distributed is based upon the account valuation date immediately preceding the distribution.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in company common stock into investments, which are more diversified. Participants who have attained the age of 55, with at least 10 years of participation in the Plan, may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the total number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage increases to 50 percent. Participants who elect to diversify receive a cash distribution.

Voting Rights

All qualifying company securities in the trust shall normally be voted by the trustee in the manner directed by the Plan administrator. In certain important matters, however, such as a sale or merger of the Company, participants will have the right to direct the trustee on how shares of company stock allocated to their ESOP account will be voted.

Put Option

Under Federal income tax regulations, company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The shares of the Company's common stock are reported at estimated fair value. See Note 6 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plans' expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

3. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated November 1, 2017, that the Plan is qualified, and the trust established under the Plan is tax-exempt under the appropriate sections of the IRC. The Plan has been amended and restated since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

4. Administration of Plan Assets

The Plan's assets, which consist principally of company common stock, are held by the trustee of the Plan.

Company contributions are held and managed by the trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. Administrative expenses for the trustee's fees are paid directly by the Company.

6. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Commerce Bank and Trust Holding Company common stock* – Valued at estimated fair value based on an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and the fair value of Commerce Bank and Trust Holding Company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.
- *Money market fund* – Valued at net asset value of shares held by the Plan at year-end.

The preceding valuation methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Plan management evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2 or 3.

7. Risks and Uncertainties

The Plan's investments consist primarily of the Company's common stock, which is exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of common stock will occur in the near term and such changes could materially affect participant account balances and the amounts reported in the financial statements and supplemental schedules.

8. Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC. Upon termination of the Plan, the ESOP/401(k) committee should direct the trustee to pay all liabilities and expenses of the trust fund.

9. Related Party and Party-in-Interest Transactions

The Plan invests in company common stock. This is a related party and party-in-interest transaction. In addition, as described in Note 2, the Company pays a portion of plan administrative expenses. These are related party and party-in-interest transactions.

The Plan has a number of service providers. Such providers are considered parties-in-interest.
