INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of the Georgia Pain and Wellness Center 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

Note 1 – Description of Plan

The following description of the Georgia Pain and Wellness Center 401(k) Plan (“the Plan”) is provided for general informational purposes only. More complete information regarding the Plan’s provisions may be found in the Plan Document.

General

The Plan is a defined contribution and profit sharing plan originally established on March 1, 2014 by Georgia Pain and Wellness Center (“the Plan Sponsor” or “the Company”), doing business as Summit Spine & Joint Centers, under the provisions of Section 401(k) of the Internal Revenue Code (“IRC”). The Plan was restated on January 1, 2023. The Plan covers all eligible employees and is administered by an Administrative Committee appointed by the Board of Directors of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers all eligible employees of Georgia Pain and Wellness Center, LLC; Georgia Interventional Pain, LLC; Sleep Ezzy, LLC; and Surgical Center Solutions, LLC.

Eligibility

Employees are eligible to participate in the Plan upon reaching the age of 21. There is no minimum service requirement in order for an employee to become eligible to participate in the Plan.

Contributions

Participants may elect to defer a portion of their pre-tax annual compensation subject to IRC limitations. The Plan also allows for Roth deferrals. The Plan permits rollover contributions into the Plan. The Company will make safe harbor matching contribution during the year. The Company matching formula is calculated as 100% of employee contributions up to 4% of annual compensation. Contributions are subject to certain limitations. The Plan does not have an automatic enrollment feature.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s contribution, rollover contributions, and allocations of the Plan’s earnings and losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting

All participants’ contributions and earnings thereon are fully vested. Participants are fully vested in Company safe harbor matching contributions. Discretionary Company matching contributions and nonelective company contributions vest using an elapsed time method. A participant is 20% vested in Company profit sharing contributions after two years of credited service, 40% vested after three years, 60% vested after four years, 80% vested after five years, and 100% vested after six years.

Forfeited Accounts

Forfeitures of terminated participants' non-vested accounts are used to reduce future Company contributions and pay administrative expenses of the Plan. The amounts of unallocated forfeitures at December 31, 2024 and 2023 were approximately \$30,937 and \$17,600, respectively. The Plan Administrator expects to use these amounts to reduce Company contributions or to pay plan expenses in the following year.

Payment of Benefits

The full value of a participant's account is eligible for payment when: (1) the participant retires at age 59 1/2 or later; (2) the participant becomes permanently disabled; (3) the participant terminates employment; or (4) the participant dies while an active participant in the Plan. Participants who are not fully vested in discretionary employer matching contributions and nonelective contributions will receive the vested portion of their account balance.

Administrative Expenses

The Company pays administrative expenses related to certain recordkeeping services. All other administrative expenses and participant transaction fees are paid by participants. Expenses may be allocated either proportionately based on participants' account balances or as an equal dollar amount based on the number of participants in the Plan. Certain expenses specifically incurred by a participant, such as taking a withdrawal from the Plan, are paid directly by that participant.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with generally accepted accounting principles (U.S. GAAP).

Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

Investment Valuation and Income Recognition

Investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

The Plan presents, in the statement of changes in net assets available for benefits, the net appreciation or depreciation in fair value of investments which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Administrative fees paid by the Plan were \$7,850 for the year ended December 31, 2024.

Fair Value Measurements

FASB ASC 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money market funds: Valued at cost, which approximates fair value using Level 1 inputs.

Mutual funds: Valued at quoted prices in active markets based on the last reported sales price of the fund on the last day of business of the year on a national exchange using Level 1 inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Subsequent Events

Subsequent events have been evaluated through October 15, 2025, which is the date the financial statements were available to be issued.

Note 3 – Tax Status

The Plan is a pre-approved, non-standardized 401(k) and profit sharing plan created by ERISA Services, Inc. The Internal Revenue Service (“IRS”) issued an opinion letter dated June 1, 2021 stating that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC) and is acceptable for use by employers for the benefit of their employees under IRC Section 401. Although the Plan has not obtained an individual determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

The Plan permitted provisions of SECURE Act 2.0 during the years ended December 31, 2024 and 2023. Written amendments to the plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidance.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 4 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 5 – Certified Information

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following investment information was certified by Voya Retirement Insurance and Annuity Company and was not subjected to any auditing procedures performed by the independent public accountants:

- a. Investments and notes receivable from participants as of December 31, 2024 and 2023.
- b. Plan transactions related to investment income, securities transactions and interest income on notes receivable from participants for the year ended December 31, 2024.
- c. Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

Note 6 – Parties-in-Interest

Parties-in-interest, as defined by the Plan, include ERISA Services, Inc. as the third-party administrator and Voya Retirement Insurance and Annuity Company as the trustee, custodian, and recordkeeper. Therefore, transactions occurring between the Plan and the third-party administrator and trustee, custodian, and recordkeeper qualify as party-in-interest transactions. Certain administrative fees are deducted from the Plan assets in the normal course of the Plan's operations. Total administrative fees deducted from the Plan's assets for the year ended December 31, 2024 was \$7,850. In addition, the Plan Sponsor paid all other administrative costs of the Plan including the audit fee.

Note 7 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 – Group Annuity Contract

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (“Voya”) totaling \$14,495 and \$47,747 as of December 31, 2024 and 2023, respectively, which is recorded at contract value. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer.

The crediting rate is reviewed on a monthly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.
