We have performed audits of the financial statements of Gourmet Boutique, LLC Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## **Note 1. Plan Description**

The following description of Gourmet Boutique, LLC Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

### ***General***

The Plan, established on June 1, 2003, and restated on January 1, 2021, is a defined contribution plan covering all eligible employees of Gourmet Boutique, LLC, and Gourmet Boutique West, LLC (collectively referred to as the “Company”), who are age 21 or older and worked more than 1,000 hours and have completed six months of service. Employees become eligible to make elective deferrals and receive matching contributions on the first day of the calendar month coinciding with or following the date the participant attains age 21 and completes six months of eligible service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974*, as amended by subsequent legislation (“ERISA”).

### **Contributions**

#### ***Participant Salary Deferral***

Participants in the Plan may contribute a discretionary amount of their annual compensation and bonus provided that the participant’s contribution does not exceed the maximum dollar amount determined by the Internal Revenue Service (“IRS”) each year, which is \$23,000 for the year ended December 31, 2024. Employees over the age of 50 can elect to contribute an additional \$7,500 each year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

#### ***Employer Safe Harbor Contributions***

The Company makes safe harbor contributions based on participants’ pre-tax contributions up to 3% of their compensation, plus one-half of the totals in excess of 3% of the participants’ compensation, but not in excess of 5% of total participants’ compensation. For the year ended December 31, 2024, the employer contributions were \$169,375. Additional amounts may be contributed by the Company at the option of its Board of Directors. There were no additional amounts contributed for the year ended December 31, 2024.

#### ***Vesting***

Participants are immediately vested in their voluntary contributions and employer safe harbor contributions plus actual earnings thereon. Any additional contributions by the employer vest over a six-year period in 20% increments beginning after one year of service until the sixth year, at which time the participant is 100% vested.

#### ***Participant Accounts***

Individual participant accounts are credited with the applicable participant and safe harbor contributions and allocations of investment earnings or losses and are charged with an allocation of administrative fees. Allocations are based upon participant earnings or account balances, as defined in the plan document.

#### ***Investment Options***

Participants may direct contributions to any of the investment options offered by the Plan. Participants may change their investment options on a daily basis.

***Distributions***

Distributions from the Plan are permitted under the following circumstances: (i) attainment of age 59 ½, (ii) termination of employment, (iii) death or permanent disability, and (iv) a proven hardship. Distributions from a participant's account are made in the form of a lump-sum payment or installments over a period of not more than the participant's assumed life expectancy (or the assumed life expectancy of a beneficiary). The benefit to which a participant is entitled is equal to the vested portion of the participant's account.

***Notes Receivable from Participants***

In general, the participants may borrow from their vested account balances a minimum of \$1,000 not to exceed the lesser of either (i) \$50,000 or (ii) 50% of the vested amount of the participant's account attributable to salary deferrals and rollovers from other plans.

Loans are secured by the balance in the participant's account and bear interest at an interest rate determined by the plan administrator based on annual interest rates charged for similar types of loans by other lenders (4.25% and 9.50% per annum at December 31, 2024). A loan shall be repaid over a period of up to five years. Loans are repaid through payroll deductions. At December 31, 2024 and 2023, participant loans were \$209,036 and \$254,958, respectively.

***Forfeitures***

Non-vested account balances that remain upon participant termination may be used to pay Plan administrative fees. Any remaining forfeitures will be used to reduce the employer's contribution. At December 31, 2024 and 2023, there were no forfeitures available for future use.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements have been prepared using the accrual method of accounting.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines its valuation policies utilizing information provided by trustee. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Benefit Payments***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Administrative Fees***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees.

**Note 3. Information Certified by the Plan's Custodian**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments were managed by Reliance Trust Company. Reliance Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$71,029 and \$60,791 for the years ended December 31, 2024 and 2023, respectively, and are included in administrative fees on the statement of changes in net assets available for benefits.

### **Note 6. Tax Status**

The Plan operates under a non-standardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 7. Risk and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities may occur in the near term, and those changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **Note 8. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants will become fully vested in their accounts.

### **Note 9. Subsequent Events**

The Plan has evaluated events through October 14, 2025, the date the financial statements were available to be issued.
