Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Martins, Inc. 401(k) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

Basis for Opinion on the Financial Statements

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1. Plan Description and Significant Accounting Policies

The following description of Martins, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan that covers all employees of Martins, Inc. (the Company or Sponsor) who have one year of service, worked 1,000 hours and are age 21 or older. The Plan's entry dates are the first day of each calendar quarter. The Plan's Retirement Investment Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors of the Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan amendment: Effective September 30, 2024, the Plan was amended to adopt the Loan Interest Rate Update Service (LIR). LIR is an automated process to update plan loan interest rates based upon the prime rate as reported by Thomson Reuters. On the first business day of the next month following any change in the prime rate as reported by Reuters, or no later than five business days following such first business day, the system will be updated to reflect the change. All loans initiated or reinitiated after such a change will be processed using the interest rate resulting from the change.

Contributions: A participant in the Plan may elect to enter into a salary reduction agreement with the Company, which would be applicable to the Plan year during which the election is made, and to subsequent plan years, unless canceled or modified. The Plan allows for a reduction in compensation not to exceed 50% of eligible plan compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also allows rollovers from other qualified defined contribution and defined benefit plans.

The Company may make discretionary matching contributions to the Plan. A discretionary matching contribution of 20% of participant's contributions, up to 25%, was made to the Plan for the year ended December 31, 2024. Discretionary employer contributions totaled \$104,174 for the year ended December 31, 2024.

Eligible bargaining unit employees are allocated a nonelective employer contribution of 10 cents per hour of service. Wage deferrals are not required for union employees to receive this employer contribution. Nonelective employer contributions totaled \$8,455 for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Auto-enrollment: The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Auto-escalation: The Plan also includes an auto-escalation provision whereby participants that are auto-enrolled are subject to an annual automatic deferral rate increase of 1% until their deferral rate reaches 10% of eligible compensation. Participants may elect to discontinue their participation in the automatic deferral rate increase at any time.

Investment options: Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator in 1% increments. Participants may change their investment options daily.

Note 1. Plan Description and Significant Accounting Policies (Continued)

Participant accounts: Each participant's account is credited with the participant's contribution and the Sponsor's matching contributions, as well as allocations of nonelective employer contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, hours of service or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their elective deferral contributions, plus actual earnings thereon. Eligible bargaining unit employees are 100% vested in all nonelective employer contributions. Vesting in the Company's discretionary matching contributions, plus actual earnings thereon, is based on years of continuous service. A participant vests in company matching contributions as follows:

Payment of benefits: Upon termination of service due to death, disability, retirement or early retirement, as defined in the Plan agreement, a participant is considered fully vested and, as such, is entitled to 100% of his/her account balance. For termination of service for other reasons, a participant may receive the value of the vested interest in his/her account. Following termination, participants with vested account balances of less than \$1,000 will receive a cash out distribution in a lump sum payment. Terminated participants with a balance greater than \$1,000, but not exceeding \$5,000, will have their vested balance automatically rolled over into a Fidelity Individual Retirement Account (IRA), unless specific distribution instructions are received from the participant within an allotted time frame. Participants may also withdraw funds from the vested portion of their accounts because of financial hardship, which must be demonstrated to the Plan Administrator, and must not exceed the amount of the participant's financial need. A participant reaching normal retirement age of 59½ may take an in-service distribution from his/her vested account balance. Participants may receive their vested account balances in the form of a lump sum payment, a direct rollover into an IRA or into an eligible benefit plan, or in substantially equal installment payments over a period of time.

Forfeitures: Forfeitures are used to reduce future employer contributions or pay Plan expenses. Forfeited nonvested accounts totaled \$1,621 and \$590, as of December 31, 2024 and 2023, respectively. During 2024, \$6,232 was used to reduce employer contributions, and \$0 were used to pay administrative expenses.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loan term can be for no more than five years, unless such loan is for the purchase of a participant's primary residence, in which case the repayment period shall be no more than 10 years. Participants are limited to two outstanding loans at any given time. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Loans outstanding at December 31, 2024, bear interest of between 4.25% and 9.50%, and the loans mature through 2029. Principal and interest are paid ratably through monthly payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements are presented on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation. Nonelective employer contributions are recorded in the year in which eligible bargaining unit employees incur qualifying paid hours. Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 4. Fair Value Measurements (Continued)

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5. Related Party and Party-in-Interest Transactions

Fidelity is the trustee of the Plan; therefore, transactions with the trustee qualify as party-in-interest transactions. The Sponsor also paid certain administrative expenses of the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider, FMR, LLC, has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Notes to Financial Statements

Note 1. Plan Description and Significant Accounting Policies

The following description of Martins, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan that covers all employees of Martins, Inc. (the Company or Sponsor) who have one year of service, worked 1,000 hours and are age 21 or older. The Plan's entry dates are the first day of each calendar quarter. The Plan's Retirement Investment Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors of the Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan amendment: Effective September 30, 2024, the Plan was amended to adopt the Loan Interest Rate Update Service (LIR). LIR is an automated process to update plan loan interest rates based upon the prime rate as reported by Thomson Reuters. On the first business day of the next month following any change in the prime rate as reported by Reuters, or no later than five business days following such first business day, the system will be updated to reflect the change. All loans initiated or reinitiated after such a change will be processed using the interest rate resulting from the change.

Contributions: A participant in the Plan may elect to enter into a salary reduction agreement with the Company, which would be applicable to the Plan year during which the election is made, and to subsequent plan years, unless canceled or modified. The Plan allows for a reduction in compensation not to exceed 50% of eligible plan compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan also allows rollovers from other qualified defined contribution and defined benefit plans.

The Company may make discretionary matching contributions to the Plan. A discretionary matching contribution of 20% of participant's contributions, up to 25%, was made to the Plan for the year ended December 31, 2024. Discretionary employer contributions totaled \$104,174 for the year ended December 31, 2024.

Eligible bargaining unit employees are allocated a nonelective employer contribution of 10 cents per hour of service. Wage deferrals are not required for union employees to receive this employer contribution. Nonelective employer contributions totaled \$8,455 for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Auto-enrollment: The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

Auto-escalation: The Plan also includes an auto-escalation provision whereby participants that are auto-enrolled are subject to an annual automatic deferral rate increase of 1% until their deferral rate reaches 10% of eligible compensation. Participants may elect to discontinue their participation in the automatic deferral rate increase at any time.

Investment options: Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator in 1% increments. Participants may change their investment options daily.

Note 1. Plan Description and Significant Accounting Policies (Continued)

Participant accounts: Each participant's account is credited with the participant's contribution and the Sponsor's matching contributions, as well as allocations of nonelective employer contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, hours of service or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their elective deferral contributions, plus actual earnings thereon. Eligible bargaining unit employees are 100% vested in all nonelective employer contributions. Vesting in the Company's discretionary matching contributions, plus actual earnings thereon, is based on years of continuous service. A participant vests in company matching contributions as follows:

Payment of benefits: Upon termination of service due to death, disability, retirement or early retirement, as defined in the Plan agreement, a participant is considered fully vested and, as such, is entitled to 100% of his/her account balance. For termination of service for other reasons, a participant may receive the value of the vested interest in his/her account. Following termination, participants with vested account balances of less than \$1,000 will receive a cash out distribution in a lump sum payment. Terminated participants with a balance greater than \$1,000, but not exceeding \$5,000, will have their vested balance automatically rolled over into a Fidelity Individual Retirement Account (IRA), unless specific distribution instructions are received from the participant within an allotted time frame. Participants may also withdraw funds from the vested portion of their accounts because of financial hardship, which must be demonstrated to the Plan Administrator, and must not exceed the amount of the participant's financial need. A participant reaching normal retirement age of 59½ may take an in-service distribution from his/her vested account balance. Participants may receive their vested account balances in the form of a lump sum payment, a direct rollover into an IRA or into an eligible benefit plan, or in substantially equal installment payments over a period of time.

Forfeitures: Forfeitures are used to reduce future employer contributions or pay Plan expenses. Forfeited nonvested accounts totaled \$1,621 and \$590, as of December 31, 2024 and 2023, respectively. During 2024, \$6,232 was used to reduce employer contributions, and \$0 were used to pay administrative expenses.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loan term can be for no more than five years, unless such loan is for the purchase of a participant's primary residence, in which case the repayment period shall be no more than 10 years. Participants are limited to two outstanding loans at any given time. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Loans outstanding at December 31, 2024, bear interest of between 4.25% and 9.50%, and the loans mature through 2029. Principal and interest are paid ratably through monthly payroll deductions.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements are presented on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation. Nonelective employer contributions are recorded in the year in which eligible bargaining unit employees incur qualifying paid hours. Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Payment of benefits: Benefits are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to the participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Note 4. Fair Value Measurements (Continued)

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5. Related Party and Party-in-Interest Transactions

Fidelity is the trustee of the Plan; therefore, transactions with the trustee qualify as party-in-interest transactions. The Sponsor also paid certain administrative expenses of the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan has adopted a non-standardized form of a pre-approved plan. The pre-approved plan provider, FMR, LLC, has received an opinion letter from the IRS as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
