## INDEPENDENT AUDITORS' REPORT

To the Participants and Administrator of  
González Trading Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of González Trading Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

#### Note 1 - Plan description

The following description of the González Trading Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan was established on July 15, 2021, as a defined contribution plan, covering all regular employees of Teselta LLC (the Plan Sponsor), formerly González Trading LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the Puerto Rico Internal Revenue Code (the Code).

Effective January 1, 2025, the name of the Plan was changed to Teselta Retirement Plan. This change did not affect the structure, administration, or operation of the Plan.

##### Contributions

Each year, participants may contribute an amount of their compensation not exceeding the maximum deferral as specified by local law. Participants may also contribute amounts representing distributions from other qualified plans, subject to the conditions and limitations set forth in the Plan agreement. The Plan's Sponsor makes discretionary matching contributions equal to 50% of participant contributions up to 6% of the participant compensation. The Plan Sponsor may also make discretionary profit sharing contributions.

##### Investments options

The Plan Sponsor's and participants' contributions are invested in various investment funds provided by the custodian as permitted in the Plan agreement.

##### Participant's accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions and related employer matching and profit-sharing contributions, as well as the participant's share of the Plan's income and losses, and related administrative expenses, if any.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Plan's Sponsor matching portion of their accounts plus actual earnings thereon is based on years of continuous service.

### Notes to Financial Statements (Continued)

December 31, 2024 and 2023

#### Note 1 - Plan description – (continued)

##### Vesting – (continued)

A participant is fully vested after five years of credited service, as follows:

2 years less than 3	25%
3 years less than 4	50%
4 years less than 5	75%
5 years or more	100%

##### Notes receivable from participants

Participants may borrow from their fund accounts as provided in the plan document. Loans are secured by the balance in the participant's account and bear interest at rates determined at the time funds are borrowed as provided in the plan document.

##### Payment of benefits

Upon termination of service due to death, disability or retirement, a participant or the participant beneficiaries may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump-sum amount, substantially equal installments or partial withdrawals, provided the minimum withdrawal is \$500 and distributions may be made in cash only. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

In addition, the Plan provides for in-service distributions in certain circumstances, including financial hardship withdrawals, subject to certain limitations. Also, in-service distributions may be available to participants as special disaster distributions, as determined by the Puerto Rico Treasury Department.

##### Administrative expenses

The Plan Sponsor is responsible for the general administration of the Plan. All administrative fees, to the extent not paid from the Plan's assets, are paid by the Plan Sponsor.

#### Note 1 - Plan description – (continued)

##### Forfeitures

Upon participant's termination from employment or withdrawal from the Plan for any reason other than death, retirement or disability, the Plan Sponsor contributions on behalf of the participants not then vested are forfeited. Forfeitures shall be used to pay for the Plan's expenses, allocated to the participant accounts, or to reduce the Plan Sponsor contribution. At December 31, 2024 and 2023, the forfeitures account balance amounted to \$15,658 and \$5,392, respectively.

##### Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### Note 2 - Summary of significant accounting policies

##### Basis of accounting and presentation

The financial statements of the Plan are prepared under the accrual method of accounting and in accordance with accounting principles generally accepted in the United States of America (GAAP).

##### Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### Investments valuation and income recognition

The Plan's investments with readily determinable fair values are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investments without readily determinable fair values consist of shares of collective trust funds, which are valued using the net asset value per share as a practical expedient for fair value.

### Notes to Financial Statements (Continued)

December 31, 2024 and 2023

#### Note 2 - Summary of significant accounting policies – (continued)

##### Investments valuation and income recognition – (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. During the year ended December 31, 2024, the Plan's investments appreciated in value by \$102,436.

##### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the plan document.

##### Excess participants' contribution payable

Amounts payable to participants for contributions in excess of amounts allowed by the Code are recorded as a liability in the accompanying statements of net assets available for benefits, with a corresponding reduction to contributions.

##### Payment of benefits

Benefits are recorded when paid.

##### Benefits payable

The Plan accounts for benefits payable in accordance with the guidance provided by the American Institute of Certified Public Accounts (AICPA) *Audit and Accounting Guide, Audits of Employee Benefit Plans*, which requires that benefits payable to persons who have withdrawn from participation in a defined contribution plan be disclosed in the notes to the financial statements rather than recorded as liability of the Plan. There were no benefits payable at December 31, 2024 and 2023.

##### Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

#### Note 3 - Certified investments information

Certain information in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company LLC (the Trustee), a qualified institution.

#### Note 4 - Fair value measurements

Financial Accounting Standards Board, Accounting Standards Codification (ASC) No. 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Notes to Financial Statements (Continued)

December 31, 2024 and 2023

Note 4 - Fair value measurements – (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds – Investments in mutual funds are valued at the net asset value of shares held by the Plan at year end. Mutual funds are classified as Level 1.

Fixed annuities – Fixed annuities are valued based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider. Fixed annuities are classified as Level 2.

Collective trust funds – Investments in collective trust funds are valued at the net asset value determined by the fund administrators as a practical expedient for fair value. Such net asset values are based on the fair value of the underlying investments in the funds. Investments that are measured at fair value using the net asset value practical expedient are not required to be classified within the fair value hierarchy, as provided by ASC 820.

The preceding methods described may have resulted in fair values that may had not been indicative of net realizable values. The use of different methodologies or assumptions to determine the fair value of certain financial instruments could have resulted in different fair value measurements at the reporting date. The Plan management believes its valuation methods are appropriate and consistent with other market participants. There were no changes in the Plan's valuation methodologies used during 2024 and 2023.

As of December 31, 2024 and 2023, there were no unfunded commitments related to the Plan's collective trust funds. Redemption notice periods primarily range from 0 to 3 months and redemption frequency windows range from daily to quarterly.

Note 5 - Party-in-interest transactions

Certain Plan investments are managed by the Trustee; therefore, these transactions qualify as party in interest transactions.

Note 6 - Non-exempt prohibited transactions

During the year ended December 31, 2023 and 2022, participant contributions amounting to \$15,255 and \$58,421, respectively, were deposited into the trust later than required by Department of Labor regulations. As of December 31, 2024 and 2023, late contributions amounting to \$15,255 and \$41,273 corresponding to 2023 and 2022, respectively, remained uncorrected.

Note 7 - Tax status

The Plan constitutes a qualified plan, exempt from income taxes under the provisions of the Code. The Plan obtained a favorable determination letter on January 24, 2022, in which the Commonwealth of Puerto Rico tax authorities stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving its determination letter, however, the Plan administrator, based on the advice of legal counsel, believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Code and the Plan and related trust continue to be tax-exempt.

Note 7 - Tax status – (continued)

Management has evaluated the tax positions taken by the Plan and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that will require adjustment to the financial statements.

Note 8 - Subsequent events

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued. No events have occurred subsequent to the statement of net assets available for benefits date and through the date the financial statements were available to be issued, that would require additional adjustments to, or disclosure in, the financial statements.
