NOTE A -- Description of the plan and significant accounting policies

The following description of the Hayat for Life 401(k) Plan ("the plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions. Hayat Pharmacy, LLC (the "plan administrator" and "the company") has adopted the Saturna Trust Company Non-standardized Defined Contribution Pre-Approved Plan effective June 1, 2022. The original effective date of the plan was January 1, 2016.

General

The plan is a defined contribution plan covering all employees of Hayat Pharmacy, LLC, with the exception of nonresident aliens and union employees, who have sixty days of service and are age eighteen or older. To be eligible for the employer non-elective profit-sharing contribution, an employee must have completed one year of service. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Hayat Pharmacy Executive Team oversees governance of the plan, determines the appropriateness of the plan's investment offerings and monitors investment performance.

The plan's federal identification number is 83-1411818 and the plan's number is 001.

Contributions

Each year, participants may contribute up to the maximum amount allowed by law of annual compensation, as defined in the plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined-benefit or defined-contribution plans. Participants direct the investment of their contributions into various investment options offered by the plan. The employer contributes 200% of the first 1% of employee deferral, 100% of the next 2% and 50% of employee deferrals between 3% and 5% of eligible compensation that a participant contributes to the plan as a safe harbor contribution. The company also has the right to make additional discretionary profit-sharing contributions based on compensation. No additional discretionary contributions were made for 2024. Annual contributions from all sources are subject to certain limitations defined by the Internal Revenue Service (IRS).

Participant accounts and "rollovers"

Each participant's account is credited with the participant's contribution and allocations of (a) the employer's safe harbor and discretionary contribution, (b) plan earnings and (c) charged with an allocation of administrative expenses. Allocations of plan earnings are based on participant account balances, as defined, and allocation of company contributions are based on participants' compensation, as provided in the plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The plan permits the transfer of funds from other qualified plans to a separate participant's rollover account.

Vesting

Participants are vested immediately in their contributions and safe harbor contributions plus actual earnings thereon. Vesting in the employer's discretionary profit-sharing contribution portion of their account is based on years of continuous service. A participant is 100% vested on a six-year graded schedule. Participants who leave the plan because of death or disability, as defined in the plan, are considered 100% vested in all amounts.

NOTE A -- Description of the plan and significant accounting policies (Continued)

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate that is determined as 1% over the Prime Rate. Principal and interest is paid ratably through payroll deductions.

Benefits

On termination of service, due to death, disability or retirement (age 62), or termination of service due to other reasons, a participant with an account balance less than \$5,000 shall receive a lump-sum distribution. For accounts exceeding \$5,000, the participant may elect a lump-sum distribution, partial withdrawals, or may elect to defer such distribution to any valuation date subsequent to his or her termination but no later than the valuation date of his/her normal retirement date; or the participant may elect to rollover the distribution to another qualified plan. The plan permits hardship distributions if certain criteria are met. The plan permits in-service distributions at age 59½.

Forfeited accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. Any forfeitures will be used to pay plan expenses and, in some cases, used to reduce employer contributions.

A summary of significant accounting policies follows:

Basis of accounting

The financial statements of the plan are prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") under the accrual method of accounting.

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The plan's investments are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Hayat Pharmacy Executive Team determines the plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

NOTE A -- Description of the plan and significant accounting policies (Continued)

Payment of benefits

Benefits are recorded when paid.

Administrative fees

The company pays most of the administrative expenses of the plan, which are excluded from these financial statements. The major administrative expenses are recordkeeping and investment fees.

Notes receivable from participants

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded.

Subsequent events

These financial statements have not been updated for subsequent events occurring after August 28, 2025, which is the date these financial statements were available to be issued. The plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

NOTE B -- Information certified by the asset custodian and trustee

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest and dividends, net appreciation, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Saturna Trust Company, the asset custodian and trustee of the plan.

NOTE C -- Fair value measurements

The plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Benefits.

U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. The plan has no assets requiring Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Registered investment companies. Valued at the daily closing price as reported by the fund. Mutual funds held by the plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Gains and losses (realized and unrealized) included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 are reported in net appreciation in fair value of investments.

NOTE D -- Party-in-interest transactions

Certain plan investments are managed by Saturna Trust Company (Saturna). Saturna is the asset custodian, recordkeeper and third party administrator of the plan and is therefore designated as a fiduciary and party-in-interest.

Saturna provides certain administrative services to the plan pursuant to a Master Plan Services Agreements (MSA) between the employer and Saturna. Saturna receives revenue from mutual fund service providers for services Saturna provides to the funds. This revenue is used to offset certain amounts owed to Saturna for its administrative services to the plan.

If the revenue received by Saturna from such mutual fund service providers exceeds the amount owed, Saturna remits the excess to the plan's trust on a quarterly basis. Such amounts may be applied to pay plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The plan or plan sponsor may make a payment to Saturna for administrative expenses not covered by revenue sharing.

NOTE E -- Concentration of market risks

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE F -- Tax status

The Saturna Trust Company Non-standardized Defined Contribution Pre-Approved Plan, that the plan adopted effective June 1, 2022, obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was acceptable under Section 401 of the Internal Revenue Code (IRC) for use by employers for the benefit of their employees. The plan has been amended since the date of the opinion letter. However, the plan administrator and the plan's tax counsel believe that the plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the plan was qualified and the related trust was tax-exempt as of the financial statement date.

NOTE G -- Plan termination

Although it has not expressed any intent to do so, the company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their employer's discretionary profit-sharing contribution.


