In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Lathrop GPM LLP Retirement Plan and Trust's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### ***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to, or is derived from, the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Note 1. Description of the Plan**

The following description of Lathrop GPM LLP Retirement Plan and Trust, formerly known as Lathrop Gage LLP Retirement Plan and Trust (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan, organized in 1968, is a defined contribution plan covering all eligible members and employees of Lathrop GPM LLP (the "Firm"), a Missouri Limited Liability Partnership, who are not eligible for the Lathrop GPM LLP 401(k) Plan. Effective January 1, 2020, the Plan was renamed Lathrop GPM LLP Retirement Plan and Trust due to the merger between Lathrop Gage GPM LLP and Gray, Plant, Mooty, Mooty & Bennett, P.A. (GPM). Also, effective January 1, 2020, Lathrop GPM Consulting LLC became a participating employer.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Charles Schwab Trust Bank and First State Trust Company are the trustees of the Plan. Schwab Retirement Plan Services, Inc. is the record-keeper for the Plan.

**Plan Merger, Plan Amendment, and Restatement**

Effective January 1, 2021, the Plan was amended and restated to operate under a non-standardized adoption agreement in connection with a pre-approved profit-sharing plan sponsored by Schwab Retirement Plan Services, Inc.

Effective January 4, 2021, the assets of the Lathrop GPM LLP Retirement Savings Plan merged into the Plan.

**Asset Transfer from Plan**

In order to permit participants to consolidate all qualified defined contribution plan accounts into a single plan, participants are allowed to transfer amounts to and from this Plan to the Lathrop GPM, LLP 401(k) Plan if they are ineligible to actively participate in the Lathrop GPM, LLP 401(k) Plan at the same time as they actively participate in this Plan. During the years ended December 31, 2024 and 2023, a net \$2,474,464 and \$5,555,614, respectively, was transferred from this Plan into the Lathrop GPM, LLP 401(k) Plan.

**Eligibility and Contributions**

A partner or employee is eligible for participation in the Plan and may make salary reduction contributions on the first day of the calendar month following the date of employment. A partner or employee is eligible for full participation in the Firm's discretionary non-elective contribution once he or she has completed one year of service. The plan entry dates are January and July. Partners and employees must be active partners or employees as of the end of the plan year to receive the Firm's discretionary non-elective contribution unless terminated due to death, disability, or retirement.

Participants may elect to make salary reduction contributions up to 75% of their annual eligible compensation, excluding payments made subsequent to the severance of the participant's employment with the Firm, subject to IRS limitations. Employee rollover, employee Roth, and after-tax contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Employees, with the exception of self-employed partners, leased employees, and employees hired prior to May 1, 2015, who had fixed dollar deferral elections in effect on May 1, 2015, are automatically enrolled in automatic pretax deferrals at a rate of 4% of compensation. The automatic enrollment applies on the 16<sup>th</sup> day after the date the employee first becomes eligible to make elective contributions. If a participant's elective contribution percentage is less than 6% of compensation, the election will automatically increase by 1% on July 1, and every July 1, thereafter. This automatic increase does not apply to self-employed partners, participants with fixed dollar deferral elections, and participants with affirmative elections not to defer.

Effective June 1, 2018, the Plan was amended to allow partners to elect to defer flat dollar amounts out of their semimonthly draw payments.

For the plan years ended December 31, 2024 and 2023, eligible employees shall receive a match of 50% of employee deferrals up to 6% of compensation, which will be contributed each pay period with an annual true-up.

For the plan year ended December 31, 2024, the Firm's discretionary non-elective contribution was an annual contribution of 10.333% of annual compensation for all self-employed partners and 5% of annual compensation plus 5% of compensation in excess of the social security taxable base wage for all other eligible employees.

For the plan year ended December 31, 2023, the Firm's discretionary non-elective contribution was an annual contribution of 10.182% of annual compensation for all self-employed partners and 5% of annual compensation plus 5% of compensation in excess of the social security taxable base wage for all other eligible employees.

***Asset Custodians and Investment Options***

The Plan consists of participant-directed Trust Accounts and Personal Choice Retirement Accounts (PCRAs) maintained by Charles Schwab Trust Bank. The participant directed trust accounts can be invested in various mutual funds and common collective trusts and participants can choose among various investment options.

Each PCRA is comprised solely of one participant's account and is maintained as a self-directed brokerage account separately from the other PCRAs. The participant of a PCRA has the sole power to direct the trustee in the investment transactions of the account.

Participants may also take loans against their available account balances subject to provisions outlined in the Plan Document.

***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Firm's contributions, and plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting and Payment of Benefits***

Participants are immediately vested in the fair value of their account balances. Upon termination of service due to death, disability, or retirement, participants may receive their benefits as a lump sum, or may select from one of the other optional benefit forms offered by the Plan. Participants who terminate that have assets from the merged money purchase plan will receive that portion of their benefits as a joint and 50% survivor annuity (if married) or single life annuity (if not married) unless they elect one of the optional benefit forms offered by the Plan.

Participants who have terminated service that have vested balances of \$1,000 or less will receive a mandatory cash payout for their plan balance in the form of a lump sum payment directly to the participant.

Withdrawals other than for termination, such as in-service distributions when a participant has reached age 59 ½ or for financial hardship as defined by the IRS, are permitted under circumstances provided by the Plan.

Effective January 1, 2021, a participant who terminated employment with Gray, Plant, Mooty, Mooty & Bennett, P.A. prior to December 31, 2019, shall be fully vested in his or her nonelective employer contribution amounts after six years of service.

***Notes Receivable from Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the plan administrator.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Common stocks and U.S. government securities are valued at the closing price reported on the active market on which the individual securities are traded. Corporate bonds are valued on the basis of yields currently available on comparable securities of issuers with similar credit ratings. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the stable value fund and common collective trust funds are valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end.

Life insurance products are valued based on cash surrender value which approximates fair value. Partnerships are valued based on information received from the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Firm or the Plan, at the Firm's discretion.

### **Note 3. Certification of Plan Trustees**

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank and First State Trust Company, both qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Charles Schwab Trust Bank and First State Trust Company certified investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023.
- Charles Schwab Trust Bank and First State Trust Company certified investment income (loss) and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Charles Schwab Trust Bank and First State Trust Company certified investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

### **Note 4. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

The Plan pays record-keeping fees to Schwab Retirement Plan Services, Inc., who is related to the plan trustee.

Accounting fees and certain administrative expenses relating to the maintenance of employee eligibility records are paid by the Firm.

### **Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. See the tables below for inputs and valuation techniques used for Level 3 securities.

**Level 3 Activity**

There have been no purchases or transfers into or out of the life insurance policies and the limited partnerships during the years ended December 31, 2024 and 2023, respectively.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 7. Tax Status**

Effective January 1, 2021, the Plan was amended and restated to operate under a nonstandardized adoption agreement in connection with a pre-approved profit-sharing plan sponsored by Schwab Retirement Plan Services, Inc. This pre-approved plan document has been filed with the appropriate agency and has obtained an opinion letter from the IRS dated September 21, 2020, stating that the pre-approved plan constitutes a qualified plan under Section 401 of the Internal Revenue Code. Therefore, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

***Plan Merger***

As a result of the agreement entered into between the Firm and Hopkins & Carley, A Law Corporation, effective January 1, 2025, the former Hopkins & Carley employees and shareholders will become participants in either the Lathrop GPM LLP Retirement Plan and Trust or the Lathrop GPM LLP 401(k) Plan. Also, the Hopkins & Carley 401(k) Plan will merge certain assets into the Plan effective February 20, 2025.
