INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Ajax Paving Industries of Florida, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Ajax Paving Industries of Florida, LLC 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

NOTE 1 - Description of the Plan

The following summary description of the Ajax Paving Industries of Florida, LLC 401(k) Plan is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General - All employees of Ajax Paving Industries of Florida, LLC (the Company) not covered by a collective bargaining agreement, as defined in the Plan Agreement, who are at least 18 years old, are eligible to become participants in the Plan effective as of the first day of the month following their date of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Salary Reduction 401(k) Contributions - Participants may elect to contribute up to 75% of their pre-tax earnings to the 401(k) Plan up to the prescribed limits established by the Internal Revenue Code. Participants designate how their contribution will be invested in the investment funds selected by the Plan Administrator.

Company Matching Contributions - The Plan provides for an employer safe harbor contribution of 3% of compensation plus 50% of deferrals between 3% and 5% of compensation or an enhanced matching contribution equal to 100% of deferrals up to 5% of eligible compensation. For the plan years ended December 31, 2024 and 2023, the Company elected to utilize the enhanced matching contribution of 100% of employee deferrals up to 5% of compensation. The Company matching contributions for the years ended December 31, 2024 and 2023 were \$1,750,631 and \$1,394,648, respectively.

Discretionary Contributions - The Company may elect to make an additional matching or profit sharing contribution to the Plan. This contribution will be allocated in accordance with the terms of the Plan. The Company's discretionary contributions for the years ended December 31, 2024 and 2023 were \$35,000 and \$0, respectively.

Rollover Contributions - The Plan allows participants to make rollover contributions of amounts transferred from another qualified retirement plan.

Participant Accounts - Each participant's account is credited with the participant's contribution, company matching contribution, allocations of the Company's discretionary contribution, forfeiture allocations and Plan earnings. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the participant's vested account balance.

Investment Options - Upon enrollment in the Plan, a participant may direct contributions in any of the 36 investment options. Participants may change their investment options at any time. The options consist of professionally managed mutual funds and the insurance company guaranteed interest fund and vary in their respective strategies, risks and goals.

Vesting - Participants are immediately vested in their contributions and safe harbor contributions, plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100 percent vested after six years of credited service.

Notes Receivable From Participants - Participants may request a loan from the Plan of up to 50% of their account balance or \$50,000, whichever is lower. The loan term is limited to five years unless it is for the purchase of a principal residence. Loans are secured by the participant's account and bear interest at prevailing rates as determined by the Plan Administrator. Loans are repaid using coupons provided and administered by the Trustee.

Participant Withdrawals - Upon a participant's retirement date, death or total and permanent disability, all amounts credited to his or her account shall become fully vested. Upon termination, the non-vested portion of a participant's account shall be forfeited and subsequently allocated according to the terms of the Plan.

Distribution of the vested portion of a participant's account shall be made upon termination of employment. The vested portion of the account is payable in accordance with the terms of the Plan. If the vested portion of the account is less than \$5,000, the Administrator has the option of a lump-sum distribution without the participant's consent. However, if the vested portion of the participant's account exceeds \$5,000, a lump-sum distribution before normal retirement age can only be made with the participant's consent.

The Administrator shall direct the Trustee to distribute to a participant or his beneficiary any amount to which he is entitled under the Plan in one or more of the following methods:

- A lump-sum payment in cash or property.
- Payments in monthly, quarterly or annual cash installments over a reasonable period of time, not to extend beyond the participant's life expectancy. This option is only available if the accrued benefit exceeds \$5,000.

NOTE 1 - Description of the Plan (Continued)

Forfeited Amounts - At December 31, 2024 and 2023, unallocated forfeited balances totaled \$21,380 and \$19,726, respectively. The Company may elect to use future forfeited accounts to reduce Plan expenses or employer contributions. During the years ended December 31, 2024 and 2023, forfeited accounts were used to pay Plan expenses of \$11,690 and \$32,686, respectively.

SECURE Act and CARES Act - The Plan has implemented certain provisions of the SECURE Act, which was effective January 1, 2020, and the CARES Act, which was signed into law in March 2020. The Plan has until December 31, 2026, to adopt amendments to reflect these provisions.

NOTE 2 - Significant Accounting Policies

Basis of Accounting - The accompanying financial statements were prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investments - The Plan's investments are stated at fair value. Quoted market prices are used by the Trustee to value investments. Investments include shares of mutual funds and common trust funds and are valued at the net asset value of shares held by the Plan at year end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Dividends from investments in mutual funds are recorded when received. Unrealized appreciation (depreciation) of investments is the change between market value of investments at the beginning of the year and market value of investments at the end of the year.

Notes Receivable from Participants - Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Delinquent participant loans are recorded as a distribution in accordance with the terms of the plan document.

Payment of Benefits - Benefits are recorded when paid.

NOTE 2 - Significant Accounting Policies (Continued)

Administrative Expenses - The Plan sponsor pays for expenses associated with the administration of the Plan with the exception of the loan origination fees associated with participant loans and distribution fees, and professional fees.

Subsequent Events - Management has evaluated events and transactions through October 1, 2025, the date the financial statements were available to be issued. There were no subsequent events that require adjustment to or disclosure in the financial statements.

NOTE 3 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

The Plan's investments are reported at fair value in the statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels which are described below. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

Level 1 Fair Value Measurements

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The fair value of money market and mutual funds is based on quoted net asset values of the shares held by the Plan at year end. The fair values of common stocks are based on the closing price reported on the active market where the individual securities are traded.

Level 2 Fair Value Measurements

Level 2 inputs consist of quoted prices for similar assets in active and inactive markets and other observable corroborated market data. Level 2 inputs were only used when Level 1 inputs were not available. This includes, but not limited to, quoted prices for similar assets or liabilities in markets that are not active.

Level 3 Fair Value Measurements

Level 3 assets have the lowest priority. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available. The fair value measurement is based on other unobservable inputs. The Plan did not have Level 3 assets at December 31, 2024 and 2023.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation or (depreciation) in fair value of investments.

NOTE 5 - Information Certified by Trustee

The financial statements, accompanying notes and supplemental schedule were prepared in part from information certified by Empower Trust Company, the Trustee, in accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The information certified includes: investments, note receivable from participants, investment income, and participant loan interest.

NOTE 6 - Trust Agreement

Under an agreement signed during 2012, Empower Trust Company was appointed Trustee of the Plan. In accordance with the powers and duties of the Trustee as designated in the Trust Agreement, the Trustee invests the Plan's assets and the income for the benefit of the Plan participants.

NOTE 7 - Related Party and Party-In-Interest Transactions

Empower Trust Company is the trustee as defined by the Plan, and Great Lakes Pension Associates, Inc. provides recordkeeping services to the Plan. Therefore, they are considered parties-in-interest. The Company sponsors the Plan and is considered a party-in-interest. The administrative expenses paid by the Plan include plan administration and investment advisory fees. These service providers, along with service providers paid on behalf of the Plan, are all considered parties-in-interest.

NOTE 8 - Plan Termination

Although it has not expressed any intent to do so, the Company shall have the right at any time to terminate the Plan subject to the provisions of ERISA. Upon termination, all amounts credited to the affected participants' accounts shall become 100% vested.

NOTE 9 - Tax Status

The Plan has adopted a prototype plan sponsored by Great Lakes Pension Associates, Inc. Great Lakes Pension Associates, Inc. has obtained a determination letter dated December 29, 2020, in which the Internal Revenue Service stated that the prototype Plan was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter.

The Plan administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has concluded that as of December 31, 2024 there were no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. There are currently no audits in progress for any tax periods. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 10- Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and statement of changes in net assets available for benefits.
