Opinion

1. DESCRIPTION OF PLAN

The following description of The Townsend Corporation Employee Healthcare Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

General

The Plan was established by The Townsend Corporation (the "Employer"), to provide health benefits (medical and prescription drug) for all full-time eligible employees and their eligible enrolled dependents. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan is self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims administrator, who pays claims directly to, or on behalf of, participants after they have satisfactorily complied with the claim procedures as described in the plan document. The Plan utilizes a pharmacy benefits manager which periodically makes refunds to the Plan. Such refunds are included in rebates in the accompanying statement of changes in net assets available for benefits. The Plan offers three plans – the standard plan, the core plan, and a high deductible plan, each with varying benefits and premiums.

Contributions

The Plan is funded by contributions from the participants and the Employer. Participants contribute specified amounts based on their respective elections and applicable premiums, which are determined at the beginning of each plan year. As needed, the Employer contributes amounts to the Plan to fund claims and expenses in excess of employee contributions.

Plan Termination

Under certain conditions, the Plan may be terminated. Upon termination, any assets then remaining shall be subject to the applicable provisions of the Plan then in effect and shall be used until exhausted to pay benefits to employees in the order of their entitlement.

Administrative Expense

The Employer absorbs significant costs of plan administration.

Stop Loss Refunds

The Plan has unlimited specific stop-loss coverage for claims in excess of \$175,000 per person for the policy year, for the standard plan and high deductible plan. Claims exceeding the \$175,000 threshold are applied toward the aggregate specific deductible of \$435,000. The insurance provider pays all claims in excess of this amount. Premiums for stop loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits. Stop loss refunds are included as insurance proceeds in the accompanying statement of changes in net assets available for benefits. For the year ended December 31, 2024, no stop loss refunds were received by the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting. That basis differs from accounting principles generally accepted in the United States of America, in that the contributions are recorded when received, instead of when due to the Plan, and expenses are recorded when paid, instead of when the obligation occurs.

Although the modified cash basis of accounting represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the reporting requirements of ERISA.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Payment of Claims

Claims are recorded when paid.

Tax Status

The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator and the Plan's tax counsel believe that the Plan was designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code, and therefore believe the Plan is qualified.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be

taken that would require disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements are available to be issued, which is October 15, 2025.

3. COBRA RECEIPTS

Under the Comprehensive Omnibus Budget Reconciliation Act of 1986 (COBRA), employees who are enrolled in the Plan have the option of continuing their coverage at their own expense in certain cases when normally the coverage would cease. COBRA receipts are from former employees who qualify for continued coverage and have opted for continued coverage through the Plan.

4. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. Professional fees were paid by the Employer and the majority of other administrative expenses of the Plan were paid by the Plan.

The Plan's third-party claims administrator, UMR, receives payment from the Plan for these services. Sun Life Assurance Company of Canada is the provider of the stop-loss insurance coverage for the Plan and receives payment from the Plan for these services. Blue & Co., LLC is the independent auditor of the Plan and receives payment from the Employer for these services.
