Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Riverview Center for Growth 403(b) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

Other Matter - Supplemental Information Required by ERISA

The supplemental schedules, as identified in the table of contents, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such schedules are the responsibility of management and were derived from and relate directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Note 1 - Description of Plan

The following description of Riverview Center for Growth 403(b) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a 403(b) defined contribution plan established by Mental Health for Children, Inc. dba Riverview Center for Growth (the Plan Sponsor and the Organization), for the benefit of eligible employees of the Organization and any adopting participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as well as certain provisions of the federal income tax laws.

All employees of the Organization and any participating affiliates are subject to the following eligibility requirements, as defined in accordance with the universal availability standards:

- Age: None
- Service: 0 months
- Status Exclusions:
 - a. Employees who normally work less than 20 hours per week
 - b. Substitute employees

Upon satisfying the eligibility requirements, employees may participate in the Plan immediately upon eligibility.

Contributions

The Plan is funded through employee elective deferrals and organization contributions. Each year, participants may elect to contribute a portion of their compensation, subject to certain maximum limitations imposed by Section 402(g) of the IRC. At the discretion of the Plan Administrator, participants may be permitted to deposit or "rollover" into the plan distributions they have received from other plans and certain Individual Retirement Accounts (IRAs). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The following contribution types are allowed by the Plan:

- Elective deferrals
- Rollover contributions
- Employer matching contributions
- Employer discretionary non-elective contributions

The Organization makes a stated matching contribution of 100% of the participants' elective deferral up to 3% of compensation for contributing participants. Additionally, the Organization may make discretionary non-elective contributions which will be allocated in accordance with the collective bargaining agreement. Participants must be employed on the last day of the plan year and have earned 1,000 hours of service in a 12-month period to be eligible to receive matching and discretionary non-elective contributions.

The discretionary non-elective contribution ranges between two and seven percent of an eligible participant's compensation based upon his or her length of service in accordance with the collective bargaining agreement as follows:

- 1-2 years 2% of the salary paid to the participant by the employer
- 3-4 years 3% of the salary paid to the participant by the employer
- 4-5 years 4% of the salary paid to the participant by the employer
- 5-6 years 5% of the salary paid to the participant by the employer
- 6-7 years 6% of the salary paid to the participant by the employer
- 7+ years 7% of the salary paid to the participant by the employer

For the year ended December 31, 2024, the Organization made total employer contributions of \$256,369.

Participant Accounts

Each participant's account is credited with the participant's contribution, allocation of the Organization's contributions, and plan earnings or losses and charged with an allocation of administrative expenses that are paid by the Plan. Allocations may be charged based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately 100% vested in their elective deferrals including catch-up contributions, rollover contributions from other plans, and actual earnings thereon. Effective June 2023, the method for crediting vesting service for organization matching and non-elective contributions is based on vesting periods of service. Prior to this, participants are always fully vested in their accounts. Participants are credited with a period of service for 1,000 hours earned for each plan year. If participants are employed on or after their normal retirement age or if they terminate employment on account of death or disability, they are 100% vested in their organization matching and non-elective contributions.

Forfeited Accounts

Forfeitures represent unvested portions of terminated participants' accounts. The Plan allows forfeitures of non-vested organization contributions to be used as follows:

- Supplement organization contributions
- Reallocated as organization contributions
- Reduce employer contributions

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,989 and \$4, respectively. During the year ended December 31, 2024, no forfeitures were used.

Investment Options

Upon enrollment in the Plan, a participant may direct the contributions made to the Plan, for or on behalf of the participant, to any one or more of the investment funds determined at the discretion of the Plan Administrator and Plan Sponsor and in such multiples as the participant prescribes. A participant may change his or her investment direction with respect to future contributions or redirect the investment of his or her account balances.

In prior years, the Organization had selected Nationwide Life and Annuity Insurance Company (Nationwide Annuity) and The Standard Insurance Company (The Standard) to provide the investment options available under the Plan. Nationwide Annuity provided fixed and variable annuity contracts while The Standard only provided fixed annuity contracts. The variable contracts contained various investment options from which the participants were able to choose. Each participant instructed the Organization as to whether they wanted their contributions invested with Nationwide Annuity or The Standard. If a participant selected Nationwide Annuity, the participant further instructed Nationwide Annuity as to which investment options available under the annuity contract their contributions were to be invested in.

In 2016, the Organization added a custodial account investment option through Nationwide Financial Services, Inc. (Nationwide Custodial). Under this option, a participant is able to select investments from a menu of registered investment companies made available by Nationwide Custodial. Concurrent with the addition of the Nationwide Custodial account option, participants are no longer able to invest in new annuity contracts with Nationwide Annuity or The Standard. Any participant with a previous annuity contract is still able to direct contributions to those contracts. All other contributions are directed to the new Nationwide Custodial account option. During 2024, all remaining investments with Nationwide Annuity, were either distributed or transferred to the Nationwide Custodial option. As of December 31, 2024, there are no remaining investments with Nationwide Annuity and no future investments will be allowed in the Nationwide Annuity option.

The Plan maintains no investments which are not directed by plan participant.

Notes Receivable from Participants

Generally, participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 (reduced by certain participant notes outstanding at the time the new note is taken or anytime within the 12 months prior to the date of the new note) or 50% of their vested account balance, subject to certain restrictions. Loan terms may not be greater than five years, or such a longer period as the Plan Administrator deems appropriate in the case of a note used for the purchase of a primary residence.

No participant may have more than one note concurrently. These note transactions are treated as a transfer between the investment fund and the participant note fund and are reflected as participant notes receivable on the statements of net assets available for benefits. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan Administrator.

Principal and interest are paid ratably through payroll deductions. The outstanding amount of plan loans as of December 31, 2024 and 2023, were \$101,756 and \$61,500, respectively. The interest rates on outstanding loans ranged from 5.25% to 10.50% at December 31, 2024 and mature through December 2029.

Participants with annuity contracts may borrow from Nationwide Annuity or The Standard, subject to the same loan limits applicable to the Nationwide Custodial loans. These loans and repayments are made outside of the Plan, between the participant and Nationwide Annuity or The Standard, and are not reflected in the Plan's financial statements. These loans use the participant's plan account balance as collateral. Amounts used as collateral for the participant notes receivable are invested in the fixed annuity investment option. The collateral must be equal to or exceed 100% of the note receivable at the time the note originates. The notes bear interest at a rate as determined in the controlling contract. The fixed annuity investment option included \$0 and \$3,858 held as collateral for participant notes receivable at December 31, 2024 and 2023, respectively.

Benefits Paid to Participants

Upon termination of service, disability, or retirement, a participant is entitled to receive a distribution equal to the value of the participant's vested interest in his or her account. Distribution of a deceased participant's account will be made to the designated beneficiary.

The following types of distributions are also allowed by the Plan:

- Hardship
- In service
- Involuntary cash-outs

Termination of the Plan

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, no further contributions will be made to the Plan and all amounts credited to the participant's account will become 100% vested. The Organization will direct the distribution of the participant's account in a manner permitted by the Plan as soon as practicable.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for any fixed annuity contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments, including realized gains and losses on sales during the year and current changes in unrealized appreciation (depreciation) in the market value of investments held at year end, is presented in the statement of changes in net assets available for benefits.

Contributions

Contributions from plan participants and employer contributions, if any, are recorded in the year in which the participant contributions are withheld from compensation. Employer non-elective contributions are recorded in the year in which they are allocated.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Plan Expenses

The Plan's expenses are paid by either the Plan or the Organization, as provided by the plan document. Expenses paid directly by the Organization are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies

Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end based on quoted market prices.

Variable Annuity Contracts

Units held in the investments underlying the variable annuities are valued using the NAV practical expedient of the investments as reported by the account managers. The NAV practical expedient is based on the fair value of the underlying investments assets owned, minus liabilities, and then divided by the number of units outstanding. The NAV practical expedient of these investments is calculated based on a compilation of primarily observable market information. These investments are redeemable daily at NAV by participants and had no commitment provisions.

Note 5 - Annuity Contracts with Insurance Companies

The Plan has annuity contracts with Nationwide providing benefits to eligible employees. The Plan also had annuity contracts with The Standard which provided benefits to eligible employees. Nationwide Annuity provides both a fixed annuity contract option and a variable annuity contract option. The Standard provided only fixed annuity contracts. These contracts are credited with participant elective deferral, rollover, and employer contributions, and investment income. They are charged for investment losses, expenses, and benefits paid to plan participants.

Each participant has an individual contract, and each contract is subject to contingent deferred sales charges if the contract is surrendered within the period defined in the investment contract. Contracts with Nationwide Annuity are subject to a deferral sales charge that decreases from 7% to 0%, ratably, over seven years. The deferred sales charges on Nationwide Annuity contracts apply to each new contract purchase and fund deposit in the Plan separately. Contracts with The Standard were subject to a deferred sales charge starting at 9% in year one of the contract purchase, decreasing to 0% over nine years. The deferred sales charge will be based upon the original contract purchase date. Both Nationwide Annuity and The Standard will waive deferred sale charges if contract liquidation is a result of certain circumstances as defined in the investment contracts.

The fixed annuity contracts contain various minimum guaranteed crediting interest rates which range from 1% to 3%. The interest crediting rate for Nationwide Annuity and The Standard will remain in effect for a period of not less than 12 months and remain at such rates unless changed.

Note 6 - Related Party Transactions and Transactions with Parties-in-Interest

The Plan invests in fixed annuity contracts managed by Nationwide Annuity and The Standard. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA. Loans issued directly from funds owned by Nationwide Annuity or The Standard that are collateralized by participant accounts also represent exempt transactions with parties-in-interest.

Nationwide Custodial is the custodian of the Plan's investments in registered investment companies. Affiliates of Nationwide Custodial also manage some of the investment funds made available to participants. As manager, these affiliates receive fees from the managed accounts, which affect investment performance. Participants have access to fund information which includes these expenses. In addition, Nationwide Custodial charges fees directly to participants' accounts for certain recordkeeping expenses. Total direct fees paid by the Plan to Nationwide were \$17,674 for the year ended December 31, 2024.

The Plan paid fees to Iron Co FID Comprehensive, an affiliate of Nationwide, for investment advisory services. The total fees paid by the Plan to Iron Co FID Comprehensive were \$1,908 for the year ended December 31, 2024.

LPL Financial acts as the Plan's investment advisor and received both direct and indirect compensation from the Plan for the investment advisory services. The indirect compensation is not reflected as an expense in the financial statements. For the year ended December 31, 2024, LPL Financial received \$24,802 as direct compensation for investment advisory services.

Note 7 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is, at least, reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 8 - Tax Status

The Plan Sponsor adopted a plan which received a favorable opinion letter, issued to the document provider from the Internal Revenue Service dated March 31, 2017, which states that the Plan is designed in accordance with Section 403(b) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audit for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

Note 9 - Delinquent Participant Contributions

A reportable prohibited transaction is a transaction between the Plan and a party-in-interest for which the DOL has not issued an exemption. A late remittance of amounts withheld from participant paychecks is one such transaction. As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions and loan repayments to the Plan from its general assets as soon as practicable. During the years ended December 31, 2024 and 2023, the Organization was late in remitting \$14,618 and \$3,055, respectively, of amounts withheld from participants' paychecks. The Organization is in the process of correcting this error, including the restoration of any income a participant may have foregone as a result of the late deposit of that participants' contributions.
