Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of 403(b) Thrift Plan of Children's Home of York (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Opinion (Continued)

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

NOTES TO FINANCIAL STATEMENTS

Note 1. Plan Description

The following description of the 403(b) Thrift Plan of Children's Home of York (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, established by Children's Home of York (the Organization), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility: All permissible employees of the Organization are eligible to enroll on their date of hire and enter on the first of the month after their date of hire participate in employee contributions. Participants aged 21 or older are eligible to receive employer contributions when they have completed 1,000 hours of service during the 12-month period following their date of hire. Participants are eligible to receive employer base contributions, whether or not they are making salary contributions, provided they have completed 1,000 hours of service during that plan year.

Contributions: Participants may contribute up to 100% of pretax or post-tax (Roth) annual compensation as defined by the plan document, up to the maximum annual limitations imposed by the Internal Revenue Code (IRC). Participants age 50 or over may elect to defer additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (Rollovers).

The Organization does make base contributions. See the eligibility requirements above for the employer contribution. In 2024, the Organization made employer contributions equal to 5% of the employee's annual salary, even for those individuals not contributing to the Plan. Employer base contributions for the year ended December 31, 2024 was \$149,775, net of forfeitures of \$12,048. The Organization's contributions for any participant are subject to certain IRC limitations.

Participant Investment Options: Participants direct the investment of contributions into various investment options offered by the Plan. Participants may change their investment allocation at any time.

Participant Accounts: Each participant's account is credited with the participant's contributions, employer contributions and an allocation of Plan earnings, net of administrative expenses. The Plan's earnings and administrative expenses are allocated according to the participant's relative account balance or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Plan Loans: Participants are permitted to obtain loans directly from Mutual of America Life Insurance Company (MOA). Plan loans are issued directly from funds owned by MOA and loan proceeds are not removed from a participant's account balance. However, a portion of a participant's MOA account balance is reserved, or held in collateral, to cover 120% of the outstanding loan amount for the period of time the loan is outstanding. In general, the amount of the loan may not exceed the lesser of \$50,000 or 50% of the participants account balance. The minimum loan amount is \$1,000. The loans bear a rate of interest as determined in the contract and may be fixed or variable.

Note 1. Plan Description (Continued)

Plan Loans (Continued): At December 31, 2024 and 2023, participants had outstanding loan balances of \$3,169 and -\$0- due to Mutual of America Life Insurance Company (MOA). These amounts are reported within participant accounts and are held in reserve in the interest accumulation account of MOA on the Statements of Net Assets Available for Plan Benefits.

Vesting: Participants are vested immediately in their contributions and actual earnings on these contributions. Vesting in the Company's contribution is based on years of continuous service. Participants are fully vested at five years of service according to the following schedule:

Years of Vesting Service	
Less than two years	0%
2 years	20%
3 years	40%
4 years	60%
5 years or more	100%

Payment of Benefits: On termination of service due to death, disability, retirement, or other reasons, a participant, or his or her beneficiary, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Distributions of account balances of less than \$1,000 that meet the provisions for a mandatory distribution will automatically be paid to participants in a cash distribution if the participant does not elect the distribution method. Hardship and ins-service distributions (for those age 59½ and older) are permitted if certain criteria are met.

Participants who are age 59½ or older, or have terminated employment at age 55 or later, can also elect to receive regularly scheduled withdrawals from their account. Under this form of benefit, eligible participants can choose to receive regular monthly payments of \$100 or more.

Forfeitures: Forfeitures represent accounts with unvested Company contributions that arise from the termination of participants with less than fully vested benefits under the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled -\$0- for both years. Forfeitures of \$12,048 were used to reduce employer contributions during the year ended December 31, 2024.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to recordkeeping, advisory services, and the benefit and loan payments paid to participants, are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Note 2. Summary of Significant Accounting Policies

Accounting Method: The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Reclassification: Certain amounts in the 2023 financial statements have been reclassified to conform to 2024 presentations.

Subsequent Events: In preparing these financial statements, the Plan Sponsor has evaluated events and transactions for potential recognition or disclosure through October 13, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at December 31, 2024 and 2023, Net appreciation in fair value of investments and interest income for the year ended December 31, 2024, was obtained by management and agreed to information certified as complete and accurate by Mutual of America Life Insurance Company, Custodian of the Plan.

Note 4. Investments and Fair Value Measurements

The Plan measures on a recurring basis its investments at fair value in accordance with Financial Accounting Standards Board (FASB) codification *Fair Value Measurement*, which provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that are accessible to the Plan. These generally provide the most reliable evidence and are used to measure fair value whenever available.

- Level 2 Inputs to the valuation methodology include significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted prices for similar assets in active markets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The inputs or methodology used for valuing investments are not an indication of the risk associated with investing in those securities.

The following is a description of valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts: Units of participation in pooled separate accounts are reported at the accumulated value of units held by the Plan at year-end as reported to the Plan by Mutual of America Life Insurance Company (MOA). The accumulated unit value is determined daily by MOA and is based on the net asset value of the underlying mutual fund and the contract's separate account charges. Although the fair values of the underlying fund shares are derived based on observable market data, the accumulated unit value is not a publicly quoted price in an active market but is computed in accordance with investment company measurement principles.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain investments or financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Insurance Company General Account

The Plan has entered into a group annuity Contract with Mutual of America Life Insurance Company which provides for investments in various pooled separate accounts and an interest accumulation account.

Pooled separate accounts are credited with earnings on underlying investments and charged for participant withdrawals and certain administrative expenses. Pooled separate accounts consist of various fund investment options covering multiple asset classes.

The Plan has a deposit contract with Mutual of America. Under the terms of the contract, a portion of the Plan assets are held in the General Account, which is made up of mainly fixed maturity securities. The General Account is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Mutual of America. Mutual of America is contractually obligated to repay the principal and specified interest rate that is guaranteed to the Plan. The contract values of the investment contract at December 31, 2024 and 2023 were \$474,331 and \$473,950, respectively. The effective annual yield and crediting interest rate for the years ended December 31, 2024 and 2023 was 2.85% and 3.0%, respectively.

Because the investment contracts are considered to be fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value, as reported to the Plan by the custodian, represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. If the contract is surrendered completely, a market value adjustment may be applied to the balance. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Note 5. Insurance Company General Account (Continued)

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Note 6. Related Party and Party-in-Interest Transactions

Certain Plan investments consist of units of pooled separate accounts and funds in an interest accumulation account within an insurance company general account managed by Mutual of America Life Insurance Company, the Custodian of the plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

The Custodian issues loans to participants which are secured by participants' account balances and are contractual agreements between the Custodian and the plan participants (see 'Plan Loans' in Note 1). These transactions qualify as party-in-interest transactions.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would receive the amount in their account at 100% vesting.

NOTES TO FINANCIAL STATEMENTS

Note 8. Tax Status

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (IRC). Plan management believes the plan is currently designed and operating in accordance with the applicable requirements of the IRC. The Plan is considered qualified and the related group annuity contract is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.
