### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audits***

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

***Other Matters - Supplemental Schedule Required by ERISA***

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's *Rules and Regulations for Reporting and Disclosure* under ERISA.

**(1) Description of the Plan**

The following description of the Sundown M Ranch Employees Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***General***

The Plan is a money purchase plan, established January 1, 1979. The Plan has been amended and restated throughout the years to comply with tax legislation and was most recently amended January 1, 2022. The Plan covers substantially all employees of Sundown M Ranch (Plan Sponsor, the Organization) except for employees covered by a collective bargaining agreement.

The Plan is administered by the Plan Administrator who receives assistance from a retirement plan administration organization, which processes and maintains records of participant account activity.

All contributions made to the Plan are held in a trust fund. The Plan Administrator is responsible for the safekeeping of the trust fund. The trust fund established by the Plan Administrator is the funding medium used for the accumulation of assets from which benefits are distributed.

***Eligibility***

Employees are eligible to participate in the Plan if they are age twenty-one or over and have met the 1,000 hours of service or more in a 12-month period, as defined in the Plan's provisions. Employees must also be employed on the last day of the plan year to be eligible for employer contributions. Employees enter the Plan on the first day of the first month and seventh month of the Plan year.

***Contributions***

The Plan is subject to minimum funding requirements per ERISA. Each Plan year the Organization contributes 5% of a participant's eligible compensation. All funding requirements have been met. Participant salary deferral contributions are not permitted in the Plan.

Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

***Participant Accounts***

Individual accounts are maintained for each Plan participant. Each participant's account is credited with an allocation of the Organization's contribution and Plan earnings and charged with an allocation of asset management fees. Allocations are based on participant earnings and account balances, as defined in the Plan provisions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Vesting in the Plan Sponsor's contribution portion of the participants' account plus actual earnings thereon occurs at a rate of 20% annually beginning after the second year of credited service. A participant is 100% vested after six years of credited service.

***Payment of Benefits***

Participants are eligible to receive 100% of their vested account balance upon death, disability, break in service, or attaining normal retirement age which is the later of sixty-five years or the fifth anniversary of the participant's participation in the Plan. Benefits are either rolled over, paid in a lump-sum, or paid in installments to satisfy required minimum distribution rules.

If a participant terminates employment and the participant's account balance does not exceed \$1,000, the balance will be distributed in a single lump sum. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Administrator will transfer the balance into an individual retirement account in the participant's name. The Plan allows for in-service distributions from a participant's rollover contribution account when a participant reaches age sixty-two. The participant is limited to only two in-service distributions a year.

***Investment Options***

Participants direct the investment of Plan Sponsor contributions into various investment options offered by the Plan.

***Forfeited Accounts***

Forfeitures which are non-vested portions of participants' accounts at point of termination from the Plan may be used to pay Plan expenses or reduce employer contributions. There were \$11,547 and \$4,462 of new forfeitures for the years ended December 31, 2024 and 2023, respectively. No forfeitures were used during 2024. \$16,024 of forfeitures were used in 2023 to fund the 2022 employer contribution. Forfeitures unused including interest earned as of December 31, 2024 and 2023, were \$16,945 and \$4,307, respectively.

***Administrative Expenses***

The Plan pays all asset management fees. All other administrative expenses are paid by the Plan Sponsor. The Plan expenses are allocated based on participant account balances and those participants who elect to withdraw amounts from the Plan.

**(2) Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

***Concentration of Credit Risk***

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of investments in mutual funds and money market funds. Concentrations of credit are limited, as the Plan maintains an investment portfolio that is diversified between various publicly traded investments. The Plan Administrator believes there is no significant risk with respect to these accounts.

***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The fair value of the investments is based on quoted market prices, if available. Otherwise, the fair values are determined by the issuers based on other investments with similar terms.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

***Fair Value***

Financial Accounting Standards Board Accounting Standard Codification 820, *Fair Value Measurements and Disclosures*, provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Assets and liabilities are classified based on the lowest level of input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

- Level 1    Inputs based upon quoted prices in active markets for identical assets.
- Level 2    Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly.
- Level 3    Inputs that are unobserved for the asset.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used during 2024 and 2023.

*Mutual Funds and Money Market Funds* – Valued at the daily closing prices reported on the exchange or listed market. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market funds are deemed to be actively traded and are considered Level 1 investments.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

***Payments of Benefits***

Benefits paid to participants are recorded when paid. As of December 31, 2024, there was \$3,131 of benefits requested but not yet paid. There were no benefits requested but not yet paid at December 31, 2023.

**(3) Investments**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's *Rules and Regulations for Reporting and Disclosure* under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's auditors to not perform any auditing procedures with respect to investments that were certified by Matrix Trust Company, the custodian of the Plan, for the years ended December 31, 2024 and 2023, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

**(4) Party-in-Interest Transactions**

Matrix Trust Company is the custodian of the Plan. Purpose Financial Advisors, LLC offers investment advisory services to the Plan, and Randall & Hurley, Inc. is the record keeper and third-party administrator (TPA). Therefore, transactions with these service providers qualify as party-in-interest transactions. Total fees paid by the Plan for administration and investment advisory services amounted to \$2,880 and \$3,190 for the years ended December 31, 2024 and 2023, respectively. The Plan Sponsor also paid certain administrative expenses of the Plan. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**(5) Plan Termination**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts and all assets would be held, administered, and distributed pursuant to the Plan's terms and conditions.

**(6) Tax Status**

The Internal Revenue Service determined and informed Matrix Trust Company, holder of the prototype profit sharing plan, by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRS and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The Plan's income tax returns are subject to review and examination by federal and state authorities. The Plan is not aware of any activities that would jeopardize its tax-exempt status, nor is it aware of any activities that are subject to tax on unrelated business income or excise or other taxes. Plan amendments have had no impact on the Plan's tax status.

**(7) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**(8) Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued.
