## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following brief description of the Anthony L. Jordan Health Center, Inc. Pre-Tax Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan available to employees of Anthony L. Jordan Health Corporation, Inc. (the Company) who meet certain eligibility requirements. The Company is responsible for general administration of the Plan. Hand Benefits & Trust Company (HBTC) is the trustee and custodian of the Plan's assets. Benefit Plans Administrative Services, Inc. (BPAS) is the Plan's third-party administrator and provides record keeping services for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

Employees of the Company are eligible to contribute to the Plan immediately upon hire. Employees who have worked one year, at least 1,000 hours of service, and are 21 years of age, are eligible to receive employer contributions to the Plan. Employees covered by a collective bargaining agreement are not eligible for employer contributions.

#### **Contributions**

Active participants may make voluntary contributions in the form of salary reductions and any applicable rollovers from other qualified plans, subject to certain limitations of the Plan and the Internal Revenue Code (IRC) under Section 403(b). Eligible participants, who attain the age of 50 or have 15 years of service before the end of the Plan year, are eligible to make long-term service catch-up contributions, subject to certain limitations of the IRC. Participants have the option to change their deferral percentage or discontinue deferrals at any time.

New employees are automatically enrolled into the Plan with a contribution of 1%, unless elected otherwise within 60 days of hire.

The Company provides a safe harbor contribution on behalf of eligible employees, which is calculated as 3% of the participant's compensation for the Plan year.

The Company may make discretionary matching contributions on behalf of eligible employees, at 100% of the employee's elected deferral, less any catch-up contribution, up to 3% of the employee's annual compensation. Discretionary matching contributions for the year are approved and made to the Plan subsequent to year-end. Discretionary amounts remitted to the Plan were approximately \$230,926 and \$220,907 during the years ended December 31, 2024 and 2023.

Additionally, the Company can make a discretionary non-matching contribution which is allocated equally among all eligible participants. Discretionary contributions for the year are made to the Plan subsequent to year-end. There was no discretionary non-matching contribution made for the years ended December 31, 2024 and 2023.

## 1. DESCRIPTION OF PLAN (Continued)

### **Contributions (Continued)**

During 2024, the Plan recorded a receivable for amounts owed to the Plan for lost investment earnings for the years 2009-2024, for employees who were previously deemed ineligible in the plan but should have been eligible to make participant contributions under the universal eligibility rules. The Plan has since corrected the plan provisions to provide for universal eligibility. The amount owed to the Plan was approximately \$630,000 at December 31, 2024 and is included in employer receivables and employer contributions in the accompanying statements of net assets available for benefits and changes in net assets available for benefits, respectively.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution, the Plan's earnings or losses on all contributions, and administrative expenses. Allocations of earnings or losses and administrative expenses are based on participant account balances according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account balance and subject to the vesting rules where applicable.

Participants select the investments in which their contributions will be allocated by the Plan. If a participant does not direct the contributions, they are invested in a target date retirement fund where the allocation strategy is consistent with the participant's date of retirement.

### **Vesting**

Participants are immediately vested in their contributions to the Plan, which includes safe harbor contributions and actual earnings thereon. Company discretionary matching contributions vest 20% per year beginning after two years of service. Participants are fully vested after six years of credited service or upon normal retirement age.

### **Forfeitures**

Forfeitures of non-vested account balances are netted against the Company's discretionary contribution and are allocated to participants eligible to share in such contributions. Forfeitures reduced the Company's contributions by approximately \$23,400 and \$8,900 for the years ended December 31, 2024 and 2023, respectively. Unapplied, forfeited, and non-vested accounts were approximately \$9,700 and \$23,100 at December 31, 2024 and 2023, respectively.

### **Notes Receivable From Participants**

Participants may borrow up to the lesser of 50% of their vested account balance or \$50,000. Loans in the amount of \$1,000 or less are not permitted. Loans are payable over a period not to exceed five years, except when used to acquire a principal residence, in which case loans may be paid over a longer repayment period. The plan administrator determines interest rates at the time of the loan request by reviewing interest rates charged for similar types of loans by other lenders.

### **Benefit Payments**

Upon retirement or termination of service, participants may elect to receive a lump-sum distribution of their vested account balance or elect a rollover to another qualified retirement plan or an Individual Retirement Account. Additionally, payments may be made in installments, but only for purposes of minimum required distributions, over a period of not more than the participant's assumed life expectancy.

### **Hardship Withdrawals**

Prior to age 59  $\frac{1}{2}$ , a participant may withdraw only their participant plan contributions for reasons of hardship. All hardship withdrawals must comply with the rules relating to hardships, which are uniformly applicable to all participants.

## 1. DESCRIPTION OF PLAN (Continued)

### **Administrative Expenses**

Substantially all administrative expenses associated with the Plan are paid by participants. Management fees and operating expenses charged to the Plan for investments in registered investment companies are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair value of investments.

### **Plan Termination**

Although the Company has not expressed any intent to do so, it has the right to terminate the Plan at any time subject to the provisions of the ERISA. In the event of Plan termination or complete discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants would become fully vested and nonforfeitable. In the event of a partial termination, only those who are affected by such partial termination shall be fully vested. All distributions would be made in accordance with any applicable requirements of ERISA and the IRC.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted (GAAP) in the United States of America.

### **Investment Valuation and Income Recognition**

The Plan's investments in mutual funds and a stable value fund are reported at fair value as reported by the Trustee. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### **Risks and Uncertainties**

Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the financial statements.

### **Fair Value Measurement**

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures* provides a framework for measuring fair value. The Plan uses various valuation techniques in determining fair value. GAAP establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's estimate about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value Measurement (Continued)

The fair value hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations are based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations are based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations are based on inputs that are unobservable and significant to the overall fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value.

*Mutual funds:* Valued at fair value based on quoted market prices in active markets.

*Stable Value Fund:* The fund is valued at the net asset value (NAV) as a practical expedient per unit by dividing the total assets of the fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the fund and included in the determination of unit values. These contracts contain certain restrictions on the Plan participants' ability to cash out their contracts and thus are not fully-benefit responsive contracts.

The Plan's investment in a stable value fund is comprised of guaranteed insurance contracts established between the Plan's participants and the Plan's custodian. These contracts guarantee the participants' principal and a minimum interest rate. In addition, participants have the opportunity to earn amounts in excess of the guaranteed rate. The contract returns are backed by Prudential Financial, Inc. which invests in a broadly diversified portfolio of private placement bonds, commercial mortgages, and publicly traded securities. Since the agreement or funding agency has the ability to restrict certain transfers and withdrawals, the contract is not considered fully-benefit responsive.

Redemptions are generally restricted to processing on a valuation date at the NAV per unit computed on that date. Trust units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the trust. The fund does not have any unfunded commitments.

There were no changes in the valuation methodologies used during 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Fair Value Measurement (Continued)

The availability of observable inputs can vary and is affected by a wide variety of factors. To the extent that valuation is based on models or inputs that are less observable or unobservable in the market, the determination of fair value requires more judgment. Accordingly, the degree of judgment exercised in determining fair value is greatest for instruments categorized in Level 3. In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes the level in the fair value hierarchy within which the fair value measurement in its entirety falls is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes are reclassified as distributions based upon terms of the plan document.

### Benefit Payments

Benefit payments to participants are recorded when paid.

### Estimates

The preparation of financial statements in accordance with GAAP requires the plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from those estimates.

The Internal Revenue Service (IRS) has determined and informed the Company by letter dated August 30, 2001 for its Prototype Non-Standardized Safe Harbor Profit Sharing Plan that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving that determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### 7. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

#### 8. SUBSEQUENT EVENTS
