We have performed an audit of the financial statements of the Selking International 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Decatur Truck & Tractor, Inc. (the “Company”, the “Employer”), Selking International 401(k) Plan (the “Plan”) is provided for general information purposes only. More complete information regarding the Plan’s provisions may be found in the Plan document and amendments.

***General***

The Plan, which was effective January 1, 2007 and amended from time to time thereafter, is a defined contribution safe harbor plan available to all eligible full and part-time employees of Decatur Truck & Tractor, Inc. (the “Company”), under the provision of Section 401(a) of the Internal Revenue Code (“IRC”), which includes a qualified cash or deferred arrangement as described in section 401(k) of the IRC, for the benefit of eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The plan covers employees who 18 years of age and have completed one month of service. The plan entry date is the first of the month following eligibility satisfaction.

***Plan Administration***

The Plan is administered by John Hancock Retirement Plan Services LLC and John Hancock Trust Company (the Plan Administrator), which was appointed by the Board of Directors of the Company. John Hancock is also the Plan’s Custodian, being responsible for the custody and management of the Plan’s assets.

***Contributions***

Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan, subject to certain limitations established by the Internal Revenue Code. As defined in the Plan, Roth deferrals are permitted, and participants may elect both pre-tax and Roth deferrals. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Plan allows participants who have attained the age of 50 by the end of the Plan year to make catch-up contributions in accordance with the provisions of Internal Revenue Code Section 414(v). Participants direct these contributions into various investment options offered by the Plan.

The employer utilizes a safe harbor matching contribution to match employees’ contributions at 100% of the employees first 3% of salary deferrals and 50% of the next 2% percent of salary deferrals, for a maximum match of 4% of employee’s eligible compensation.

***Participant Accounts***

Each participant's account is credited with the participant’s contributions and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with withdrawals and an allocation of plan losses and administrative expenses. Allocations are based on participant earnings or account balance, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

***Vesting***

Participants are immediately vested in their contributions and rollovers plus actual earnings thereon. Safe harbor non-elective contributions, plus actual earnings thereon, vest 100% immediately. Discretionary nonelective profit sharing contributions, plus actual earnings thereon vest at 100% after six years. Employer matching contributions, plus actual earnings thereon vest as follows:

***Investment Options***

Participants may direct the investment of all contributions into various investment options offered by the Plan in 1% increments. Participants may change their investment options at any time. The Plan may change and provide additional investment options at any point.

***Payment of Benefits***

On termination of service without the participant's consent, a participant with a vested account balance of \$999 or less will receive a lump-sum distribution equal to the vested value of their account as soon as administratively feasible following the participant's employment termination date. An account balance of \$1,000 to \$4,999 will receive a direct rollover to an individual retirement plan designated by the Plan Administrator equal to the vested value of their account as soon as administratively feasible following the participant's employment termination date. A participant with a vested account balance of \$5,000 or more will receive a distribution as soon as administratively feasible following the first date that occurs on or after both (1) the participant's employment termination date and (2) the date on which the participant consents to the distribution.

***Notes Receivable – Participant Loans***

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. A participant may not have more than two loans outstanding at any time and no new loans may be made to a participant when in default on any payment required to be made on a previous loan. The notes receivable, which are secured by the balance in the participant's account, generally bear interest at Federal Reserve Bank Prime rate plus 1%, as defined. Interest rates for new loans are determined on the date of the loan. Interest rates were between 4.25% and 9.50% as of December 31, 2024. Maturities were between February 25, 2025, and November 16, 2029, as of December 31, 2024. Principal and interest are paid ratably through bi-weekly payroll deductions. All loans are repaid within five years.

***Forfeited Accounts***

Forfeitures of terminated non-vested amounts are eligible to reduce employer discretionary, employer match contributions and are eligible to pay for Plan expenses. During 2024, no forfeitures were used to offset employer contributions or pay for plan expenses. As of December 31, 2024 and 2023, there was \$6,033 and \$693, respectively, of non-vested forfeitures to be used to pay plan expenses or to reduce future employer contributions.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

***Notes Receivable – Participant Loans***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make scheduled repayments and the Plan administrator deems the participant note receivable to be in default, the outstanding loan including accrued interest will become taxable and treated as a deemed distribution.

**NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

***Contributions***

Participant contributions are recognized when the participant contributions are withheld from the participant's earnings. Contributions from the Employer are recorded in the period in which the related participant contributions are due. Discretionary employer contributions are recognized when declared by the Employer. No allowance for credit losses had been recorded as of December 31, 2024 and 2023.

***Payments of Benefits***

Benefits are recorded when paid.

***Administrative and Investment Management Expenses***

The Company provides certain administrative and accounting services to the Plan at no cost. Most administrative expenses are paid directly by the Plan sponsor and include audit fees and legal fees. Administrative expenses incurred by the Plan include investment advisory fees, custodian fees, recordkeeping fees and loan fees charged directly to the participants' accounts and are allocated on a pro-rata basis based upon participant account balance, as provided by the Plan's provisions.

***Subsequent Events***

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

ASC topic *Fair Value Measurements and Disclosures* provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 3 – FAIR VALUE MEASUREMENTS (CONTINUED)**

*Level 3* - Inputs to valuation methodology are unobservable and significant to the fair value measurement. Valuation is generated from model-based techniques that use significant assumptions not observable in the market. These unobservable assumptions would reflect our own estimates of assumptions that market participants would use in pricing the asset or liability. Such valuation techniques include the use of option pricing models, discounted cash flow models and similar techniques.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

*Mutual Funds*: The fair value of mutual fund investments are determined by obtaining quoted net asset values of the shares on nationally recognized securities exchanges (Level 1 inputs).

**NOTE 4 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than the established floor rate. The crediting rate is reviewed on an annual basis for resetting. The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

**NOTE 5 – TAX STATUS**

The Plan sponsor adopted the restated version of a non-standardized Prototype Plan Document. The Internal Revenue Service has determined and informed the prototype plan sponsor, by a letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code (the "IRC"). Although the Plan has been amended from the original prototype document, Plan management believes the Plan is designed and is currently being operated in accordance with the applicable requirements of the IRC.

**NOTE 5 – TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Parties in interest are defined under the Department of Labor (DOL) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative and fiduciary functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. John Hancock Trust Company LLC provides administrative services and custodian services and Lincoln Investments/Shepherd Financial provides investment advisory services for the Plan. Fees paid by the Plan for recordkeeping, custodian and investment advisory services qualify as party-in-interest transactions. During 2024, the Plan paid \$48,922 for contract administrative fees and \$4,091 in investment advisory and management fees to Lincoln Investments/Shepherd Financial for these services. Certain professional fees of the Plan were paid on behalf of the Plan by the Company. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 – PLAN TERMINATION AND AMENDMENT**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become fully vested in their account balances.

The Plan was amended effective July 1, 2023, to account for an acquisition by the Plan Sponsor. In this amendment, employees of the acquired company were allowed to transfer their period of service for eligibility purposes and years of service for vesting considerations to the Plan.

Effective January 1, 2024, the Plan was amended to adopt an automatic enrollment provision, automatic deferral provision, and automatic deferral increase provision. Participants will automatically be enrolled in the Plan at a 1% deferral to a target date retirement fund, unless otherwise elected. Participants will also have their deferral percentages automatically increased by 1% on the first of each Plan year, to a maximum of 15% of eligible compensation, unless otherwise elected.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
