Scope and Nature of the ERISA 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of DM Gary Holding Company 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 1. Description of the Plan

The following description of the DM Gary Holding Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of DM Gary Holding Company and related entities (the Company). The Plan excludes union and leased employees. Employees are eligible to participate in the Plan after completing three months of service. Entry date is the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974. The Plan administrator is responsible for oversight of the Plan, including reviewing the appropriateness of the Plan's investment offerings and monitoring investment performance.

Contributions

Participants may elect to have the Company contribute (pre-tax or Roth) up to 100% of their eligible compensation as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan also allows Roth In-Plan transfers. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company has elected to make safe harbor matching contributions equal to 100% of the first 6% of a participant's eligible compensation, contributed to the Plan as deferral contributions. Prior to January 1, 2022, the Plan also allowed for discretionary employer matching and profit sharing contributions each year. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contribution, the discretionary employer matching and profit sharing contribution, and allocations of plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Company safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contributions portions of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service. A participant becomes fully vested, regardless of the years of service, upon attainment of retirement age or due to total and permanent disability or death.

Notes Receivable from Participants

Participants may borrow, under certain circumstances, from their account a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is lower. The loans are secured by the balance in the participant's account and bear interest at 6.50% to 9.50%, which is determined at the time the loan is established by the prime interest rate plus 1%. Principal and interest is paid ratably through payroll deductions.

1. Description of the Plan (continued)

Payment of Benefits

The Plan provides for payment of benefits upon death, disability, retirement, or termination of employment. The participant may also elect to receive a distribution upon reaching age 59½. A separated participant with a vested balance exceeding \$5,000 may elect to defer receipt of their distribution until a later date. The Plan automatically distributes accounts less than \$5,000 upon participant separation. Benefits may be paid by either a lump sum payment, partial withdrawals, or installments for those participants who must receive minimum required distributions over a period of not more than the participant's assumed life expectancy.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,912 and \$9,866, respectively. Forfeited balances are used to reduce future employer contributions. In 2024 and 2023, employer contributions were reduced by \$3,962 and \$0, respectively, from forfeited nonvested accounts.

Administrative Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains on investments bought and sold as well as held during the year.

2. Summary of Significant Accounting Policies (continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a distribution is recorded.

Payment of Benefits

Benefits are recorded when paid.

3. Information Prepared and Certified by the Plan's Custodian

Certain information related to the investments disclosed in the accompanying financial statements and supplemental schedules was obtained or derived from information supplied by the Plan administrator and certified as complete and accurate by Capital Bank and Trust Company, the custodian.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- a. Quoted prices for similar assets or liabilities in active markets.
- b. Quoted prices for identical or similar assets or liabilities in inactive markets.
- c. Inputs other than quoted prices that are observable for the asset or liability.
- d. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Mutual funds* – Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

Plan management evaluated the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of Levels 1, 2 or 3.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in all of their employer contributions.

6. Related Party Transactions and Transactions with Parties-in-Interest

A related party is any party who can control or significantly influence Plan management or operating policies. Parties-in-interest are defined under Department of Labor regulations as any employees of the Plan, fiduciaries of the Plan, service providers to the Plan, the employer whose employees are covered by the Plan, and certain significant owners of the employer and their relatives. Service providers may include, but are not limited to the custodian, trustee, third-party administrator (TPA), investments managers, investment advisors, legal counsel, and Plan auditor.

The Plan made direct payments to certain parties-in-interest for administration fees, as allowed by ERISA of \$2,967 and \$2,438 during the years ended December 31, 2024 and 2023, respectively. The Plan sponsor pays directly any other fees related to the operation of the Plan.

Fees incurred by the Plan for investment management services are included in the net appreciation in fair value of the related investment, as they are paid using investment earnings rather than a direct payment.

Notes receivable from participants are managed by the Capital Bank and Trust Company and are also considered party-in-interest transactions.

7. Tax Status

The Company adopted a Non-Standardized Defined Contribution Pre-Approved Plan, which received a favorable opinion letter from the IRS dated June 30, 2020. The letter states that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has since been amended. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and statements of changes in net assets available for benefits.

9. Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date that the financial statements were available to be issued.
