Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Austin Advantage 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Austin Advantage 401(k) Plan (the Plan) provides only general information. Participants should refer to the *Plan document* for a more complete description of the Plan's provisions, which is available from Plan management.

General

The Plan is a defined contribution plan covering all full-time employees of Austin Industries Inc. (Industries) and its subsidiaries companies (Collectively, the company) as defined in the Plan document. Eligible employees shall be eligible to participate as of the entry date coinciding with or next following the sixtieth day after his or her date of employment, provided he/she is an eligible employee on such date. Employees become eligible for company matching contributions upon enrollment. Effective in 2017, eligible employees had access to online enrollment through the third-party administrator's website. Eligible employees who desire to participate in the Plan must elect to participate utilizing the online enrollment portal provided by the plan administrator or contact Vanguard by phone and authorize the Company to make payroll deductions for contributions to the Plan. Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Directors. Effective January 1, 2023, the Company has amended the Plan to allow Union employees to participate in the Plan.

Contributions

Effective January 1, 2002, participants may make 401(k) contributions from 1% to 50% of their compensation up to the maximum allowed by law. Effective January 1, 2024, participants may also designate some of their contributions as after tax contributions to a Roth 401(k) option. Effective January 1, 2007, the Company will provide a fixed match totaling 100% of the first 4% of compensation that a participant contributes to the Plan. These fixed matching contributions are divided equally between the Plan and the Austin Industries, Inc. Employee Stock Ownership Plan (ESOP). This contribution is intended to satisfy a safe harbor contribution formula permitted by Internal Revenue Service (IRS) regulations. By making the safe harbor matching contribution, the Plan will automatically satisfy the nondiscrimination requirements that otherwise would apply to 401(k) contributions made by the Plan.

Participants, in accordance with the Plan and with approval of the Retirement Plans Committee (the Committee), may transfer distributions from another eligible retirement plan to the Plan (employee rollover contributions) at any time. Effective January 1, 2002, participants who are at least 50 years of age may make an additional (\$7,500 for 2024, respectively) contribution to the Plan. Participants are allowed to make this contribution after their annual deferrals have reached the statutory limits. A Participant who is eligible to make additional contribution is not subject to the 50% of compensation limit. Participation in any one of several mutual funds or a combination thereof is at the election of the participant.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Generally, a participant employed on or after January 1, 2002 shall be fully vested in Company contributions immediately upon meeting the eligibility requirement for receiving the Company's matching contributions. Employees who left the Company prior to 2002 for reasons other than death, disability, or normal retirement, with less than five years of service, will forfeit their Company contribution accounts after they receive distribution of their account, or after five or more one-year breaks in service, as defined by the Plan.

Notes Receivable from Participants

A participant may borrow from the vested portion of his/her account, a minimum of \$1,000, but not more than the lesser of the following:

- (1) \$50,000 less the highest outstanding loan balance during the preceding twelve-month period;
- or
- (2) 50% of the participant's vested interest in his/her account.

The interest-bearing loans are collateralized by the remaining portion of the participant's account. Loan terms may range up to a maximum of five years and ten years for general purpose loans and loans used to purchase a primary residence, respectively. Interest rates are based on a reasonable rate of interest, which is commensurate with the interest rates charged by institutions in the business of lending money for loans of a similar nature. This rate of interest is determined by the Committee or its delegate in its sole discretion. Interest rates on outstanding loans ranged from 1.0% to 9.5% at December 31, 2024 and December 31, 2023. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Upon termination, participants are entitled to receive 100% of their total account balance and all related earnings.

Distributions shall be made, based on the election of the participant, in an immediate lump sum as soon as administratively possible after termination. A delayed lump sum at or before the participant's required beginning date is also offered. Participants who continue to work for the Company past age 59½ may request a withdrawal of all or part of their entire account, including rollover contributions and vested Company contributions made to the Plan on their behalf.

In-service hardship withdrawals may be permitted to the extent the Committee determines that a participant has an immediate and heavy financial need for a permitted purpose.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$1, respectively. These accounts will be used to reduce future Company contributions and to pay Plan expenses. During 2024 and 2023, Company contributions were reduced by \$9,861 and \$1,183, respectively, from forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plans Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Expenses

The Retirement Plans Committee, which is appointed by the Board of Directors of Industries, oversees certain aspects of the administration of the Plan. Currently, the Company has elected to pay all administrative expenses of the Plan except for participant loan and maintenance fees, \$10 per active participant per year and \$20 per terminated participant per year for recordkeeping fees. The Plan is not currently required to reimburse the Company for any such expenses on its behalf.

Note 3. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation(depreciation) in fair value of investments, interest and dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Vanguard Fiduciary Trust Company, the trustee of the Plan.

Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds. Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds. Valued using the NAV of the fund shares.

Collective trust fund. Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Note 5. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of various funds managed by Vanguard Fiduciary Trust Company or its affiliates. Vanguard Fiduciary Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

Note 7. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated March 16, 2018 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, Plan management believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through October 14, 2025, the date the financial statements were available to be issued.

Plan Amendment

The Plan has been amended effective March 1, 2025 to increase catch-up contribution limits to \$10,000 for participants between the ages of 60-63 as part of SECURE Act 2.0.
