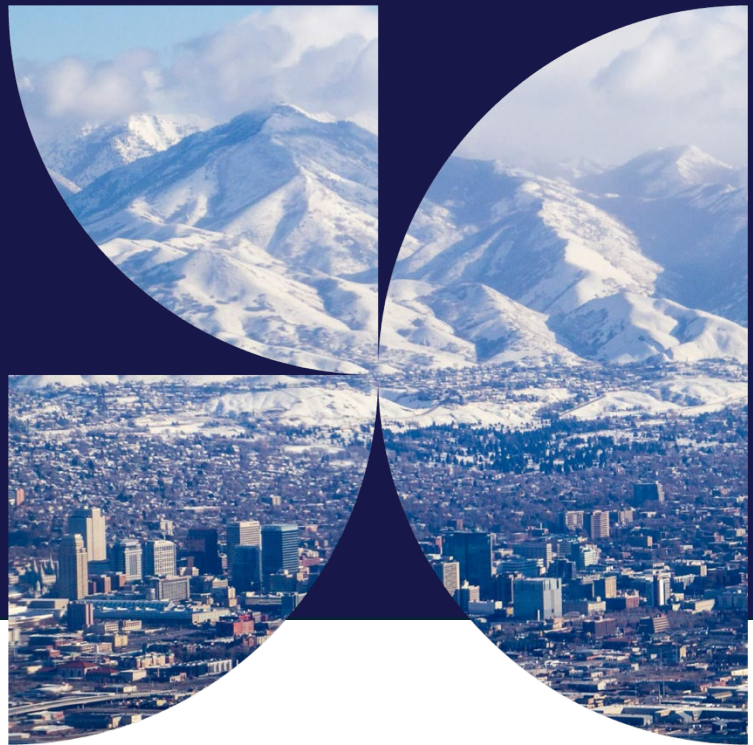

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Section 403(b) Retirement Plan for South Shore Hospital Corp., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Section 403(b) Retirement Plan for South Shore Hospital Corp.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

The Firm of Philip+Rae & Associates, CPA's, which audited the financial statements of the Club for the year ended December 31, 2023, was acquired by Platform CPA's, LLP effective November 4, 2024.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Section 403(b) Retirement Plan for South Shore Hospital Corp. and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Note 1 - Description of the Plan**

The Section 403(b) Retirement Plan for South Shore Hospital Corp. (the "Plan") was established on January 1, 1993 to enable eligible employees of South Shore Hospital Corporation (the "Company") and their beneficiaries to save money for retirement. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a 403(b) plan, formally called a tax deferred annuity plan, available to tax-exempt organizations, such as educational institutions, hospitals, and churches. The plan is similar to a 401(k) plan in that it allows participants to make salary reduction contributions to the plan. The participant is not taxed on the amount of the contributions until distributed from the plan. 403(b) plans may also include a Roth contribution feature similar to the Roth 401(k) accounts. The Plan is a defined contribution plan covering all full-time employees of the Company who have worked at least 1,000 hours a year and two years of continuous service. Newly eligible participants may enter the Plan on the first day of each month following two years of continuous service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company absorbs administrative costs of the plan.

#### ***Contributions***

Participants may each year voluntarily contribute to the Plan an amount which does not exceed the dollar limitation provided by Section 415(c) of the Internal Revenue Code as defined in the Plan. A minimum contribution of 3% of eligible wages is required by each participant contributing to the Plan. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Company makes a base matching contribution to the account of each eligible participant in an amount up to five percent of the participant's contribution.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, Company contributions and allocations of Plan earnings. Plan earnings are allocated to participants based upon a share or unit owned method applied on a daily basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### ***Vesting***

Participants are immediately vested in their contributions and in the Company's discretionary contribution portion of their accounts plus actual earnings thereon.

#### ***Investment Options***

Upon enrollment in the Plan, a participant may direct their contributions between a fixed interest account or various separate pooled accounts used to invest in over sixty mutual fund vehicles. Participants may change their investment options daily.

#### ***Participant Loans***

The Plan allows for participants to borrow in accordance with the Plan's established loan procedure as follows. Participants are allowed one loan outstanding at any time. Loans are available to all participants. A loan shall be made for no less than one thousand dollars (\$1,000) and the maximum amount is the lesser of \$50,000 or 50% of the contributions of the participant in the Plan. Loans shall bear interest at a reasonable rate at the time of application, set at prime plus 1%. Loans are to be repaid in equal installment payments on the basis of substantially level amortization over the term of the loan. All loans are required to be repaid within five years of the date of the loan except if the proceeds are used to acquire the principal residence of the participant.

#### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting.

#### **Note 2 - Summary of Significant Accounting Policies**

#### ***Payment of Benefits***

Distributions may commence at the election of a participant or beneficiary at the beginning of the month after termination of employment or the early retirement date of age 59 1/2. Installment and partial distributions are permitted and withdrawals in restricted amounts may be made for certain hardship reasons upon the written request of a participant.

#### Note 2 - Summary of Significant Accounting Policies (continued)

##### *Date of Management's Review*

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

##### *Estimates*

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

##### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

##### *Operating Expenses*

The Company pays a portion of the administrative expenses on behalf of the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### Note 3 - Investments

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. The investments of the Plan at December 31, 2024 and 2023 are held, and all transactions therewith are initiated and executed, by Empower the Custodian. The following information, as well as the information presented on the accompanying schedule of assets held at year end, has been certified by the Custodian.

#### Note 5 - Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurements authoritative literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 1 inputs were available to the Plan; Level 3 inputs were used only when Level 2 inputs were not available.

The applicable levels of the fair value hierarchy under FASB ASC 820 are described as follows:

#### *Level 2 Fair Value Measurements:*

*Pooled separate accounts:* The fair value of the pooled separate accounts is based on a per unit allocation of the net asset values (NAV) of the underlying mutual funds in which the separate accounts invest. The NAV of mutual funds are reported daily at their quoted close. The Plan utilized the fair value as reported by the Custodian as a practical expedient to valuing these assets.

#### **Note 6 – Guaranteed Investment Contracts**

The Plan maintains a benefit-responsive guaranteed investment contract with Empower. The account is credited with earnings on the underlying investments and charged for participant withdrawals. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the plan. The stated interest rate for the 2024 plan year was 2.54% and for 2023 was 2.00%.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The occurrence of an event that limits the ability of the investment to transact at contract value between Empower and a participant holding the investment is not probable. (If an event should ever occur such as a significant decline in creditworthiness of Empower, the SF guaranteed interest fund choice may no longer be considered fully benefit-responsive.)

#### **Note 7 - Tax Status**

The Internal Revenue Service (IRS) has not yet developed an approval program for 403(b) prototype documents. The plan has been restated effective January 1, 2019. However, the plan administrator believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing authorities for 3 years. Tax years prior to 2022 are no longer subject to audit.

#### **Note 8 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### **Note 9 – Related Party Transactions**

Certain plan investments are shares of separate pooled accounts managed by Empower, the custodian of the Plan. Therefore, these transactions qualify as party-in-interest transactions and are denoted as such on the supplemental schedule of assets (held at end of year).
