### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of **Mashura, LLC 401(k) Plan** (formerly known as Cubex, LLC 401(k) Plan) (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). ### NOTES TO FINANCIAL STATEMENTS

#### (1) Description of Plan

The following description of the Mashura, LLC 401(k) Plan (formerly known as Cubex, LLC 401(k) Plan) (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator. On July 29, 2024 the Plan filed an amendment to change its name from Cubex, LLC 401(k) Plan to Mashura, LLC 401(k) Plan.

**General** - The Plan is a defined contribution plan sponsored by Mashura, LLC (the "Company") for the benefit of its employees who have attained age 18 and completed six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan is administered by the Company's Chief Executive Officer and Human Resources Manager ("Management"). Management has the overall responsibility for the operations and administration of the Plan. Management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

**Contributions** - Participants may contribute their annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants aged 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan has an auto-enrollment feature that provides for participants in the Plan to be automatically enrolled in the Plan at a 3% elective deferral contribution percentage. Automatically enrolled participants deferral rate will increase by 1% annually until a maximum of 8% is reached. Automatically enrolled deferral contribution percentages may be overridden by the participant via an affirmative election.

For the year ended December 31, 2024, the Company is in the process of making a safe harbor non-elective employer contribution of 3% of each eligible participant's compensation. Additional amounts may be contributed at the option of the Company. Contributions are subject to certain Internal Revenue Code ("IRC") limitations. The Company may elect to make profit sharing contributions allocated to individual accounts of qualifying participants based on a formula specified by the employer.

**Participant investment account options** - The Plan currently offers various mutual funds as investment options for participants. Each investment option has its own strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

**Participant accounts** - Each participant's account is credited with the participant's contributions, and allocations of (a) the Company's Safe Harbor Non-Elective Employer Contributions, (b) the Company's profit-sharing contribution, (c) an allocation of Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**(1) Description of Plan (continued)**

**Rollover contributions** – Amounts represent employee funds transferred into the Plan from similar plans of prior employees.

**Vesting** - Participants' contributions plus actual earnings are 100% vested immediately. The employer's Safe Harbor Non-Elective Employer Contributions are 100% vested. The Company's discretionary match and non-elective contributions are subject to the following vesting schedule:

**Notes receivable from participants** - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years unless the loan is used for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through scheduled payroll deductions.

**Payment of benefits** - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over the life of the participant, participant and spouse, or designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If the value of a participant's vested interest in his or her account is between \$5,000 and \$1,000 it will be automatically rolled into an IRA outside of the plan, if the balance is less than \$1,000 the account will be automatically distributed as a lump sum.

**Forfeited accounts** - As of December 31, 2024 and 2023, there were no forfeited non-vested accounts. These accounts may first be used for payment of Plan administrative expenses. Any remaining amounts attributable to employer matching forfeitures will be allocated to the accounts of eligible participants in the same manner as provided for nonelective contributions.

**Plan Termination** – While the Company has not expressed any intent to terminate the Plan, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of the ERISA. In the event of such a termination, the Plan Document provides that the participant become fully vested in their accounts.

#### (2) Summary of Significant Accounting Policies

**Basis of accounting** - The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of estimates** - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Investment valuation and income recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management determines the Plan's valuation policies utilizing the information provided by Alerus Financial, N.A. ("Alerus"), the Trustee and Custodian. See Note 4 for discussions of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of benefits** - Benefits are recorded when paid. As of December 31, 2024 and 2023, there were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but who have not yet been paid.

**Administrative expenses** – Administrative expenses of the Plan are paid by the Plan and are included in the statements of changes in net assets available for benefits. Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

#### (3) Information Prepared and Certified by the Custodian (Unaudited)

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Alerus, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

#### (4) **Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). *Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual and money market funds held by the Plan are open-end mutual and money market funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value ("NAV") and to transact at that price. The mutual and money market funds held by the Plan are deemed to be actively traded.

**(5) Related Party Transactions and Party-In-Interest Transactions**

Certain plan investments were shares of mutual funds managed by Alerus. Alerus was the Trustee and Custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to Alerus, the third-party administrator and trustee, totaling \$38,853 for the year ended December 31, 2024, which was not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the plan's operations. The Plan paid certain expenses related to plan operations and investment activity to various service providers, these transactions are party-in-interest transactions under ERISA.

#### (6) **Tax Status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (7) **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investments securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statement of net assets available for benefit.

At December 31, 2024, approximately 15%, 15% and 11% of the Plan's investments were invested in Dimensional US Core Equity 1, Vanguard Target Retirement 2040, and Vanguard Target Retirement 2035 Fund, respectively. At December 31, 2023, approximately 25%, 14% and 13% of the Plan's investments were invested in Vanguard Target Retirement 2035, Vanguard Target Retirement 2040, and Vanguard Target Retirement 2045 Fund, respectively.

#### (8) **Subsequent Events**

The Plan has evaluated subsequent events through October 14, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
