INDEPENDENT AUDITOR'S REPORT

To the Members of
So. Cal. Sandbags, Inc. Prevailing Wage Retirement Plan, LLC

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of So. Cal. Sandbags, Inc. Prevailing Wage Retirement Plan, LLC (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of the Plan including summary of significant accounting policies

The following brief description of the So. Cal. Sandbags, Inc. Prevailing Wage Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution retirement Plan administered by So. Cal. Sandbags, Inc. (the “Company”, “Plan Sponsor”, “Plan Administrator” or “Employer”); it was established on January 1, 2015. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan covers participants working under the terms of prevailing wage contracts that provide for employer prevailing wage contributions.

Eligibility

The Plan provides that participants must be at least 18 years of age, must complete at least 83 hours of service during their first 3 months of employment in order to be eligible to participate in the Plan. In order to receive matching contributions or other employer contributions, participants must also complete a year of service, with a minimum of 100 hours. Participants may enter the plan January 1, April 1, July 1 or October 1, once the participant satisfies the eligibility.

The Plan provides that prevailing wage contributions are not subject to minimum age or service requirements. See Plan agreement for complete description for prevailing wage provisions. Participants that are covered by the contract, will be eligible for the employer prevailing wage contribution immediately following their date of hire.

Contributions and vesting

Participants may contribute up to 100% of pretax annual compensation, as defined by the Plan, and subject to the annual limits of the Internal Revenue Code (“IRC”). At December 31, 2024 and 2023, the imposed limit was \$23,000 and \$22,500, respectively. Participants may also rollover amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained the age of 50 are allowed an additional “catch-up contribution” not to exceed \$7,500 and \$7,500 in 2024 and 2023, respectively. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may elect to change their investment options directly through Great-West Empower (Empower) at any time.

The Company may make discretionary matches to the participant contributions at a rate of 100% of all contributions that do not exceed 5% of compensation. For the years ended December 31, 2024 and 2023, the Company did not make any discretionary match contributions.

The Company may make discretionary employer contributions to the Plan as determined annually by the Plan Sponsor. For the years ended December 31, 2024 and 2023, the Company made discretionary employer profit sharing contributions totaling \$425,850 and \$204,441, respectively.

The Company may make special employer contributions (Qualified Nonelective Employer Contributions) to the Plan as determined annually by the Plan Sponsor. If participants receive a QNEC contribution, they will automatically be vested 100% in that QNEC contribution. For the years ended December 31, 2024 and 2023, the Company made QNEC contributions totaling \$48,551, and \$289,226, respectively.

Participants are immediately vested in their voluntary contributions and any non-discretionary contributions made on their behalf, plus actual earnings thereon. Other contributions vest ratably over a period of six years and the participant must be employed on the last day of the contribution period. A year of vesting service is any year in which a participant works at least 1,000 hours for the Company.

The Employer makes prevailing wage contributions for eligible participants who perform services to the Service Contract Act, Davis-Bacon Act, or similar federal, state or municipal prevailing wage statutes. Each participant's prevailing wage is equal to the balance of fringe benefit payments based on designated hourly contribution rates for each participant's employment classification. Prevailing wage contributions are determined by contract depending on each employee's type of work. Prevailing wage contributions are subject to special rules that apply without regard to any other provisions under the Plan and are not subject to any minimum age or service requirements or allocation conditions. Prevailing wage contributions are immediately 100% vested.

Participant accounts

Each participant's account is credited with the Employer's prevailing wage contributions, allocations of Plan earnings or losses, and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant compensation or account balances, as defined by the Plan. Participants direct their investment choices into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants

Participants may borrow against their vested balance at a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested balance. The Plan allows for only one outstanding loan at any given time. The notes receivable are secured by the vested balance in the participant accounts. The loan interest rate is determined by the Plan Sponsor based on prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Participants' notes receivable are for fixed terms, not to exceed five years, requiring regular periodic repayment by payroll deductions. A note receivable becomes immediately due and payable upon a participant's termination of employment, death, or disability. The notes receivable are valued at their outstanding balance plus accrued interest. Principal and interest is paid ratably through monthly payroll deductions.

Benefit obligations

In conformity with guidance for accounting and disclosure by employee benefit plans, benefit obligations to terminated employees who have withdrawn from participation in the Plan are not accrued in the statements of net assets available for plan benefits; rather, such amounts are disclosed in the notes to the financial statements. There were no such benefit obligations as of December 31, 2024 and 2023.

Payment of benefits

Upon termination of service, death, or reaching retirement age, participants may request a lump sum cash distribution equal to the value of their vested account balance or roll-over their vested account balance into an Individual Retirement Account (“IRA”) or another qualified employer plan. However, if the account balance is less than or equal to \$5,000, the participant does not need to request a distribution as the funds will be distributed to the participant automatically. Participants may request hardship distributions from their account balance for certain financial needs, as defined in the Plan.

Benefit payments are recorded when paid.

Administrative expenses

The Plan administrative expenses are paid by the Plan and/or the Company. For the years ended December 31, 2024 and 2023, the Company paid \$17,087 and \$15,175, respectively, relating to Plan expenses.

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of estimates

The preparation of financial statements in conformity with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for plan benefits.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Investment valuation and income recognition

The Plan's key guaranteed portfolio fund is valued at contract value and mutual fund investments are stated at fair value as determined by quoted market prices. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a description of the valuation methodologies used in determining the fair value of the Plan's investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

2. Tax status

The Plan adopted the First Allied Retirement Services Volume Submitter Profit Sharing/401k Plan Agreement and is relying on the tax exempt status from the Internal Revenue Service ("IRS") by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan Administrator believes the Plan, as currently designed and operated, is in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the taxing jurisdiction; however, there are currently no audits for any tax periods in progress.

3. Plan termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the net assets of the Plan will be allocated to the participants in accordance with the terms of the Plan.

5. Fair value measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, established the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. Key guaranteed portfolio fund

The Key Guaranteed Portfolio Fund (“KGPF”) is fully-benefit-responsive contract issued by Great-West Empower (“Empower”) totaling \$362,264 and \$351,783 as of the years ended December 31, 2024 and 2023, respectively. Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The investment contract is presented on the Plan’s financial statements for the years ended December 31, 2024 and 2023, at contract value. The Empower KGPF account does not contain any type of market value formula or provision. Participant distributions are paid at contract value.

Because the guaranteed investment contracts are fully benefit-responsive, contract value is the relevant measurement for that portion of the net assets available for benefits attributable to the guaranteed investment contracts. Contract value, as reported to the Plan by Empower, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The interest crediting rate is based on the contract value, the fair value, duration, and yield to maturity of the underlying portfolio. The contract issuers determine the declared interest rate (portfolio rate) which will be credited to all monies invested in the Contract during the relevant period until the interest rate is reset. The crediting interest rate is set quarterly by Empower.

The average credit interest rate for the years ended December 31, 2024 and 2023 for the contracts was 1.41% and 1.23%, respectively.

The Plan’s ability to receive amounts due in accordance with the fully benefit-responsive investment contract dependent on the issuers’ ability to meet financial obligations, which may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options or deletion of equity wash provision, (3) bankruptcy of the Company, (4) the failure of the trusts to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. The Plan Administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

7. Related party and party in interest transactions

Certain Plan investments are shares of mutual funds managed by Empower. Empower is the trustee and the recordkeeper as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping services amounted to \$25,316 and \$21,346 for the years ended December 31, 2024 and 2023, respectively.

8. Subsequent events

Management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued. No subsequent events were noted that would require disclosure.


