We have performed audits of the financial statements of the National Amusements 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the Statements of Net Assets Available for Plan Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### A. Description of Plan

The following description of the National Amusements 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan covering all employees that meet the following criteria:

- Employees of National Amusements, Inc. and related employers as defined (the “Employer” or “Plan Sponsor”), with the exception of employees covered by a collective bargaining agreement, other than those covered by an agreement negotiated with the Employer which provides for their participation in the Plan; and
- Employees who have attained age 21.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a single plan of a controlled group as defined in Code Sections 414(b) and 414(c). All investments are participant directed.

The Employer is also the administrator of the Plan. As administrator, the Employer has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan. Fidelity Management Trust Company (Fidelity) is the appointed trustee of the Plan, and acts at the direction of the Plan Administrator. The Employer was recently sold (see Notes B and I).

#### Contributions

Each year, participants may contribute up to 60% of eligible compensation on a pre-tax basis, as defined in the Plan. Effective November 3, 2023, the Plan was amended to allow participants to designate all or a portion of their elective deferrals as Roth deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“Rollovers”). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan is a safe harbor plan, whereby matching contributions to all eligible participants equal to 100% of the participant’s contribution up to 4% of compensation are being made.

#### Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Employer’s contribution and allocations of earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**A. Description of Plan, Continued**

**Vesting**

Participants are 100% vested immediately in participant and Employer contributions, plus actual earnings thereon.

**Participant Notes Receivable**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance, reduced by the highest outstanding note balance during the prior 12-month period. Note transactions are treated as a transfer to (from) the investment fund from (to) the participant's note fund. The notes are secured by the balance in the participant's account and bear interest at 1% above the prime-lending rate at the inception of the note. Principal and interest are paid ratably through payroll deductions. Participants pay an application fee of \$75 per note and a note maintenance fee of \$25 per year.

**Payment of Benefits**

Upon termination of service due to death, disability, retirement or other termination of employment, a participant may elect to receive either a lump-sum amount or annual installments. A distribution may be made in fund shares at the election of the participant, pursuant to a qualifying rollover of such distributions to another Fidelity Investments individual retirement account. If the participant's vested balance is less than \$1,000, the participant will receive a cash-out of their vested account balance. If a participant's vested balance exceeds \$1,000 but is less than \$5,000, the amount will be rolled over to an individual retirement account designated by the trustee, unless otherwise directed by the participant.

**Early Withdrawals**

Participants may request a financial hardship withdrawal from their account. Participants who have attained age 59½ may elect to withdraw all or a portion of their vested account while still employed.

**B. Summary of Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

**B. Summary of Accounting Policies, Continued****Administrative Revenue (Expenses)**

Certain administrative expenses of the Plan are paid by the Employer, unless the Employer directs that the expenses be paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Participant notes receivable initiation and maintenance fees are paid directly by the participants through a reduction in their account and are included in administrative expenses. Investment management fees for certain investments are included as a reduction of investment return (net appreciation or depreciation) and not reflected separately in the Statement of Changes in Net Assets Available for Plan Benefits. Administrative revenue arises when investment managers return a portion of the investment fees to the recordkeeper to offset the administrative expenses. Any excess resulting from this revenue credit remains in an unallocated account from which future Plan expenses can be paid or allocated to participant accounts. The Plan held unallocated administrative revenues of \$92,556 and \$59,349 at December 31, 2024 and 2023, respectively.

**Use of Estimates**

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions**

Participant and Employer matching contributions are recorded weekly when the Company remits the payroll deductions for investment into the Plan.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note C). The Plan invests in the Fidelity Managed Income Portfolio Class 1 Fund, which is a common collective trust fund. The Plan's interest in the fund is valued at the net asset value (NAV) practical expedient of the underlying investments reported by the issuer of the common collective trust fund at year end.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation included in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**B. Summary of Accounting Policies, Continued**

**Participant Notes Receivable**

Participant notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Interest income on participant notes receivable is recorded when it is earned. A receivable is considered past due if payment has not been received within stated terms. Delinquent participant notes receivable are reclassified as distributions based on the terms of the Plan document.

**Payment of Benefits**

Benefits are recognized when paid to participants or their designated beneficiaries.

**Risks and Uncertainties**

The Plan provides for various investment options with a variety of investment objectives. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan invested in two mutual funds that accounted for approximately 57% and 53% of total Plan investments as of December 31, 2024 and 2023, respectively.

The Plan Sponsor continues to face ongoing challenges with fewer blockbuster film releases, competition from streaming platforms as well as changes in consumer moviegoing behavior. It is difficult to predict with any assurance how future film releases, streaming competition and consumer confidence will impact attendance and revenue and the Plan Sponsor's ability to generate positive cash flows from operations in the future. The greatest risk facing the Plan is the possibility of the Plan Sponsor not meeting the Plan's liability or cash flow requirements. The possible future success of the Plan Sponsor's operations cannot be determined as of the date of these financial statements. On July 7, 2024, the Plan Sponsor's shareholders entered into a purchase and sales agreement to sell the Plan Sponsor. The transaction closed on August 7, 2025 and the Plan Sponsor subsequently changed its legal name to Harbor Lights Entertainment, Inc.

**B. Summary of Accounting Policies, Continued****Financial Instruments with a Concentration of Credit Risk**

The Plan's assets are held by a single trustee. The Plan's exposure to credit risk is associated with the trustee's non-performance of its fiduciary responsibilities relating to these amounts as specified in the trust agreement. Benefits provided by the Plan are not insured or guaranteed by the Pension Benefit Guaranty Corporation.

**C. Fair Value Measurements**

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy and inputs to the valuation methodologies are described as follows:

Level 1 inputs are unadjusted quoted prices in active markets for identical assets the Plan has the ability to access.

Level 2 inputs are other than quoted prices in active markets that are observable either directly or indirectly for the asset. Such inputs are derived principally from or corroborated by observable market data for similar assets by correlation or other means, over substantially the full contractual term of the asset, if applicable.

Level 3 inputs are unobservable and significant to the fair value measurement. Such inputs generally rely on the Plan's own assumptions about the assumptions that market participants would use in pricing the asset.

The assets' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis.

*Money Market Fund:* The money market fund is valued at deposit amount less, plus accrued interest, as determined according to stated terms.

### C. Fair Value Measurements, Continued

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust Fund:* The Plan invests in the Fidelity Managed Income Portfolio Class 1 Fund, an investment vehicle that invests in benefit-responsive investment contracts, fixed income securities, and money market funds. This investment is valued at NAV of units held by the Plan. The NAV, as provided by Fidelity, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Unit values are determined by dividing the fund's net assets at fair value by its units outstanding at the valuation dates. Participant transactions (purchases and sales) occur daily. There are no unfunded commitments or redemption restrictions for the individual participants within the Plan, however, there is up to a 12-month redemption for this investment at the Plan level.

**D. Related Party Transactions and Party-in-Interest Transactions**

Plan investments are managed by Fidelity, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, the Plan made direct payments of \$27,998 to Fidelity and subsidiaries and \$46,253 to its independent investment advisors and accountants. Participant notes receivable are also party-in-interest transactions.

In 2024, participant accounts were also provided a revenue credit of \$76,897 related to the management of investments. This credit is used to cover administrative fees of the Plan.

**E. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, and after administrative expenses have been paid by the Plan, the remaining assets of the trust shall be distributed to participants.

**F. Tax Status**

The Plan is an adoption of a volume submitter defined contribution plan. The Plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan was amended subsequent to the Plan's receipt of the advisory letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**G. Information Certified by the Trustee**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the trustee, has certified to the completeness and accuracy of all investments and participant notes receivable reflected on the accompanying Statements of Net Assets Available for Plan Benefits at December 31, 2024 and 2023, the related investment and participant notes receivable activity reflected in the Statement of Changes in Net Assets Available for Plan Benefits for the year ended December 31, 2024, and the Schedule of Assets (Held at End of Year) at December 31, 2024.

**H. Differences from Form 5500**

Differences between the Annual Return/Report of Employee Benefit Plan, Form 5500 and these financial statements are the result of different classifications between line items. Total Plan assets are in agreement.

**I. Subsequent Events**

Management has evaluated subsequent events through October 14, 2025, which is the date these financial statements were available to be issued, and determined that there are no additional events to recognize or disclose other than the sale of the Plan Sponsor and the Plan Sponsor name change on August 7, 2025 as discussed in Note B.
