As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section -

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Village Management Services, Inc. 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Village Management Services, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date financial statements are available to be issued.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE A - DESCRIPTION OF THE PLAN

The following description of the Village Management Services, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan established January 1, 2016 for the benefit of all eligible employees of Village Management Services, Inc. (the “Employer”) under the provisions of Section 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is administered by the Employer and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, the Plan was amended to change the safe harbor eligibility from one year to 6 months of service.

2. Eligibility

An employee is eligible to make deferral contributions to the Plan upon attainment of age 21 and completion of one month of employment. The entry date into the Plan is the first day of the month coinciding with or following the date the eligibility conditions have been satisfied.

Participants are eligible for Employer safe harbor matching and additional matching contributions upon completion of six months of service. In order to be eligible for profit sharing contributions, participants must complete one year of service during which at least 1,000 hours are worked and upon attainment of age 21. Employees who are non-resident aliens and leased employees are not eligible to participate in the Plan. Employees covered under a collective bargaining agreement are not eligible to receive Employer contributions under the Plan.

3. Contributions

Participants may elect to contribute on a tax-deferred basis and/or make Roth contributions, up to 90% of annual compensation, limited to the maximum deferral amount set by Section 402(g)(1) of the IRC. Participants who attain age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan allows rollover contributions from other qualified plans, as defined in the plan document.

The Plan’s provision for the safe harbor matching contribution is equal to 100% of salary deferrals up to 5% of plan compensation. In addition, the Employer may make a profit-sharing contribution or an additional discretionary matching contribution to the Plan. For the year ended December 31, 2024, no profit sharing or additional discretionary matching contributions were made to the Plan.

4. Investment Options

Upon enrollment in the Plan, a participant may direct employee and Employer contributions, as desired, in any of a variety of options offered by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, custodians (collectively as “Empower”) of the Plan, as chosen by the Employer. Participants may change their investment options daily.

5. Participant Accounts

Each participant’s account is credited with the participant’s contributions, Employer safe harbor matching contributions, Employer discretionary matching contributions, and allocations of profit-sharing contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

6. Notes Receivable from Participants

The Plan permits participants to borrow from their account a minimum of \$1,000 up to 50% of their vested account balance not to exceed \$50,000, reduced by the participant’s highest outstanding loan balance during the prior twelve-month period. The loans are secured by the balance in the participant’s account. Loans must be repaid within five years with interest at prime plus 1% per annum. Loans for the purchase of a principal residence may be repaid over a longer period of time, but not to exceed 30 years. A maximum of one loan is allowed to be outstanding at any time.

7. Benefit Payments

Upon termination of service, participants are entitled to receive their vested account balances. Upon retirement, early retirement, permanent disability or in the event of death while still employed, a participant or a participant’s beneficiary is entitled to the total value of the participant’s account balance. In addition, participants may request in-service and hardship distributions if certain criteria are met.

8. Vesting

Participant contributions, participant rollovers, Employer safe harbor matching contributions, and actual earnings on all such contributions are fully vested at all times. However, vesting of the discretionary Employer matching and profit sharing contribution portions of participant accounts, plus actual earnings thereon, is based on the participant’s years of service with the Employer as follows:

9. Forfeitures

Forfeitures of terminated participants' nonvested discretionary profit sharing or Employer matching contribution accounts may be used to pay plan expenses, allocated as additional Employer contributions or used to reduce future Employer contributions under the Plan. Forfeitures outstanding at December 31, 2024 and 2023 were not material.

10. Plan Termination

While the Employer has not expressed any intent to terminate the Plan, the Employer reserves the right to terminate the Plan at any time subject to the provisions of ERISA. Upon termination, all interests of participants become fully vested, and plan assets are distributed among the participants of the Plan in accordance with the provisions of the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

2. Plan Administration

The Employer is the plan sponsor and plan administrator. The plan administrator is responsible for carrying out the duties imposed under ERISA.

3. Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

4. Payment of Benefits

Benefits are recorded when paid.

5. Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment adviser, trustee and custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation/depreciation includes gains and losses on investments bought and sold as well as held during the year.

6. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

7. Administrative Expenses

Administrative expenses incurred by the trustee, custodian and other service providers in performance of their duties are paid from the assets of the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation/depreciation in fair value of investments.

8. Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year which the employee contributions are withheld from compensation.

NOTE C - CERTIFIED INVESTMENT INFORMATION

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (the trustee and custodian of the Plan), qualified institutions.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards codification ("ASC") are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The NAV for mutual funds is a publicly available quoted price in an active market.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan holds an investment that meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus credited interest, less participant withdrawals, and administrative expenses. The following represents the traditional investment contract held by the Plan:

The fully benefit-responsive investment contract held by the Plan at December 31, 2024 and 2023 is a Guaranteed Interest Account (GIA) backed by Empower's general investment account. Under the contract, a crediting rate is established at least annually (a "rate period") and all assets invested in the GIA are credited with that rate. At the expiration of each rate period, a new crediting rate is declared. Certain events may limit the ability of the Plan to transact at contract value with the contract issuer. Such events include but may not be limited to a participant termination of employment due to: (1) removal of a group of participants from plan coverage as a result of temporary absence; (2) change in position or other occurrence qualifying as a temporary break in service under the Plan; (3) transfer or other change of position resulting in employment by an entity controlling, controlled by, or under other common control with the employer; or (4) cessation of an employment relationship resulting from a reorganization, merger, layoff or the sale or discontinuance of all or any part of the plan sponsor's business. Such events also include: (1) removal from the Plan of one or more groups or classifications of participants; (2) partial or complete plan termination; or (3) plan disqualification. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers or that also may limit the ability of the Plan to transact at contract value with the participants.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third party issuer's ability to meet its financial obligations which may be affected by future economic and regulatory developments.

Although plan participants generally withdraw assets from the GIA without restrictions, Empower could impose a liquidation (market value) adjustment at the contract level in the event of a full or partial contract discontinuance.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Empower Annuity Insurance Company of America and Empower Trust Company, LLC are the custodians of the Plan's assets, and Empower Retirement, LLC is the recordkeeper. Therefore, transactions with these entities qualify as party-in-interest transactions. Notes receivable from plan participants and the related interest income are also considered party-in-interest transactions.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur, in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE H - TAX STATUS

The Employer adopted a non-standardized pre-approved Profit sharing plan (“pre-approved plan”), which received favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the pre-approved plan and related trust, as then designed, were in compliance with applicable sections of the IRC. The Plan administrator and the Plan’s advisors believe that the Plan is currently designed and operated with the applicable requirements of the IRC. Administration errors, if any, that are insignificant or operational in nature, are handled by the plan administrator in accordance with applicable IRS correction policies. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - SUBSEQUENT EVENTS

Plan management has evaluated subsequent events through October 15, 2025, the date the financial statements were available to be issued.
