**NOTE 1 - DESCRIPTION OF PLAN**

The following description of the Solomon Partners, L.P. 401(k) Plan (the "Plan"), sponsored by Solomon Partners, L.P. (the "Company"), provides general information only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General** - The Plan is a defined contribution plan covering substantially all full-time employees of the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The following brief description of the plan is provided for general information purposes only. Participants should refer to the "Summary Plan Description" for a more complete description of the Plan's provisions.

**Plan Sponsor, Administrator, and Custodian** - The Plan is sponsored by Solomon Partners, L.P. Fidelity Management Trust Company ("Fidelity") and Principal Trust Company are the appointed custodians for the Plan (the "Custodians"), and act at the direction of the Plan Administrator. Participants have the option to invest in certain Custodian maintained funds in accordance with the provisions of the Plan document. Participants may elect to change their investment options daily.

**Participant Accounts** - Participants may elect to invest in one or more of the aforementioned investment options at their discretion within Plan limits. Transfers of existing investments between funds are also permissible upon election. Each participant's account is credited with that participant's contribution, a Company matching contribution and allocated fund earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the proportion of each participant's account balance to the corresponding investment fund balance. The benefit to which a participant account is entitled is the benefit that can be provided from a participant's vested account.

**Eligibility** - Employees are eligible to enroll in the Plan upon hire date and attaining the age of twenty-one.

**Contributions** - Participants may elect to defer up to 100% of pretax annual compensation, not to exceed the limits established by Internal Revenue Code ("the Code") Section 402(g) ("voluntary contributions"). Participants, subject to the approval of the Plan Administrator, can also contribute amounts representing distributions from other qualified defined benefit or contribution plans ("rollover contributions"). Effective January 1, 2022, for each plan year, the Company makes safe harbor matching contributions on behalf of each participant of 100 percent of the first 4 percent of contributions not to exceed the amount contributed by the participant.

**Vesting** - Participants have a vested right to receive payment of 100% of their participant pretax and Roth contributions, rollover contributions, safe harbor matching contributions, and earnings thereon whenever their service terminates.

**NOTE 1 - DESCRIPTION OF PLAN (Continued)**

**Forfeitures** - Participants who terminate employment but have not become fully vested forfeit the unvested balances in their accounts. In accordance with the Plan, the amount of the forfeitures is utilized to pay Plan expenses. Forfeitures in the amount of \$25 were utilized to pay Plan expenses in 2024. The balance of the forfeiture account at December 31, 2024 and 2023 was \$13,817 and \$598, respectively.

**Payment of Benefits** - Upon death, retirement, total and permanent disability, or termination of employment, the participant shall be entitled to the vested amount of his/her account in accordance with the provision and payment method elections specified in the Plan. If the participant leaves and returns to the Plan within a defined period of time, the non-vested portion is reinstated upon meeting certain criteria. Participants who meet the Plan provisions may take in-service withdrawals. For accounts with less than \$5,000, the Company can pay the participant in a lump sum at any time after the participant leaves the Company.

**Notes Receivable from Participants** - Participants have the ability to borrow up to 50% of their vested account balance up to a maximum of \$50,000 upon application and approval by the Plan Administrator, as defined in the Plan. The loans are secured by the balance in the participant's account. The interest rate charged to participants is one percent above the prime interest rate established by commercial lending institutions. Principal and interest are paid ratably through payroll deductions. The Plan Administrator will fix the term of repayment for all loans. A general purpose loan will be repayable over a period not to exceed five years. The Administrator may permit a longer repayment term for a "home loan" used to purchase a primary residence.

**Hardship Withdrawals** - The Plan allows for "hardship" withdrawals in accordance with the Internal Revenue Service regulations as specified in the Plan summary.

**Administrative Expenses** - Investment management fees of the Plan are funded directly by the Plan. All other administrative expenses (audit and legal fees) are paid by the Company on the Plan's behalf. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation** - The Plan financial statements have been prepared on the accrual basis of accounting.

**Fair Value Measurements** - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements. The Plan follows the guidance in ASU 2015-07 which removed the requirement to categorize within the fair value hierarchy all investments for which fair value is measured using the net asset value ("NAV") per share as quoted on a private market that is not active.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

*Use of Estimates* - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition* - The Plan's investments are stated at fair value (except for fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits* - Benefits are recognized when paid.

*Note Receivable from Participant* - Note receivable from participant is measured at its unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

*Risks and Uncertainties* - The Plan provides the participants with various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 3 - SUMMARY OF CERTIFIED FINANCIAL DATA (UNAUDITED)**

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Accordingly, Fidelity has certified as to the completeness and accuracy of the investments and investment transactions of the Plan as of December 31, 2024 and 2023 and for the year ended December 31, 2024, and Principal Trust Company and Principal Life Insurance Company have certified as to the completeness and accuracy of the investments and investment transactions of the Plan as of December 31, 2023 and for the period from January 1, 2024 to August 29, 2024. The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by Fidelity, Principal Trust Company and Principal Life Insurance Company:

**NOTE 4 - TERMINATION PRIORITIES**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100 percent vested in their employer contributions.

**NOTE 5 - INVESTMENT CONTRACTS WITH INSURANCE COMPANIES**

In 2018, the Plan entered into a fully benefit-responsive investment contract with Principal Life Insurance Company (“Principal”). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Since the guaranteed investment contracts are fully benefit responsive, the guaranteed investment contracts are reported at contract value. Contract value is the relevant measure for fully benefit responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuers or otherwise. The crediting interest rate is based on a formula agreed upon with the issuers. Such interest rates are reviewed on a semi-annual basis for resetting. The guaranteed investment contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan’s ability to receive amounts due is dependent on the third-party issuer’s ability to meet its financial obligations. The issuer’s ability to meet its contractual obligation may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: amendments to plan documents (including complete or partial plan termination or merger with another plan), changes to plan’s prohibition on competing investment options or deletion of equity wash provisions, bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary), that cause a significant withdrawal from the plan, or the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974 or premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include an uncured violation of the Plan’s investment guidelines, a breach of material obligation under the contract, a material misrepresentation, and a material amendment to the agreement without the consent of the issuer.

On August 29, 2024, the investment contract with Principal was liquidated and funds were transferred to Fidelity.

**NOTE 6 - FAIR VALUE MEASUREMENTS**

ASC Topic 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual and money market funds:* Valued at the net asset value of shares held by the Plan at year-end.

**NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS**

During 2024, there were transactions involving the investment of Plan assets in accounts maintained by both Principal and Fidelity, parties-in-interest, as defined under Section 3(14) of ERISA.

Fidelity receives revenue from mutual fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. Fidelity shares a portion of the revenue generated from such mutual fund service providers with the Plan. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 there was \$4,198 of revenue sharing/other allocations paid back to the Plan. There were no revenue sharing/other allocations paid back to the Plan during 2023.

**NOTE 8 - TAX STATUS**

The Plan sponsor has adopted a standardized prototype plan which received a favorable opinion letter dated June 30, 2020, from the Internal Revenue Service. The Plan itself has not received a determination letter from the IRS.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examination for years prior to 2022.
