Independent Auditor's Report

Opinion

Note 1: Description of the Plan

The following description of the Athens Restaurant Employees' Health Insurance Fund (the Plan) provides only general information. Participants should refer to the Plan Document for a complete description of the Plan's provisions.

General

The Plan provides health and dental benefits covering substantially all active employees of Zaxby's Franchising LLC, Zax LLC, and Restaurant System Solutions, LLC (collectively, the Sponsor). The Plan and related trust were established on March 27, 2006 and have subsequently been amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Sponsor has engaged Truist Financial Corporation (the Trustee) and Stanley, Hunt, Dupree & Rhine, Inc. (SHDR) as its agents to assist in performing specific services covered under the Plan's service agreement. Any regulatory or administrative functions not specifically assigned in the Plan's service agreement remain the responsibility of the Sponsor.

Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides health (medical, prescription, hospital, and surgical) and dental benefits to full-time employees of the Sponsor (with at least 1,560 hours of service each year) and to their beneficiaries and covered dependents.

With the exception of dental benefits, all of the Plan's benefits are self-insured. The claims are processed by the Plan's third-party claims processor, AmeriBen. The claims processor pays claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA trust. Despite the Plan's utilization of a third-party claims processor, the ultimate responsibility for payments to providers and participants is retained by the Plan. The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for its self-insured health benefits. Under the provisions of the contract, the annual individual stop-loss was \$150,000 in 2024, with no maximum aggregate stop-loss coverage.

The Plan has a contract with Metropolitan Life Insurance Company (MetLife) to provide fully insured dental coverage benefits to its participants. Plan participants have the option to have a specified premium amount withheld from their biweekly paychecks and the Plan remits monthly premiums to MetLife based on the number of covered participants.

During 2024, benefits paid are net of stop-loss reimbursements and pharmacy rebates of \$309,330 and \$405,432, respectively.

All assets and earnings of the Plan are dedicated to the payment of benefits for eligible participants pursuant to the terms and conditions of the Plan and to cover reasonable administrative expenses of the Plan. Distributions from the Plan are directed by the Sponsor or its authorized agents.

Contributions

The Sponsor's policy is to contribute the maximum amounts allowed as a tax deduction by the Internal Revenue Code (IRC). Under present law, the Sponsor is not permitted to deduct amounts for future benefits to current employees. Employees may contribute specified amounts, determined periodically by the Plan's insurance company, to extend coverage to eligible dependents.

Plan Termination

The Sponsor intends to continue the Plan indefinitely for the benefit of its employees, but reserves the right under the Plan to modify the benefits provided to active employees, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

Cash and Cash Equivalents

The Plan considers all highly liquid investments with an original maturity of three months or less to be cash and cash equivalents. Cash and cash equivalents are comprised of noninterest-bearing checking accounts and an interest-bearing money market account held within a bank-administered trust fund. The Sponsor's investments may not be used for any purpose other than providing health benefits for eligible employees and their beneficiaries.

Receivables

Stop-loss reimbursements and pharmacy rebate receivables are recorded when earned. Reimbursements and rebates due as of year end have been reported as receivables, with the offset being netted against benefits paid.

Payments of Benefits

Benefit payments are recorded when paid by the Plan's third-party claims processors.

Use of Estimates in Financial Statements

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Concentration of Credit Risk

At times, cash and cash equivalent balances may exceed federally insured limits. The Plan believes it mitigates this risk by depositing cash and investing in cash equivalents with major financial institutions.

Benefit Obligations

As of December 31, 2024 and 2023, based largely on subsequent payment activity, the Sponsor estimated that claims incurred but not reported approximated \$327,000 and \$475,389, respectively. Participants pay the estimated full cost of health benefits under COBRA. Therefore, the Plan does not report postemployment benefit obligations.

Claims Administration Expenses

The Plan has contracted with third-party claims processors whereby participant claims are processed and paid by the claims processors in accordance with provisions of the Plan. The Plan pays monthly fees to the claims processors equal to the number of eligible participants in the Plan multiplied by the rates specified in the contracts, in addition to other administrative services, as defined. During 2024, the Plan incurred \$157,920 in fees related to third-party claims processors, which are included in administrative expenses in the accompanying statement of changes in net assets available for benefits.

Stop-Loss

Premiums for stop-loss insurance are included in insurance premiums in the accompanying statement of changes in net assets available for benefits.

Note 3: Tax Status

The trust established under the Plan to hold the Plan's net assets is qualified pursuant to Section 501(c)(9) of the Internal Revenue Code (IRC). Accordingly, the trust's net interest income is exempt from income taxes. On July 2, 1992, the plan administrator obtained a favorable tax determination letter from the Internal Revenue Service (IRS) which stated that the Plan met the requirements of the IRC. The Plan has been amended since receiving the determination letter and has not received an updated determination letter. However, the plan administrator believes that the Plan is designed and currently operating in compliance with the requirements of the IRC and that the Plan was qualified and tax-exempt as of December 31, 2024.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 4: Reconciliation to Form 5500

The financial information of the Plan, as reported on Form 5500, includes certain plan benefit obligations that are not required to be included in the accompanying financial statements. A reconciliation of the amounts appearing on Form 5500 to the accompanying financial statements follows:

Note 5: Risks and Uncertainties

The actuarial present value of the trust's benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Note 6: Transactions with Parties-in-Interest

The Sponsor provides certain accounting and administrative services to the Plan for which no fees are charged. As described in Note 1, the Plan has several arrangements with service providers. These transactions are party-in-interest transactions under ERISA. During 2024, \$157,920 was paid to these service providers, which is included in administrative expenses in the accompanying statement of changes in net assets available for benefit.

Note 7: Subsequent Events

The Plan Sponsor has evaluated for subsequent events between December 31, 2024 and the report date, the date the financial statements were available for issuance, and has concluded that all subsequent events requiring recognition or disclosure have been incorporated into these financial statements.
